- 6. Auditor's Report Question from Art Wakabayashi what were the errors identified in the report? The answer was some rounding errors that were not significant.
 - a. **MOTION 2017-26**: Moved by Jim Chernick, Seconded by Sharon Mark that the Auditor's Report be approved. **CARRIED**
 - b. The appointment of the Auditor for the 2017/2018 fiscal year was done at the Annual Fiscal Meeting earlier this year.
