Annual Meeting Minutes- May 4th, 2014- Rev. Joy Segal

Call to order - Rev. Joy Segal

The meeting was called to order at 10:57 AM

### Election Announcements - Judges of Election

The polls were declared closed during the meeting and were to be reopened for a half hour immediately following adjournment of the meeting.

## Approval of 2013 Annual meeting Minutes - Rev. Joy Segal

A motion to approve the 2013 minutes as submitted was made by Anne Blackstone and seconded by Dave Hammond. The motion carried unanimously.

### Rector's Report - Rev. Joy Segal

Joy reviewed her report and asked for any questions. She asked the congregation for thoughts on how we can continue our relationship with the National Park Service and reminded us that they are struggling to stay alive just as much as Gloria Dei is, bringing up the point that just because we are historic doesn't mean we're safe.

### Rector's Warden Report - Carol Jenkins

Carol thanked the outgoing vestry members, Lisa Reeves, Mark Roberts, and Dave Hammond.

#### Financial Report - Dave Hammond

Dave explained the graphs to the congregation, He then showed the process of creating the yearly budget along with everything that is factored into it, previous year's income and expenses, salaries, gifts, etc. Dave also explained that we are in our fourth straight year of decrease in endowments. He reported that we try not to touch the principal of endowments though we do take funds from one fund for capital improvements and growth for the future to help us grow (piano, tv, banners, all inclusive bulletins, etc.)

#### Vestry Report - Barbara Potts

Barbara shared her report of the multiple events and projects the vestry has worked on this past year and invited everyone in the congregation to attend the vestry meetings and think about serving on the vestry next year.

### Sunday School Report - Jill Duink

Jill shared what happened in Sunday School the past year which included Sunday School being moved to after communion, having parishioner guests teaching about the way they give their time and talents to the church and outreach projects. Jill also explained "Godly Play" to the congregation and addressed our concern about the number of Sunday School participants.

### Property Committee Report - Rev. Joy Segal

Joy explained the property report, addressing certain issues such as the sanctuary floor needing repairs and our possible partnership with Seamen's Church Institute - we are awaiting more information before continuing that conversation. She also shared things the vestry has been considering improving that aren't exactly necessary but would make a big difference, such as installing a light given to us by the National Park Service and new chairs for Riverside Hall. The congregation agreed that we need a sign erected that shows we are a working church. There will be communication with the National Park Service about putting the sign on their grounds so that it may be seen from Columbus Blvd.

### History Committee Report - Jeanette Woehr

Jeanette briefly explained the report and shared upcoming projects for this year which include mapping the graveyard, seminars with other historic churches and continuing tomb openings,

## Hospitality and the Gift of Fellowship - Peggy Buescher and Re Henning

Peggy thanked everyone for their helped and welcomed anyone to join the hospitality committee. Peggy and Re expressed the joy they receive from the hospitality.

## Sextons' Report - Jim and Paula Minacci

Jim and Paula talked about upcoming events: Flea market, Memorial Day, and the WXPN event. They reminded everyone that signs don't draw people to the church as much as we can and we do. We are now part of Walmart's donation list for produce which we give to those who are in need.

#### Guatemala Committee Report - Heather Myers

Heather talked about where the committee is going in the future. They had a successful trip this past year and are now thinking if we should continue our outreach there or move in a new direction with local mission work. She also made the point that if we decide to no longer do our outreach in Guatemala there are other parishes who would like to replace us, so our sister parishes would still be in partnership with the diocese.

### Music - Paul Fejko

Paul welcomed new bell ringers and reminded everyone of the envelopes and recalled the multiple music events the church had this year.

### Stewardship Report - Megan Bartlett

Megan thanked everyone for their support and announced that she will be stepping down as Stewardship Committee chair, inviting people to think about taking up the position.

### Inreach Ministry - Rev. Joy Segal

Joy gave thanks, especially to Dolores Collins for her contributions, and encourages people to continue their work.

### Liturgy Committee - Rev. Joy Segal

Joy thanked everyone who has been a part of the committee and encouraged more people to help out. She explained that liturgy is the work of the people and that the way we plan and do our liturgy is directly linked to what people think of us.

#### Altar Guild - Candace Roberts

Candace expressed her thanks to everyone who has assisted with the altar and welcomed more people to assist.

## **HGDPC** - Candace Roberts

Candace announced the accomplishments the committee has had so far which includes a number of people from the surrounding community on the committee. She announced the fundraising they have begun (100 Founding Members and Friends of Old Swedes')

Joy thanked Terry O'Brien, Jim and Paula Minacci, and Paul Fejko for all of the hard work they do for this church.

For everything there is a season, and a time for every matter under heaven. (Ecclesiastes 3:1)

As we gather for our Annual Meeting this year, I am put in mind of this familiar quotation from *Ecclesiastes*. It speaks volumes when we face change. It speaks comfort for those who mourn and challenge for those who envision a future different from the past. And it speaks to the truth of our lives. So, let us consider: what does it say to us as a faith community? How shall we hear this truth?

Change is uncomfortable most of the time. Even change we plan and look forward to tends to put us on tilt, changing our view of the world, whether out a new window or in a new relationship. And discomfort can create anxiety, fear, and even anger. Then there's change we didn't plan, didn't want, and don't like. We know about that too.

Gloria Dei continues to be challenged by a lack of growth and a slow decrease in income. Not the kind of changes we welcome or wish for. As we work to make ourselves relevant in our community we find it challenging to change as the needs of the community change. This past year we have begun to recognize that the way in which we are surviving, financially, is through making our facilities available for events and by participating in and supporting our own increasing fund raising events with our time and talent.

We must not forget that it is just as important to our identity as a worshipping community, to do the work of the Gospel, to insure that what we do in the community reflects how we understand our call to be a part of the Body of Christ – welcoming strangers, feeding the poor, visiting the sick and homebound, and reaching outside of our walls and our comfort zones to live the Gospel out loud in word and action.

We have worked conscientiously to cultivate our relationship with the Queen Village community. This has worked to our favor, as more and more residents surrounding us have discovered what we have to offer – in worship, in beautiful surroundings, and in events that bring the community together for fun and fellowship.

We continue to enjoy a good and valuable relationship with the National Park Service, our partners on this property. Though the NPS has its own challenges financially with government cutbacks they still pay close attention to our needs and we are so grateful for their efforts to maintain the property along with us.

Young Children's Creative Arts (YCCA) continues to maintain an excellent reputation in our community and so brings many young families onto our property. They continue to be of great financial importance to us as well. But they also face change this coming year as they open a new facility in South Philadelphia in order to better meet the needs of the community. We do not know yet whether they will be able to continue at Gloria Dei. It is their wish to do so, but as in everything, the economics of buildings and enrollment will determine whether this will be possible. Meanwhile we are consulting with architects and real estate folks to better prepare ourselves for a possible new tenant for the Roak House.

And as we ended a long relationship with our Guatemala sister parishes this past year we began a new relationship with Episcopal Community Services, working with the children and mothers at St. Barnabas Mission and planning to work with the Youth Center in the months to come. This Outreach ministry allows more of our congregation to be involved, and we look forward to many new opportunities to serve in the community in partnership with ECS.

All that is well and good, but we still need to face the facts – and the numbers. And in looking at our financial situation, and recognizing that the bulk of new income is coming from events, we have begun to consider a building project that would modernize and expand Riverside Hall to better serve these events and to encourage others to consider our site for renting of events not our own. If we decide to go ahead with these plans we will need to spend some of our endowment funds. This is scary, for sure. It means we will earn less in interest income in the future. Do we make this commitment to the future now? Is it "that season" in the life of this parish?

Gloria Dei has been here, on this property, for three hundred and fifteen years. Some of those years saw crowded pews and Sunday School classes filled to the brim. Some of those years saw poverty, hunger, and a risk of closure. Some years were comfortable, some years not so much. Much has changed over that expanse of time. Here we are, in 2015, contemplating change again, recognizing risk again, and being faithful to our call again – just like all those who came before us.

As I thank all those who have gone before and insured our continued presence, so I thank you all, in this season of Gloria Dei's life, for the love and support you give to this very special corner of God's garden.

### Rector's Warden Report - Carol Jenkins

Have you heard people are talking about us? Recently at Gloria Dei I have been listening to comments made by visitors and guests that attend church services or an event. They are saying that we are "friendly and welcoming", "different and not what I expected", and one of my favorite we are "fun!"

We have lots to offer our community with a long list of events to go along with our Sunday worship. Summer Bible Study, Evensong, Dinner Church, Seder meal, Video & discussion events, Blessing of the animals, Lucia, Sexton sideshows, Jazz & Joe, Colonial Fair, Flea markets, Bell ringers, Book Club, Yoga, Thai Chi, Line dancing, Picnics, and Book signings.

All of these events bring our community onto our grounds. We also have many activities that send us out into the community. These outreach programs include: Guest Chefs at Ronald McDonald House, ECS/St. Barnabas Mission, local food pantry, and feeding the homeless.



Speaking of giving thanks, I'd like to give a big thank you to the staff of Gloria Dei church; Joy, our faithful rector - who leads in worship and encourages us to do God's work; Jim & Paula, our sextons - who are always on duty and planning our next fundraising event; Paul, our musical director - for the wonderful music; Vicki, our parish administrator - who keeps us organized and puts a smile on our face; and lastly I'd like thank the entire vestry of Gloria Dei, for their devotion and hard work.

## Financial Report - Jill Duink

The charts below illustrate our 2014 income and expense ratios.

- Endowments provide our largest income source. (38%)
- Fundraising income (21%) was almost \$14,000 over our anticipated budget.
- Pledge income (15%) was \$4,300 below our anticipated budget.
- Our largest expense was compensation and related benefits. (52%)
- Our outreach/Diocesan contribution totaled about 6% of our spending.



The vestry approved a distribution of the principal of one endowment fund for capital expenditures, growth, and to balance the budget if needed. This year \$25,879 of these funds were spent on capital expenditures and \$16,812 was spent on growth.

Gloria Dei finished 2014 in a strong financial situation thanks to the improvement in the stock market and its effect on our endowments. However, because much of our income is from endowments, we are vulnerable to stock prices and may face a significant reduction in income if the market declines.

## Vestry Report - Jim Parsons

Your Vestry at Gloria Dei has been caught up in making some very exciting decisions about the property and programs at Gloria Dei. The Vestry is called to discuss action items and approve or disapprove for the betterment of this congregation. We are all excited about some of the changes that have already been made and some to come.

When you enter the Churchyard you will see the Graveyard is cleared of the bushes and it appears cleaner and greener. Our trees have been cleared of the fungus that had been destroying our trees. Some branches have been removed to keep them from dropping off and damaging our buildings. Our Graveyard has become a pleasant sight to see and appreciate for its beauty.

We are constantly working on our budget to maintain the expenses for repairs and improvements to our property and all the new exciting adventures coming to you all in the near future. We only wish some of you were here to share this excitement with us. Come and join us, we have room for you!!! The congregation is invited to every Vestry meeting.

## Sunday School Report - Jill Duink

This year, Gloria Dei's children and teachers continued to learn and grow together. The youngest children meet from 9:45 to 10:30 for a lesson and play, and then join their families for communion in church. Our older children come to Sunday School after communion.

Our time together begins with greeting and singing. The children then sit in a circle for a story, told and illustrated through Godly Play materials. After wondering about God's lesson, the children interact with the story materials or create their own work. Finally, prayer and the feast bring us together.

This year, the children learned about the Bible, God's people, and the parables told by Jesus. The children illustrated their own Parable Book. We learned about the birth of Jesus and the gifts of the Magi throughout the Christmas season. During Lent, we learned about the life of Jesus. During our prayer time, the children learned about different types of prayer.

Using the Godly Play stories and materials, our children touch, share and expand the stories. From week to week, the children remember these powerful stories and they make them their own. It is wonderful to see the children sing, share, trust and grow together.

Next year, we invite you to share your experience, talents and wisdom with the children. Those interested in teaching or volunteering are welcome. As the children grow, the teachers also grow. The children teach us. Godly Play teaches us. This year, Julie Daye expanded her understanding through Saturday Godly Play training sessions.

In the coming year, we look forward to deeper friendships, deeper wondering, and to deeper, growing relationships with God.

## Property Committee Report - Rev. Joy Segal

As I say year in and year out - "Property" is a big word at Gloria Dei. We have a lot of it, and it requires a lot of attention. Over the past few years we have managed to address quite a number of issues, and those that we cannot afford to remedy at the present we have identified and insured that matters will not get worse while we await funding.

During the summer of 2014 we continued the restoration of the graveyard, cleaning and restoring a number of stones and opening a vault. We spent all we had raised for this project, about \$9000.00. Additionally we added a contribution the vestry agreed to make from our Property Fund of \$5000.00, and a contribution from the History Committee's fund of \$500.00. This allowed us to not only restore two additional stones but also to re-lay a portion of the brick pathway.

We continued a long loved project of planting our Easter flowers in the graveyard, insuring that each year we can enjoy the wonders of flowers that bloom, even in the heart of a busy city.

The vestry approved, once again, the use of funds this past year from one of our unrestricted funds to address property issues as well as what we are calling "Growth and Transformation" opportunities. The use of these funds allowed us to complete many things we would otherwise not have been able to do. The list of items completed reflects this reality.

### Property and Growth items completed since last Annual Meeting

- Tree maintenance through the property
- Cable connection, WiFi, and a new 70" screen in Riverside Hall
- Many banners and sandwich boards and local advertising opportunites
- Continued all-inclusive Sunday bulletins
- Driveway repaving
- Leveling of gravevard on southwest corner
- An extensive examination and report of our property and all buildings, including electrical and plumbing
  needs as well as consideration of roofing, structural integrity, and masonry needs to be addressed. This report
  was done by architects Daley & Jalboot along with engineers.
- An extensive examination and report of the church building sinkage evident in the sanctuary done by J&M Preservation Studio and Materials Conservation.
- Backboard replaced, painted behind light over west side church doors.
- Some pew repairs and inner door repairs in church.

The Vestry has approved use of additional funds from the same unrestricted fund for use this year, allowing us to consider other items and issues, many left undone last year but still under consideration.

### Property items under consideration

- Refinishing floors Riverside Hall and Sexton house.
- Closed circuit capability from church to Riverside Hall and the Roak Room, and including security cameras at gate entrances and parking lot.
- Sanctuary Floor repair
- Rebuild brick piers adjacent to amphitheater
- Install light given to us by NPS

- Painting/Pointing Rectory
- Pointing Sexton's House
- Install new baseboard heat in center rooms, 3<sup>rd</sup> floor and basement, of Roak House
- Leveling of brick pathways incl. drainage system work as needed.
- Leveling of the Sexton House patio
- A/C Riverside Hall
- Banners, sandwich boards, local advertising

Liberty Tree and Landscape spent three days working on our trees this year, and this fifth year of professional care continues to add to the clean, well-tended look of our property as well as assuring us that safety issues caused by dead tree branches untended are not a worry for us.

We are still not financially ready to tackle the more expensive projects, but we have our new Historic Gloria Dei Preservation Corporation (HGDPC) up and running. That Board has, of course, just completed their "coming out party" yesterday as Colonial Day returned to Old Swedes. They have committed to underwriting the survey of the graveyard we have so long put off. And they will soon be applying for grants to help with the expensive and extensive projects – Sanctuary floor repair, painting and pointing of the Rectory, pointing of the Sexton House, leveling of brick pathways and repair of drainage systems, complete repaving of the parking lot, leveling of the Sexton House patio, air conditioning of Riverside Hall – that we just cannot manage within the church's budget.

Meanwhile we will continue to rely on the great talent within our congregation and the wonderful offering of time, talent and treasure from so many volunteers that help with the needed repairs that occur throughout the year.

Gloria Dei Church has been on this property, making a difference within the community, since 1677. Our conscious efforts to maintain it for future generations mirror the efforts of those who came before us and, hopefully, set an example for future generations who will discover in years to come the sacred space we call Gloria Dei.

The History Committee continues to work with the documents in our archives. Many requests for family genealogy research have been completed this year. Some of these requests require many hours of work.

We continue to research people buried in our graveyard, especially those whose tombstones are being restored.

**Share your prayer concerns.** Prayer requests can be made to me or Rev. Joy Segal or by filling out a Prayer Request Form, available on the table in the back of the church. Prayer requests are kept confidential among the intercessors.
