New Business

Chapel Doors - Chris Eve

Chapel Doors The parish has been awarded \$10,000 from the Vision Fund, but only \$5,000 from the Anglican Foundation (the parish had requested \$10,000). The revised cost for the doors is approximately:

- all glass \$22,500
- half wood, half glass \$21,000

The grant funding needs to be spent in this calendar year so we need to make a decision about how to cover the shortfall and also whether we want all glass or half wood/half glass doors. We should get the work under way early in the fall to avoid losing the Vision Fund and Anglican Foundation grant.

Redevelopment Plan - Graeme Brown

The contamination issue was a major stumbling block in moving the project forward. The redevelopment committee has obtained quotes for the next stage of the process of drilling exploratory wells to discern the extent of the contamination. Redevelopment committee is considering digging a single hole in the parking lot to determine if the pollution has moved into the southern part of the property. If it has not, it is possible to develop the separate lot. Redevelopment committee will discuss and bring forward a recommendation.
