

THE MABEL C. DEAN MEMORIAL TRUST

The Bursaries

- 4.01 The purpose of the bursaries provided for herein is to assist children of clergy to attend a university, or college, or other post secondary institution, including, without restricting, the meaning of post secondary institution, a community college or nursing school.
- 4.02 Bursaries awarded hereunder shall be known as "The Mabel C. Dean Memorial Bursaries," being so named in memory of Mabel C. Dean, mother of the Settlor, the Reverend David Dean, who served the Church in many ways, and who was Diocesan Recording Secretary of the Women's Auxiliary for many years.
- 4.03 Bursaries shall be awarded only to children of deacons, priests or bishops of the Anglican Church of Canada, who (a) are engaged in the full-time ministry of the Church in the Diocese of Fredericton, or (b) are retired on pension from the full time ministry in the Diocese of Fredericton, or (c) have died while engaged in the full-time ministry in the Diocese of Fredericton, or after retiring therefrom on pension.
- 4.04 Subject to sections 5.01 and 6.02 each bursary shall be in the amount of \$1,000.
- 4.07 Bursaries shall be awarded having regard to the financial need and academic standing of the applicants. Preference shall be given to applicants graduating from High School. Where two or more applicants have equal financial need, academic standing shall be the determining factor. A bursary may be awarded to the same applicant in two or more years, successive or otherwise, but a second or subsequent bursary shall not be awarded to an applicant who, in the opinion of the committee, has not maintained a satisfactory academic standing. Notwithstanding anything contained in this Agreement, the Committee may decline to award any bursaries in any year when in its opinion there are no qualified applicants.
- 4.08 Applications for the bursaries shall be made to the Committee by March 31 in each year commencing in 1988, and the Committee shall award the bursaries by June 1 in each year, but if any applicant declines an award the Committee may make an award to another applicant at a date later than June 1.
- 4.09 The Committee may direct that a bursary be disbursed in one or two payments, and may direct that payment be made to the applicant or to the university, or other institution the student is attending for credit to the student's account with it. If for any reason only part of a bursary is paid the unpaid portion shall be added to the capital of the trust.
- 4.10 All decisions of the Committee shall be made by the vote of a majority of the members of the Committee.

Special Bursaries

- 5.01 Notwithstanding the other provisions of this Agreement the Committee may, if in its opinion a student who is eligible to apply for a bursary is in any year in an emergency situation of financial need, award to such student a special bursary of less than the amount fixed by section 4.04, or pursuant to section 6.02 out of any unused income earned by the capital of the trust in that year.
