Legal Waiver for 2016-2017 Year

This is a legal document.

By signing this document the parents/guardians and young person (the “participant”) are giving up certain legal rights and assuming certain obligations. Notwithstanding precautions taken, accidents occur and this agreement must be signed in anticipation of that possibility.

TO: Richmond Pentecostal Church (the “Church”)

In consideration of the Church sponsoring or being involved with various functions with the Participant from May 1, 2016 to May 31, 2017, the undersigned parents/guardians and Participant hereby:

- a) Acknowledge that involvement in and access to some or all of these functions may involve private and/or public transportation;
- b) Understand that these functions and transportation to and from them may involve some risks;
- c) Understand that unintended injuries and death may possibly result as a consequence of participation in such functions and transportation to and from them;
- d) Accept full risk and responsibility for the death of or injury to the Participant or damage to the property of the Participant arising from the functions or transportation of the Participant to and from such functions;
- e) Waive any rights whatsoever that the undersigned and Participant may have now or in the future against the Church and, as applicable, its members, directors, officers, leaders, agents and employees as a result of death or injury to the Participant or damage to the property of the Participant arising from the participation in the functions or transportation to and from them;
- f) Release and forever discharge the Church and, its members, directors, officers, leaders, agents and employees from all actions, causes of action, suits, claims and demands whatsoever, that may rise from any functions or transportation to and from them, however caused;
- g) Agree and understand that this document will be binding on the heirs, executors, administrators and assigns of the undersigned parents/guardians and the Participant;
- h) Indemnify and hold harmless the Church, its members, directors, officer, leaders, agents and employees from any actions, suits, claims, demands whatsoever, arising from any negligent, wrongful or illegal act or omission of the Participant in respect of any function or transportation sponsored, arranged or coordinated by the Church or its agents; and
- i) Agree that if any provision hereof is invalid, illegal or incapable of being enforced by reason of any rule of law or public policy then such provision will be severed from and will not affect any other provision contained herein, and this instrument will be read as if such invalid, illegal or unenforceable provision had never been contained herein and all other provisions hereof will, nevertheless, remain in full force and effect and no provision will be deemed to be dependent upon any other provision.
