The Annual Congregational Meeting Is Coming

The Annual Congregational Meeting has been set for January 31, 2021 at 11:00 A.M.

Due to the COVID19 guidelines, this year's Annual meeting will be both virtual and in person. For those planning to attend virtually via Zoom, a link will be sent to attend the meeting as well as instructions on how to vote for both new Council members and the constitutional updates.

For those planning to attend the Annual Meeting in person, two to three groups of 10 people each will be created. To participate in person please contact the church office and make a reservation. You will be assigned a room and door to enter so that we keep our groups separated and small. The agenda for the Annual Meeting is in the Annual Book of Reports. During the meeting time will be allocated for congregational conversation from all three in person locations and zoom. See you there, one way or another.

Lord of Life's Annual Report

The Annual report has been sent via email or can be picked up when picking up communion packets. If anyone wants a hard copy, contact the church office and Kathy will send out a copy or request it when you drive up for communion. The annual reports are available a week before the congregational meeting so that you can read and formulate any questions. Thank you to everyone who wrote reports so that we have a full picture of last year.

Updated Constitution

During the month of December everyone received a copy of a Proposed Updated Constitution for Lord of Life. Updating the constitution is one of those things a congregation does during the interim. Earlier this year the Congregation Council appointed a Constitution Taskforce to review required changes and suggested changes from the ELCA. The Taskforce studied each suggested change and then chose to recommend it or not to the Council. These recommendations went to the Congregation Council who studied each proposed change and chose to approve or change the recommendations. The Proposed Updated Constitution you received was this constitution. The next step was congregational Two Sunday Morning Coffee conversation. Conversations took place where 3 amendments to the Proposed Updated Constitution were suggested by participants. Below is the list of each of those amendments that will be entered from the floor at the congregational meeting.

C.10.03

Original: Notice of all meetings of this congregation shall be given at the services of worship on the preceding 2 (two) consecutive Sundays and by mail to all voting members at least 10 (ten) days in advance of the date of the meeting. The posting of such notice in the regular mail, with the regular postage affixed or paid, sent to the last known address of such members shall be sufficient.

Updated: Notice of all meetings of this congregation shall be given at the services of worship on the preceding 2 (two) consecutive Sundays and by mail or electronic means, as permitted by state law to all voting members at least 10 (ten) days in advance of the date of the meeting. The posting of such notice in the regular mail, with the regular postage affixed or paid, sent to the last known address of such members shall be sufficient. An email sent to the member's last known email address is also sufficient notice.

This change was made to clarify the sufficiency of email

C.13.05

Original: When a pastoral vacancy occurs, a *Call Committee* of six (6) voting members shall be appointed by the Congregation Council. Term of office will terminate upon installation of a newly called pastor or upon dissolution of the committee by the Congregation Council. No more than two (2) Council members are to serve on this Committee.

Updated: When a vacancy occurs in a position for which this congregation calls a rostered minister, a *Call Committee* of six (6) voting members and one (1) alternate shall be appointed by the Congregation Council. No more than two (2) Council members are to serve on this Committee. Term of office will terminate upon installation of a newly called rostered minister.

This change was made to reflect the current practice used twice in appointing Lord of Life's Call Committee and ensuring that a full committee will be present when calling a pastor.

C13.08

Original: The pastor of this congregation shall be an *ex officio* member of all committees and boards of this congregation. The president of this congregation shall be an *ex officio* member of all committees and boards of this congregation, except the Nominating Committee.

Updated: The pastor and the president of this congregation shall be ex officio members of all committees and boards of this congregation except the Nominating Committee, Audit Committee and Call Committee. These committees may seek the counsel of the pastor and the president.

This change was made to clarify roles of pastor and council president on boards and committee.
