Cameron thanked everyone involved for making it such a great year.

Eve Brealey, Rita Carey, Carol Cheal, Don Christie, Pam Lokken, Pam Tattersfield, David Hildreth, Edie Hildreth, Carol Grolman, Stacey Spencer. The list will be sent to the Archbishop for approval.

Moved by Don Christie seconded by Edie Hildreth carried

Presentation and Reception of Treasure's Report made by Eve Brealey.

Question raised by Dorothy Bruce re difference between Savings contingency and Special Purpose contingency fund...this is handled through envelope giving, one is more building focused.

Question raised by Eleanor Faveris about amortization period -Response 20 years.

Question raised by Don Christie about roof renovations. - Response all payments are recorded under excess income and expenses.

Moved by Eve Brealey seconded by Karen Brumpton

Question raised by Roy Shephard what will happen when the subsidy from the Archbishop stops in 2 years and could the rectory be developed. Cameron explained that the development of the rectory is complicated and could only go through the diocese. Cameron also noted that he is pleased that the budget is balanced and that the Diocesan grant is only 12% of income as noted on the pie chart on page 30.

David Hildreth also noted that there were a few major expenses incurred each January such as insurance etc...

Huge round of applause with special thanks to Eve and Elaine carried

Eve presented the 2020 Budget. One revision was handed out to everyone on a separate sheet.

Dorothy Bruce asked about the curacy grant. Cameron explained it is the grant money given to St. John the Divine for having a new priest. There is normally a 2-year curacy period served in a larger church under supervision. Cameron noted the increase in income from other sources helping offset the grant is encouraging.

A motion to adopt the 2020 Budget.

Moved by Pam Tattersfield seconded by Peg Tinney.

Discussion followed about the efficiency of carpet vs flooring. Karen Brumpton explained they were individual tiles that could be removed and replaced. David noted this was thoroughly discussed by Parish council. David explained the individual carpet tiles were extremely durable and came with a 20-year warranty. A replacement supply was included. Debbie Fryer asked about the cleaning costs and noted that there was a lot of spillage. David, Cameron, and Ed the carpet installer will set up a meeting regarding the proper and most efficient way to clean.

Cameron noted that "Spaces Matter". These areas are very important for first impressions.

Don Christie questioned about rodents chewing carpet. Trevor explained that doors had been fixed resolving any previous rodent problems.

David noted that the wall-to-wall carpet had been generous in giving a great price. A team of volunteers will be meeting this Saturday to rip out all the old carpet before the installation.

Roy Shephard asked how the Diocesan Grant Income is calculated and changed over 3 years. Cameron explained that a special formula based on parish income was calculated by the Diocese.

Cameron put forward the list of Parish council nominees. Cameron called for nominations from the floor. There were none.

Moved by Roy Shephard seconded by Dorothy Bruce carried

Trevor announced he would be stepping down from his position on council, but he would continue his regular duties in maintenance and running the web site. Cameron thanked Trevor for all his hard work as People's Warden and presented him with a small token of thanks. Trevor received a loud round of applause. Peggy also thanked Eve for all her hard work. another round of applause. Cameron thanked everyone for all their dedication and working as a cohesive group.

Other Business: Rita discussed the Spring Fund Raiser, the plant sale will be May9 th, pick up in time for Mother's Day. A choice of dates was put forth for the Spring Fling- a show of hands chose May 23 rd. A co-ordinator is still needed!

Dorothy Bruce asked if someone would take over the Large Print Music for Sunday services and banking deposits on Sunday after church as she is moving to Salt Spring island.

Roy Shephard discussed the audio system - sometimes the readers are not clear. A reminder will be given to all to speak closer to the microphone.

No other business.

Call for adjournment followed by lunch, move by Michael Moore.

The Rector's Report ~ The Reverend Cameron Gutjahr

It's been quite a year, my friends. In some ways it has looked nothing like what we were expecting over a year ago at our last vestry. However, the Spirit has still been moving, God has still been acting on and through us in ways that were awesome and unexpected in 2020.

Let me first address our deep struggles over the past year. COVID-19, of course, dominated our consciousnesses. We have been living with fear, suffering, illness, and death on our minds and in the world for most of 2020. It has been difficult not being able to gather and grieve as we are used to when beloved members of our community have died. It has been difficult not being able to gather, period, to support one another, to pray, sing and just *be* together.

I have missed you.

We also unexpectedly had to deal with a very unfortunate situation with the rectory, resulting in lost income and major expenditures to fix it (at a most inopportune time). Thankfully, it was resolved, and we have new tenants now.

Additionally, due to the pandemic, we lost, without warning, the majority of our income from rentals, some of our fundraising, like the Spring Fling, and donations from people visiting our services in-person.

However, like I said, God has still been moving.

Despite these financial difficulties, we ended the year with a healthy surplus. That's amazing, even considering that we received the majority of our curacy grant this year, and the diocese stepped in to financially support us in the initial months of the pandemic (thanks be to God!).

The first two months of 2021 started off with attendance at our Sunday-morning services that was over 30% higher than the same time last year. We had a small Sunday School running at the beginning of the year. The ukulele hymn jam group played for the first time at the Multicultural Day at Totem Hall. We redid the carpets in the narthex and meeting rooms to make our space even more inviting for new people. We had the wedding of a new family in our parish.

Even in the grips of the pandemic, we quickly pivoted to offer online services, which have helped connect our established St. John's community in prayer, as well as connecting with new people in Squamish and farther afield. We set up a telephone tree to check in on each other, and I have been so moved to hear how you have all been taking care and checking-in on each other on your own, how you have been the Church. We have been running our weekly prayer group and discussion group online, as well as joining St. Stephen's in West Vancouver for an online Bible Study. We also started a new weekly liturgy, a Night Prayer service on Sunday evenings, first in-person, then online. We started a new partnership with a community group -Squamish Fresh – a fruit and vegetable co-op who use our space weekly. We hosted Community Christmas Care's Oops Depot and supported them considerably through our online auction. We had over 300 people visit our online nativity display in December. We ran a stewardship campaign. We had a special series of conversation-style sermons with local pastors. We started having members of the community write "guest reflections" on the first of the month. We seriously started discerning a new community in our parish in Whistler. I tried to continue to be present in the community, making connections, and being an ambassador for Christ and the little part of His Church that we call home.

A lot has happened. I wouldn't be able to name it all. There is a lot to celebrate and give thanks for, as well as to grieve. However, the mission and ministry of God at and through St. John's has continued – it has not been stopped by this pandemic.

I can never thank you all enough for what you have done last year: for your dedication, prayer, generosity, time, courage, flexibility, grace and wisdom. None of it would have been possible without *all* of you.

I am excited, honoured, and deeply grateful to be your priest, to be serving God and neighbour here in this place with you.

2021 will be another year with challenges, but I do not doubt that God will continue to work among and through us, and that we will again be surprised by the abundance of God's blessing. Let us step forward in faith, hope and love, with the words of the doxology on our lips:

Glory to God, whose power, working in us, can do infinitely more than we can ask or imagine. Glory to God from generation to generation, in the Church and in Christ Jesus, forever and ever. Amen.

Thank you for this opportunity to serve as St. John's delegate to Synod this year. It was an off-year for the gathering of all from the Diocese, but it was an exciting year as it involved participating in the election of our new Bishop, John Stephens.

Some of us remember John as our dynamic spiritual leader in the late 1990s who also was a big part of the process of expanding our church and building the new sacristy which opened in Easter of 2000. It was an honour to be able to nominate him as a candidate for Bishop in the summer of 2020, and to participate in the electoral process and voting on October 3.

It was interesting to be part of an election where everything was done online. I found it a disadvantage to not have a real time candidates' forum where questions could be posed from the floor, but it was good to be able to review their video submissions and prepared answers to questions at leisure rather than take everything in over a day or two of meetings. The online voting was done by a specialist firm, and was easy and secure, and probably faster with ecounting of ballots. It was wonderful to participate from anywhere with a wifi connection rather than miss a beautiful fall day in many rounds of voting an a big meeting hall.

It was bitter-sweet to say goodbye to Archbishop Melissa by zoom on February 11, but very good to see all the churches in the Diocese in presentations made by each deanery. It was much better than I was expecting, and certainly the easiest way to attend a party of almost 300
