Board Chairman's Oyen United Church Annual Report for 2020

This has certainly been a challenging year for our church and pastoral charge. When COVID 19 hit, we had to close our sanctuary, and it continues to be closed. I say the sanctuary was closed, but the members of the congregation have continued to do God's work in different forms. Thank you to all.

We had a second blow when The Rev. Helen Reed announced that she was leaving at the end of August. The Cereal United Church did a wonderful job of putting together a farewell for her while maintaining all COVID restrictions of spacing, face masks, and sanitizing. It was a lovely service. And while we were sad for us about losing Helen, we were happy for her. Her new church is in Camrose where her whole family resides, and she will be close to her parents when they need her. It is the best possible placement for her.

After our sanctuary was closed, we were able to continue with on line worship by Zoom. For many of us it worked well, but, unfortunately there are members of our congregation that do not have computers or do not know how to access Zoom, so for them, it has been a bleak period. We had thought about having virtual services for these people in our basement, and I did make an application to Regional to do this, but there was some miscommunication. By the time we received their approval, more COVID restrictions had come into being. Therefore, this idea has not been implemented.

The COVID closing has had an adverse effect upon our finances. Since church attendance declined, so did some of our contributions. We still had 31 people who continued to contribute, either through envelopes or through PAR. To these faithful people I extend my heartfelt gratitude! We also owe a vote of thanks to the Pioneer Pastoral Charge for forgiving us two months' of our allocation. They were able to do this because we are no longer paying a minister's salary.

Because of the pandemic, we lost nearly all of our ability to fund raise. We had to cancel our fall turkey supper which usually nets us around \$3000. We were unable to have any concerts. We had one Soup & Sandwich prior to the closing, but that was the only one. Luckily, we were able to have three bake tables at the Farmers' Market. We were scheduled to have another at the Christmas Market, but that was cancelled. Three women had already done their baking for it and were able to sell that baking by word of mouth. How is that for dedication? Thank you, ladies. However, we were not able to do our Soup & Sandwich at the Farmers' Market, so we lost that revenue. We no longer have rental revenue. That has been replaced with voluntary donations instead. Our church was used for only one funeral for which we received a donation.

I shall try to summarize some of our financial situation. Our donations and offerings were \$8,000 below our budget. Our memorial donations were \$990 below budget. As I have mentioned, all of our fund raising was well below budget. Our lawn and snow removal was double what we had budgeted; however our janitorial services were \$1,400 below budget because we are not using the church. Our utilities remained in line with our budget. Hugh Allen continues to pick up empty bottles and take them to the depot. Thanks, Hugh!

We did receive an unbudgeted \$5000 grant, which I shall now explain. Even though the church is not in use, it still has to be maintained and kept up to date. In that respect, we undertook two major investments. These were unanimously endorsed by the board.

The first was the replacement of the double doors on the west entrance and the south entrance. Both were in very bad condition and would fly open when the wind caught them. We also needed the doors to open properly to enable a casket to be brought into the church. If we can ever open the church with COVID restrictions, we needed two functioning doors so that people can enter one door and exit another. The grant which we received nearly covered this cost, and we now have two new sets of functioning doors.

The second capital expenditure was for new sewer and water lines into the church. I need to give you the background for that. Upon many occasions, the sewer line had backed up. We had been "making do" by having the sewer line reamed out each year. The worry with that was at some point, the sewer line might completely collapse. We never knew when that might happen. We had priced out replacing them with a plumber, and it was over \$10,000. This summer when the sewer and water lines were being replaced in the town, they were going right by the church, UG Excavating offered do replace both water and sewer for slightly over half. We felt it was an opportunity we should not pass up. Val has been searching for a grant to cover the cost, but so far has been unsuccessful. We had a GIC which was a bequest for the upkeep of the church, which we partially used.

This will be my last annual report to you. As many of you know, I have resigned as chair. I spent three years as chair of the pastoral charge board, took a year off, and then became chair of the Oyen United Church. I think you have had enough of me and it is time to have someone with some new ideas and new visions. I had planned to resign at the annual meeting, but since November, I have been isolating with my eldest son in Calgary. I just did not feel as though I was fulfilling my obligations to the church, and so I resigned a few weeks early.

This congregation will always be in my heart, and I shall continue to help wherever possible. I wish the new chair and the new board the best.

Trustees Report

Trustees have legal responsibility for the church building and the land. The Trustees have not met as a group for a few years now. However, the Trustees are active in the church community and attend Board meetings and so are current with the condition of the church building.

Land Titles are current and are kept in the Pastoral Charge Safety Deposit Box at the Toronto Dominion Bank in Oyen.

Trustees are to ensure that the buildings are kept in good repair and that sufficient Insurance coverage is kept on the buildings.

- Basic Maintenance
 - Lawn Care and Snow Removal
- Capital Upgrades
 - Sewer line replacement at a cost of \$5,405. We applied for, but were unsuccessful in receiving grant funding for this project.
 - New double doors on west and south sides at a cost of \$7,648. We received a \$5,000 grant from Community Foundations to help cover part of this cost and moved \$2,765 from the Memorial Fund to cover the remainder
- Fund Raisers We have had substantially less fundraisers than normal due to restrictions of Covid
 - 2 Soup and sandwiches taking in \$1,384
 - 3 Bake Tables at the Farmers Market bringing in \$1,516
 - Although the Christmas Market was cancelled, our bakers sold all their baking and kindly donated the proceeds to the church totalling \$459
 - Bottle donations are still coming in as well
- PAR Program
 - We continue to encourage participation in PAR (Pre-Authorized Remittance), a monthly debit program of regular giving to the church. PAR participants allow the church to manage its budget more responsibly because it is known that a set amount is coming in

each month. PAR forms are available at the church office and on the West Entrance Bulletin Board.

- Building Use Policy
 - With the permission of the Oyen Board, the Stewards developed a new rental policy for the church building. Basically there is no charge for use of the church. Guests may book the facility and must sign a responsibility form for their use of the building
- Mission and Service
 - Our Mission and Service goal was almost reached this year. Thank you to those who
 chose to designate givings to Mission and Service.
 - Oyen United Church made donations to the Oyen and District Food Bank through our Christmas Food Hampers from the Reverse Advent Calendar.
 - As well, thank you to those who sewed masks. Donations from people who took masks were forwarded to Mission and Service.

The Stewards would like to thank the Oyen United Church family for their generous support of these activities. It allows us to support our budget and continue our presence in the community with a full time minister.
