I would say that 2020 has been a frustrating year for Acadia Valley Church and Congregation due to the Wuhan Flu manifesting in January and personal lockdowns and Medical Officer of Health Emergency forbidding gatherings of any size, singing, and of course physical distancing, which shut down our normal activities in the church. After a year, we are all patiently awaiting reopening our services.

However, some of our accomplishments are:

- 1. Cleaning the carpets in the sanctuary.
- 2. Commissioning and installing new large sign on the church identifying who we are, and that we are a United Church of Canada, with our contact information and church times.
- 3. We contributed to the preservation of our environment by not using the furnace all year, so we still have the propane that we bought from last year.
- 4. We saved \$500 as a credit from our Annual fee for our portion of the annual operating fee for the Pioneer Pastoral Charge when were relieved of the cost of a Minister's salary due to Helen Reed leaving to go to Camrose United Church and assume the Minister's duties there. She will be with her elderly parents to aid and assist them also.

I am please to report that we have a healthy bank account thanks to continued support from our members and bequests, and the building is in excellent condition.

I would like to thank Rev. Reed for her service as our supervisor, and especially to our Worship Leader, Bonnie Burke, who will resume her roll when the lockdowns end, hopefully soon in 2021

Pioneer Pastoral Charge Allocation:

2021 budget has been reduced from last year: \$500 as a credit for the 2020 partial waiver of fees due to no Minister salary for November and December and \$200 is a one-time reduction of fees for the 2021 year.

Furnace:

Should a new furnace be needed, there is an outstanding motion to spend \$4,456 + GST = \$4,679. The old furnace was serviced and is now working well.
