- 6.1. Community of Faith Profile update. Dan reported that the Profile is complete, although the minister's position

description should be included. M & P is working on it. The Profile as is will be posted on Church HUB and our Website. The congregation will be advised in the weekly announcements. Printed copies will be made available.

- 6.2. Discussion of table service. Well organized, good discussion. Dan & Kent prepared the congregation well for the discussion. One comment, not enough time to discuss what Amalgamation or Resource Sharing would mean. Perhaps a further table service would be useful. Dan ranked the responses in order of preference: Resource Sharing 1.57, Amalgamation 2.19, Status Quo 2.35, Closure 3.76. There was a clear preference for Resource Sharing; Amalgamation & Status Quo are virtually tied. Dan has not completed an analysis of the notes recorded at the tables and will share the results. The results could be read as a mandate to experiment with other groups, whether church groups or community groups. It was agreed that we should have another Sunday table service to talk just about Shared Resources and Amalgamation, after Easter.

 - 7.1. Refugee Proposal was favourably received.
