- 2. Opening reflection: Linda Paul

Motion 2020-32: That the Consent Agenda be approved (with the Christian Education, Administration and Finance and Ministry and Personnel reports removed). M/S June Blau/Frances Goudie – carried.

Reports removed from the Consent Agenda:

<u>Christian Education.</u> Fran has been working with Lee to put kids ideas in the announcements each week. Fran sends a message and Lee composes the announcement.

<u>Administration and Finance</u>. The committee recommended going ahead with unbudgeted painting of hallways and ceilings by Jonathan at an approximate cost of \$1,500. The funds are available.

Motion 2020-33: That painting of hallways and ceilings at an approximate cost of \$1,500 proceed. M/S June Blau/Laura Thomson – carried.

June said it is clear that the government grant to support rental loss is available to charities.

Motion 2020-34: That Wesley apply for a government grant to pay one-half of lost daycare rental for April, May and June. M/S June Blau/Jim Chernick – carried.

<u>Ministry and Personnel.</u> Arising from the M & P report, Tessa proposed the following motion:

Motion 2020-35: That Council approve a declaration be made to the Wesley congregation that Wesley will continue employing its staff during the COVID-19 pandemic. M/S Tessa Whyte/Linda Paul – carried.

Arising from the M & P report a discussion ensued about the whether to pay music leaders/soloists in the Sunday worship services during the pandemic.

Motion 2020-36: That Wesley pay soloists in the Sunday worship services during the Pandemic from the beginning of virtual services until June 14, 2020, an honorarium of \$50. M/S June Blau/Frances Goudie

Amendment to motion 2020-36: That the honorarium be \$100. M/S Stephanie Dove/Jim Chernick – amendment defeated.

Motion 2020-36 – defeated.

6. Old business

6.1. Blueberry Sale update. Fran reported that we are good to go. Yesterday Pratt's said that they can supply blueberries. Last year's committee will be meeting later this week. The sale will be on July 25.

 - 7.1. Correspondence letter of support for St. Andrews.

Motion 2020-37. That Wesley Church write a letter of support in opposition to the anti-Queer defacement of St. Andrews College, Grosvenor Park United Church, McLure United Church and other churches in Saskatoon. M/S June Blau/Linda Paul – carried. Dan will ask Kent Stewart or David Kyle to write the letter.

7.2. Program meeting/nominations. Stephanie Dove as chair of nominations suggested that at this time of social distancing a virtual Annual Program Meeting would be difficult. She recommended that the meting be delayed.

Motion 2020-38: That the Annual Program Meeting be postponed until such time as the congregation can gather in the church and that until such time the current Council and Officers of Council remain in place. M/S Laura Thomson/June Blau – carried.

Council agreed to re-evaluate this motion in September.

8. Minister's report. Cindy has been focussing on worship and how to have an operating church. She attends to pastoral care through phone calls. She asked that we think about what re-opening will look like. There will be no choir for at least a year, as singing is more dangerous than speaking during the pandemic. Cindy has asked Lee Stubbe to work on an online choir. She thanked Linda Gunningham and Pam Thomas for their work on stewardship. Tri-church services begin June 21 at Sunset, followed by Lakeview July 19 and Wesley August 16.
