- Call to order Dan welcomed everyone and called the meeting to order at 7:03 pm.
- 2. Opening reflection: Fran
- 3. Approval of agenda

Motion 2020-24: That the agenda be approved as amended. M/S Tessa Whyte/Linda Paul – carried.

4. Approval of minutes from March 18, 2020 council meeting

Motion 2020-25: That the minutes of the meeting of March 18, 2020 be adopted. M/S Al Goudie/June Blau – carried.

Since the last Council meeting, the following motions were passed unanimously by Council Executive:

Motion 2020-22: That Wesley apply for a \$40,000 interest-free loan under the federal government's COVID-19 assistance program as soon as it becomes available. M/S Al Goudie/Jim Chernick – carried.

Motion 2020-23: That Wesley offer 1) rent relief to iDiscover to June 30, (\$1253/mo) and 2) a two week equivalent refund to the Yoga group (~#320). M/S Al Goudie/Jim Chernick – carried.

The Trustees were informed of Motion 2020-22 and unanimously passed the following motion:

That the Trustees of Wesley United Church approve the application for a \$40,000 interest-free loan under the federal government's COVID-19 assistance program and direct Glenn Schmuland and/or Jim Chernick to complete and sign any and all loan documentation on behalf of Wesley United Church.

Motion 2020-26: That the Consent Agenda be approved (with the Administration and Finance Committee report removed). M/S June Blau/Laura Thomson – carried.

Reports removed from the Consent Agenda:

Administration and Finance Committee: June reported that she sent notice of motion 2020-22 to the Regional Council but had not received a response. At a Webinar today, she and Glenn learned that churches are not eligible for the \$40,000 loan. Churches were encouraged to apply for the 10% wage top-up through ADP. The United Church Foundation is offering a \$10,000 interest free loan; Regional Council approval is not required.

Motion 2020-27: That Wesley apply for a \$10,000 interest-free loan from the United Church Foundation. M/S June Blau/Stephanie Dove – carried.

June also mentioned that she had received notes of appreciation from iDiscover Daycare and Yoga group for the rent forgiveness.

Old business

- 6.1. Wesley's COVID-19 response / emergency preparedness committee. Cindy reported that the committee has met several times and has fulfilled all of the recommendations/suggestions of the United Church. There was a good response to the phoning tree. Some follow up calls are happening.
- 6.2 Garage Sale decision. The Men's Club has postponed the Garage Sale until the fall.

- 7. April strategy and visioning (new business)
 - 7.1. Correspondence none.
 - 7.2. Sunset/Wesley Refugee Committee decision to provide \$200 per month for 5 months from the refugee fund to support the Fattal family and their loss of income due to the current COVID-19 pandemic.

Motion 2020-28: That \$1,000 be taken from the Refugee Fund to support the Fattal family for 5 months, \$200 per month. M/S Linda Paul/Laura Thomson – carried.

7.3 Joint Services with Eastside United Church. Cindy and Russell Mitchell-Walker discussed sharing one service per month each to allow Cindy and Russell a Sunday off. They agreed that Russell would conduct the service on April 26th and Cindy on May 10th. Both services would be by ZOOM. An extra license is required to allow for an increased number of attendees. The cost of the extra license would be shared by Wesley and Eastview.

Motion 2020-29: That Council authorizes the expenditure of approximately \$40 per month for an extra license to increase our ZOOM capacity. M/S Tessa Whyte/Fran Goudie – carried.

7.4 Blueberry sale. Linda and Fran will be speaking to Pratt's next week and if they can supply blueberries for a summer sale, will convene a committee meeting to discuss the feasibility of having a summer sale.
