# 2019/2020 Financial Statements presented by Kelly Froese

- Giving fell short of budget by \$31k. Expenses were reduced as much as possible. There was a surplus of \$68k for 2019/2020 due to COVID-19 wage subsidies and the reduced mortgage payments program offered by the Alliance District. The surplus was applied to the mortgage and to projects for upgrading the video capability.
- Mortgage outstanding as of June 30, 2020 is \$269,423.
