# Okotoks De Winton Pastoral Charge Ministry and Personnel (M&P) Committee – what, how and who?

**What**: The M&P Committee acts under the guidelines of *The Manual* of The United Church of Canada which requires that every pastoral charge establish its own M&P Committee. The committee functions around three roles, which are:

#### The consultative and supportive role

The M&P Committee consults with ministry personnel, lay employees, and the community of faith on matters concerning their welfare and interests, and oversees the relationships of the ministry personnel and lay employees with the members of the congregation. The M&P Committee's role is to continually monitor and review the effectiveness of staff in relation to the community of faith's mission.

#### The healthy relationships role

The M&P Committee is responsible for overseeing the relationship of the pastoral charge staff to each other and to people in the congregation. The M&P Committee helps to ensure a climate where constructive feedback can be offered and received in a positive way, allowing for direct discussion, explanation, improvement, or change.

#### The supervisory role

The M&P Committee is responsible for regularly reviewing the working conditions, responsibilities, and compensation of all pastoral charge staff, and making any recommendations needed as a result of these reviews to the Board.

We provide resources and support for the staff and the community of faith with respect to any issue affecting staff of our church, including ministry personnel, lay employees and contractors. The committee works to build positive and trusting relationships between staff and members and adherents of our community of faith.

**How:** Okotoks and De Winton United Churches are blessed with staff who are committed to their work and we are thankful for this work in our community of faith. If members of the community of faith have praise or concerns about staff, both ministry personnel and lay employees, these can be shared in signed correspondence with the committee. The issues will be considered confidentially by the M&P Committee, who will recommend action.

**Who:** Presently serving on the committee are Sally Salter, Jack Parsons, Stewart Thomas and Wayne Stordahl. Please feel free to contact any member of the committee with your questions, your praise for our team or your concerns. We value your input and your privacy.

### **Singing the Lord's Prayer**

For many years we have been singing The Lord's Prayer from our Voices United hymn book, #959. It has been a favourite of many and meaningful as we sang it together. Recently several people have asked, as we return to in-person worship, whether we can return to singing The Lord's Prayer.

After much discussion, deliberation and discernment, Matthew and Julia have decided not to include *this* version of The Lord's Prayer in worship services.

In the past few years, several allegations of spiritual and sexual abuse have been brought to light by women who have worked with David Haas, the composer of the musical setting we have been using for The Lord's Prayer. The allegations have been deemed credible by many organizations including Catholic Dioceses in the United States along with several publishing companies. His music has been removed from catalogues and is no longer sung in many congregations, including several United Churches in Canada.

While most in our congregations may not have any idea of the background of the composer, knowing what we know, it became difficult in all good conscience to keep singing something that may cause triggers or create trauma for anyone who might know the circumstances. Music engages us emotionally and viscerally and engages our hearts as well as our memories. Many women today are re-traumatized by singing Mr. Haas's music. We want to avoid this possibility.

As we all know, claims of this nature—by so many—must be heard and taken seriously. Many people are traumatized by the actions of those who engage in behaviours such as those for which Mr. Haas has been accused. The United Church of Canada seeks to promote justice and reconciliation and to date we are not aware that such resolution has happened in this case, one still very much in process.

### NEWS FROM ST. ANDREW'S UNITED CHURCH

**NEWS FROM ST. ANDREW'S UNITED CHURCH**

As I sat down to write this on Tuesday morning (May 3<sup>rd</sup>), our field at the farm has been planted and we are praying for some much needed rain. And so I ask "What are your prayers and concerns for God's Creation at this time?"

Easter Sunday (April 17<sup>th</sup>) saw people gather from the three communities of faith at the Okotoks Erratic for the sunrise service. The sun broke through the clouds as we were leaving. Later sixteen people joined Julia for the service at St. Andrew's. Speaking from John 20:1-18, Julia enabled us to see through a new lens as we heard Jesus speak Mary's name at the empty tomb. For when Jesus called Mary by her name this one whom Mary had first thought was the gardener was revealed to her through new eyes that he was indeed the risen Jesus. Now Mary, seeing through a new lens, could sing the hallelujahs of resurrection.

Then on the Second Sunday of Easter (April 24<sup>th</sup>) fourteen people joined with Karen Pryznyk as she spoke of the Trinity using the letter written to the Ephesians (3:14-19a) as the scripture. She asked how do we describe and understand the Trinity and why does it matter? She then said that however we do describe and understand the Trinity, the Trinity is all about relationship and love for that is how God is revealed. One of the ways Karen showed the Trinity was having Shirle play three notes on the piano together producing one sound and is that not how we experience the Trinity for God the Creator, Christ the Redeemer, and the Spirit the Sustainer who show the one essence of the divine.

Unfortunately Matthew was not able to join us on the Third Sunday of Easter (May 1<sup>st</sup>). Thus, as seventeen of us gathered for worship, I led the service using material that Matthew and Julia had written and recorded for The United Church of Canada's *Together We Worship* for just such an occasion. I read what Julia had written in the message which spoke of Wisdom. Based on Proverbs 1:20-33, Julia wrote that there are two types of wisdom. The world's wisdom is "described as jealous, self-seeking, ambitious, arrogant, and deceitful which leads to disharmony and hypocrisy." God's Wisdom, on the other hand, is "humble, pure, kind, considerate, and full of compassion." Thus, God's Wisdom "works for peace, and shows itself by doing good, which bears fruit in holiness." In the message that I read, Julia then asked "Which wisdom am I practicing?" How do we answer this question in our daily lives?


We also like to welcome Cindy Imler to our team. Cindy has completed the Naramata Healing Pathway as well as the Healing Touch International Certification Program.


