HISTORY OF THE PARISH OF ST. MATTHIAS

The parish of St. Matthias was established in west Edmonton in the fall of 1988. The parish was created from the amalgamation of St. Barnabas parish and St. Philip's Mission. The newly constructed church was dedicated on Palm Sunday, April 12, 1992. A large parish hall was added in 2004. We gratefully acknowledge that we are located on Treaty 6 Territory.

ST. MATTHIAS PARISH DEMOGRAPHICS

By the Numbers

The following information was compiled as of May 2022:

- 115 families on our parish list
- 340 parishioners

Like most churches, St. Matthias is slowly emerging from the Covid-19 pandemic. Although we have lost some parishioners, we are grateful our numbers have remained steady, thanks in part to new families with children who have joined the congregation in recent months. As a result, we have seen an increase in Sunday School attendance, and participation in our morning coffee and fellowship following the Sunday 10:00 am service.

Services

Currently, there are 2 Sunday services: a BCP Eucharist at 8:30 a.m. and a 10 a.m. BAS Choral Eucharist.

We have recently initiated a Wednesday-morning prayer service led by one of our Lay Readers.



During Lent and Easter, services include: Ash Wednesday, Palm Sunday, Maundy Thursday, Good Friday and two services on Easter Sunday at 8:30 am and 10:00 am.

There are two services on Christmas Eve, and one service at 10:00 am on Christmas Day.

In the past, special services have included: Healing Services, Remembrance Day Services, Prayers and Music on the Patio and Pet Blessings. St. Matthias is a community that embraces these types of services, and we are excited to grow with ideas from our parish and new rector.

Baptisms, Confirmations, Weddings, and Funerals

At St. Matthias, the Rector is responsible for helping to prepare individuals for baptisms, confirmations, weddings, and funerals.

Ministry Support

In addition to a full-time Rector, the parish has an Associate Priest who works ten hours a week, a half-time music director (20 hours/week) and two lay readers who are available to help with preaching and other ministries.

Our administrative assistant (25 hours/week) is responsible for hall rentals and carries out related administrative requests from the Rector, Wardens, and Vestry. The cleaning of the church complex, snow removal and general maintenance is contracted out. We are fortunate to have a dedicated group of volunteers who support our paid staff.

OUTREACH AT ST. MATTHIAS



In our continuing efforts to further the kingdom of God, St. Matthias actively seeks out a variety of outreach opportunities. We support donations to PWRDF, The Edmonton Food Bank and Inner-City Pastoral Mission with donations from our parishioners. We support the Youth Empowerment Services with donations of food and

sundry items. Our church serves as a weekly Food Bank Depot to West Edmonton and was able to maintain this vital service without interruption during the pandemic. In addition, we have volunteers from the parish that tend and nurture three garden boxes. The fresh vegetables that are harvested during the summer help supplement the Food Bank hampers that are collected each week.

For years we have been active in the Inner-City Pastoral Mission(ICPM) by having a co-ordinator organize lunches and provide seasonal support at the Bissell Centre. We offer affordable hall-rental rates to non-profit organizations. Currently our Vestry is considering a proposal that will provide the use of our hall to various non-profit organizations at no cost by absorbing the cleaning/insurance costs. This is currently in the formative stages and hope to finalize further planning with this soon.

We are blessed to have a generous congregation who are both socially aware and sympathetic to charitable organizations who put out the call. Whether donating time, money, or supplies, they are quick and eager to respond to those in need. The examples mentioned above are only a few of the charities and organizations that we have supported over the years. With the support of our new Rector, our vision is to expand and broaden our outreach ministry so that our efforts will have a greater impact.

ST. MATTHIAS PARISH GROUPS AND ACTIVITIES

ACW

Although currently there is no formal ACW structure, volunteers, (both men and women) still host or coordinate periodic hall functions. In the past, the ACW provided catering for receptions following funerals and other services and had been involved in outreach to the community in addition to generously providing the parish with monetary gifts.





Altar Guild

The Altar Guild at St. Matthias consists of dedicated volunteers who faithfully prepare the altar for our worship services, including Baptism, Confirmation, Wedding, and Funeral Services. At Christmas, Easter, and Thanksgiving the sanctuary is beautifully

decorated according to the season, all of which is made possible by monetary gifts from our parishioners.

Bible Study

Prior to the pandemic, our Rector led bible study on Wednesday mornings that would discuss the coming Sunday's scripture readings. Although the Wednesday bible study has been suspended, a Bible Discovery session led by our Lay Readers is being offered on Saturdays through June and July to sustain this ministry until our new Rector is in place and we can establish a more permanent program.

Book Study

Shortly before Lent and Advent, parishioners are invited to read a book selected by clergy and then gather during the season to discuss important themes and ideas. The clergy-guided discussions focused not only on exploring and deepening our faith in relation to the text but, also encouraged participation in a relaxed and safe environment. We look forward to more opportunities to learn and grow in our faith.

Men's Breakfast

This event is currently being revived. It is an opportunity for men of all ages to gather in an informal fellowship.

Music



Our gifted music director is an integral part of our worship and church life. While we do not currently have a choir, we have a Music Collective who present their offerings, most often at the 10:00 a.m. Sunday service and at special services.

Currently, the Music Director and Music Collective are actively participating with children and youth from the parish on some new musical projects and hope to continue and expand this initiative. Pre-Covid, our Music

Director encouraged group participation with the formation of an ad-hoc large group choir for celebration of music at both Easter and Christmas Eve services and we hope to return to this soon. It is important to our congregation and our Music Director to grow the overall music program in collaboration with our new Rector.

Other Events

Each Sunday we enjoy a coffee hour following the 10:00 a.m. service, hosted by a roster of volunteers. An ever increasing group of parishioners meet in the church hall (enjoy a light snack and beverages) to grow closer with fellow members of the parish.



Pre-Covid, we hosted two post-church BBQs: one in June to kick off the summer and celebrate the conclusion of the school year, and the other in September to celebrate the start of a new school year. The congregation gathers for some laughs, food, games, and fun for all ages!

Prior to the pandemic, Shrove Tuesday was an occasion for a gathering of sweet-toothed lovers of sticky pancakes, which is enjoyed by young and old alike. During the pandemic, it was uniquely held online.

This summer we are holding a community carnival and vehicle trunk sale in our spacious parking lot which will include games, food, music, and fun! This is an opportunity for us to come together as a congregation and create visibility in the wider community through hospitality and outreach. Our hope is to provide a meal to over 200 individuals who are currently in need of the Food Bank resources. In addition to the carnival coupons we will be distributing to the families in the neighborhood, 11 elementary schools have also been invited to join the festivities. A portion of the funds raised will help meet our renovation expenses.

St. Matthias has one of the largest Anglican church halls in the city allowing us to host larger-sized gatherings, like Diocesan Synod and ACW meetings. Parishioners and visitors to our church home are impressed with the large and well-equipped multi-purpose hall, in addition to the center stage and adjacent commercial kitchen.

REACH

In 2015, St. Matthias participated in the REACH Initiative which raised over \$45,000 for programs. The initial plan for funds raised was threefold:

- 1. support and grow the music program
- 2. support and grow the children's and youth ministries
- 3. increase outreach opportunities

Successful Outreach Initiatives

Supper and Service (community dinner)

One of the first REACH initiatives was a Supper and Service offered once a month on Wednesday evenings. With Sundays becoming increasingly busy for families with young children, the Wednesday night Supper and Service was a chance for families to gather, share a hearty free meal and attend a quiet prayer service. Prior to the pandemic, volunteers prepared a home-cooked supper in the hall after which the Rector would lead an evening prayer service in the church. The evening included scripture readings, a psalm, music, and the occasional short video.





Collective Kitchen

Prior to Covid we hosted and provided food for two Collective Kitchens. Funded by REACH, its purpose was to offer affordable meals to seniors and others that had a need for food preparation assistance. A small group of dedicated volunteers planned menus, organized the event, purchased food and helped prepare the meals. The Collective Kitchens were about more than just food, they also offered everyone the chance to gather and connect.

Foot Clinic

REACH funds were also used to subsidize a Foot Clinic held at St. Matthias by a registered nurse.

Community Garden

Initially, St. Matthias community garden boxes were built to grow produce that would be used for our Collective Kitchens, but the fresh produce has also been used to supplement our weekly Food Bank Depot.

Gospel Jam

Our parish takes great joy in offering hospitality and nothing is more inviting than music and food! 'Gospel Jam' was an uplifting and joyful evening of music and fellowship. The evening began with a free meal in the church hall and progressed into the church with live entertainment provided by many parishioners and invited guests who offered their musical gifts. A second music ministry event followed with guest speakers/musicians, wine, and cheese. Both events brought many individuals from outside of the parish to gather with us in celebration. These outreach initiatives were funded by our REACH funds.





SUNDAY SCHOOL AND YOUTH MINISTRY

Our young people are vital to St. Matthias. As young members of our congregation, we believe that active participation will enhance their spiritual development and nurture their gifts and talents while preparing them to be church leaders of the future.

Our vision is to grow our youth ministry and encourage regular attendance. To do that, we will be providing spiritual guidance for growth through creative structured programs that introduce them to Gospel, and by welcoming their presence among us so they feel loved and valued in their home parish.

Currently, we have Sunday school for our younger members, and interest from six to eight youths who want to be confirmed in the coming year.

Now that COVID restrictions have relaxed, the youth will be holding a variety of fun nights every few months to which they can invite friends from outside the parish.

PARISH FINANCES

St. Matthias was fortunate in being able to maintain a small surplus each year. We had a healthy building fund that had been built up over the years, however, due to recent essential renovations, our building reserve fund will be depleted within the next few months.

The financial ramifications of the pandemic have caused some immediate concerns. Our financial stability relies on hall-rental revenue which decreased significantly between March 2020 and the first quarter of 2022. While we are encouraged by the interest our space is now generating and are confident that the revenue will rebound, we are cognizant that this will take some time. We are encouraged that the Ladybug Playschool has continued to operate continuously during the pandemic. They pay rent monthly for a room designated solely for their use across from the church hall and kitchen.

We are very pleased that we have always been able to meet our financial obligations, including our commitments to the Diocese. However, in years past, we have had to supplement our giving with ongoing fundraising events to be able to meet these obligations. Until givings can sustain our financial obligations, St. Matthias will be seeking fundraising and additional income opportunities. St. Matthias operates on a bare-bones budget. We do not have reserves to draw upon and must rely on parishioner donations, government grants, hall rentals and fundraisers to meet our annual targets.

While we currently rely on hall rental income to assist in our operating expenses, we realize this is not ideal and it is hoped that through stewardship efforts we will be able to rebuild our maintenance fund that has been depleted by major maintenance expenses

and provide for further outreach efforts in the future. Our Administrative Assistant manages the renting of the church hall. Recently, we have hired a contract person to assist during evening and weekend rentals on a cost-recovery basis. Most of our regular givers use either pre-authorized withdrawals from their accounts or e-transfers directly to the church, with a handful still using envelopes.

It takes approximately \$20,000.00 a month for the church to operate. At this time, we are in a position financially where we must rely on hall-rental income to meet our **operational** budget. It is the goal of the parish that we grow to a point where rental income would be used as the source of funds for programs outside of operations, such as outreach.

We are currently raising funds to complete a bathroom renovation and upgrade our IT systems.

OUR FACILITIES

The Parish of St. Matthias is in west Edmonton on Callingwood Road (62 Ave) and 188 St., east of the Anthony Henday ring road.

The total building size is 1293.18 sq m and is large enough that we can simultaneously enjoy multiple functions. The entire facility is wheelchair accessible.

Our sanctuary has an open-beamed ceiling and stained-glass windows. Each window, designed by a local artist, was purchased by a member or family of the congregation. The sanctuary comfortably seats 160 people and has the capacity of seating 200 when necessary. It has a piano wired into the sound system. The sound system allows for multiple microphones, usually on the lectern, and a wireless one for the Rector. The Sanctuary is carpeted and has chairs which allow us to reconfigure the space.

Next to the Sanctuary is a private chapel with a large stained-glass window, donated by the ACW. Adjoining the Chapel is a large office used by the Rector.

In addition we have a main office for the Administrative Assistant, a Music Director office and another office which is used as needed; often by the associate priest, the Sunday-counting team, etc.

St. Matthias has a large central classroom for Sunday school and Church meetings. This room includes basic kitchen facilities.

A major feature of our church is the main hall. It has 3944 square feet of open-floor space, a twelve-foot ceiling and a 204 square foot stage at one end. The hall can seat 230 at tables and approximately 400 in theater seating. It has an attached kitchen that is approved by Alberta Health Services for food preparation with two ovens, two refrigerators and a commercial dishwasher.

In 2020, we renovated washrooms situated just outside the hall which allows us to rent the hall while maintaining security for the Sanctuary area. There are also two washrooms adjacent to the Sanctuary, which are currently being renovated.



The hall has an in-house sound system, projector and 146-inch screen, as well as a stage sound system which is used for presentations, dances, and other social events. We are also equipped to broadcast our services via closed circuit from the sanctuary to the hall when the sanctuary is overfilled. This gives us the capacity to have up to 600 people attend a service.

Our parking lot consists of 60 stalls with additional on-street parking.

St Matthias hosts many different types of events at our facility, including Synod, Diocesan meetings, church socials, outreach clinics, business meetings, a Karate club, and even golf lessons. We also rent our sanctuary to a Filipino Congregation from the Diocese on Sunday

afternoons and enjoy the comradery this group brings to our parish. They are served by their own clergy, however they are guided by our administrative support.

We have recently completed a full rectification of our exterior water drainage and related landscaping. The cost to do so was significant. Our next big commitment will be to replace the exterior of the building, which will also be costly and will require substantial fundraising and/or loans.

CHURCH NEIGHBOURHOODS

St. Matthias is one of the few Anglican churches in west Edmonton, St. Matthias serves culturally and socioeconomically diverse neighborhoods. We are primarily residential, with new development, located closely to feeder roads. The immediate proximity neighborhoods, include developing neighbourhoods, well-developed neighbours and senior complexes. We are in close proximity to neighbouring parishes which include, Our Savior Lutheran Church and Callingwood Road Presbyterian Church which we have joined together for Tea and Hymn Sing, Knitting Group and partnered in outreach to ICPM. Coming out of COVID, we look forward to exploring new opportunities to collaborate with neighbourhood organizations to support the community.

The Anthony Henday ring road affords quick access to St. Matthias from all locations in and around Edmonton. Nearby, there are three public elementary schools and two Catholic elementary schools. As well, S. Bruce Smith Junior High School is only a few blocks away.

City of Edmonton

Edmonton is the capital of the Province of Alberta. The Edmonton Metro area has a population of about 1.5 million. Edmonton is a multicultural city, a major economic base for northern and central Alberta, and one of Canada's premier research and educational centers. We have a world-class international airport.

Education

The University of Alberta in Edmonton is the oldest university in the province, and a top 5 Canadian University with over 40,000 students. Edmonton also is home to a number of other publicly funded post-secondary institutions including Northern Alberta Institute of Technology (NAIT), MacEwan University, Concordia University, and the privately funded King's University.

Athabasca University, a distance-education university, is also a viable educational option headquartered in Athabasca, two hours north of Edmonton.

Schooling from kindergarten to grade 12 offers a variety of options from the Public and Catholic school systems as well as various charter and private schools. Information on their programs can be found on their respective websites. Some schools instruct in French immersion as well as other languages and some place emphasis on religion, academics, sports, and the arts.

Recreation and Sports

Edmonton's North Saskatchewan River valley is the longest urban trail system in North America, providing enjoyment of nature and exercise to hikers, walkers, joggers, and cyclists. Our new river valley-to-downtown funicular is a real treat and increases access to the river valley trails. The city is home to many community parks with playgrounds and sport fields, and camping facilities.





Community leagues, led by community volunteers, and in partnership with the Edmonton Federation of Community Leagues, organize sport programs and teams for children. All ages enjoy facilities for sports such as skiing, skating, hockey, curling,

soccer, swimming, golfing, and softball, to name a few. We are in close proximity to Jamie Platz YMCA.

Sports fans have access to professional sports teams including the NHL Edmonton Oilers and the WHL Edmonton Oil Kings. Edmonton is also home to 14-time Grey Cup Champions Edmonton Elks. In addition, Edmonton is the home of the back-to-back CEBL Champions Edmonton Stingers and the newly formed Edmonton Riverhawks, and FC Edmonton.







Culture

The arts, theatre, and music scene is vibrant in the City and Edmonton is home to the Art Gallery of Alberta, the Winspear Center (home of the Edmonton Symphony Orchestra), the Citadel Theater, the Royal Alberta Museum, the Northern Alberta Jubilee Auditorium (home to the Edmonton Opera Society), the Telus World of Science, Fort Edmonton Park, and the newly-renovated Stanley A. Milner Library - the jewel of Edmonton's municipal library system. The Edmonton Valley Zoo and the Muttart Conservatory are examples of other popular visitor destinations.





Edmonton is known as Festival City for the many festivals, including Fringe Festival, Taste of Edmonton, The Edmonton Folk Music Festival, Edmonton International Street Performers Festival, Ice on Whyte, Silver Skate Festival, Edmonton Blues Festival, Jazz Festival, Edmonton Heritage Festival, The Works Art & Design Festival, and the Festival of Trees at Christmas, as well as numerous others. Edmonton also celebrates pride month in June with parades and festivals.





Health Care

There are several large hospitals in Edmonton including: The University of Alberta Hospital is a research and teaching hospital, The Stollery Children's Hospital, Mazankowski Heart Institutions, the Royal Alexandra Hospital in north central Edmonton, the Misericordia Community Hospital in west Edmonton, and the Grey Nuns Community Hospital in southeast Edmonton.





Retail

Edmonton is home to the largest shopping mall in Canada: West Edmonton Mall. As well, there are many other malls, retail outlets and local artisan stores throughout the city. Dining options are numerous and varied in ethnicity, reflective of the region's multi-cultural environment.





National Parks

Edmonton is a four to five-hour drive from the province's two main national mountain parks.

Jasper is due west and Banff is to the southwest. Elk Island National Park is just 35 minutes east of the city. All are part of the National Parks system, and all offer world-class walking, hiking, cycling, sightseeing, wildlife viewing, camping, and in the case of Jasper and Banff—mountain climbing and world-class downhill skiing and snowboarding, and golfing opportunities for all ages and abilities.





Climate

Edmonton's weather is dry with snow and cool temperatures, averaging from -3C to -20C in the winter months and averaging 18C to 25C in the summer. As in most parts of the world, there is a growing trend toward brief periods of more extreme temperatures in the winter (-20C or colder) and in the summer (29C or higher). Edmonton is a great place to raise a family – a great place to live!

Much of our administrative technology is outdated.	We have a solid IT plan that is already partially funded, as well as a gifted technician.
Youth consistency in our church.	We had an impromptu, fun Christmas pageant in 2021 and now the children are eager and willing to regularly be part of the Sunday service and participate in other activities (i.e. carnival, greeters, music).

Our church dynamics are changing. Our parishioners are from many walks of life and from many parts of the world. Our hope for the future of St. Matthias is to take the opportunity to share and learn from each other so that we grow to be more multicultural, more inclusive, see an increase of family participation and a parish that celebrates all ages and talents.

2021 Financial Statement

Statement of Financial Position:

As mentioned in the treasurer's report, we ended the fiscal year with a small surplus. Adding this to the cash on had at the end of 2020 we are left with a comfortable cushion in our accounts for unforeseen expenses.

Of note on this statement:

- We have approximately \$80,000.00 in accessible cash at the end of 2021, however about half of that is allocated for maintenance and REACH
- The \$4238.80 due to the Diocese is an outstanding amount owing from Padi Eric's salary this is a liability on paper only, but needs to be reported as a liability

<u>Statement of Operations – General Fund:</u>

On this statement you will see the breakdown of revenue and expenses, as well as the \$13,000.00 excess at year end. Of note on this statement:

- Seasonal and memorial donations increased this year, as well as funds received for the purchase of four glass blocks
- The functions and events total (schedule 1) includes hall rentals, the rent we receive from the Filipino Congregation, playschool rent and church calendar sales
- The miscellaneous revenue this year included three grants and the transfer of building funds to cover the cost of the drainage project
- Although we received the wage subsidy, Rev Pickett's salary is higher that what Rev Tiessen's
 was and we were required to cover both during the month of June, which account for the
 significant increase from 2020
- The apportionment to the Diocese as well as insurance increased from 2020

Statement of Operations – ACW:

The ACW account was inactive during 2021.

<u>Statement of Operations – Filipino Congregation:</u>

The expenses for this account exceeded the revenue by over \$3000.00 over the course of 2021. The outstanding amount owing to the Diocese becomes an accounts payable for that congregation and will be addressed before paying 2022 salary, but after rent to the general fund has been made.

Minutes of the VIRTUAL Annual General Meeting of the Congregation Sunday, February 21, 2021 11:30 am by the Zoom online platform

The MC for the virtual Annual General Meeting was Dony Alex. In advance of the meeting Dony provided an instruction sheet detailing how voting would be handled in the meeting, and at the beginning of the meeting Dony offered instructions as well as a demonstration of a sample vote.

Ben and Pippa Acquaye said a word of thanks to Tracey and Leanne for their work with the Sunday School Children. Ben also said a word of thanks to Evan Thomas who has helped Josie and Thomas with some piano music.

The Ven. David Tiessen made a note of thanks to Evan Thomas for persistence and patience regarding music through this difficult season when congregational music has not been possible. He also made note that Evan is taking a leave in June, July, and August for time to rejuvenate.

Since this AGM has remained tightly focused on the core matters for AGM, there is intention to meet again once covid allows for this in order to discuss parish life more widely, including some of the facility matters for the future as noted in the AGM report.
