Cindy and Trevor met with VanCity and determined that the following individuals have signing authority for the GIC account: Trevor Harris, Hugh Kerr, Marilyn Caldwell, Kevin Haberl, and Louise Martin. The current balance of the GIC is \$103,856 and the term is up in July. Cindy and Trevor arranged for the GIC to be paid out at that time rather than have it roll over as it has been doing. Once it is paid out, we have more options around reinvesting it, and hopefully at a better rate. Cindy and Trevor were advised to meet with their "Wealth Relationship Manager" prior to the end of the GIC term for options available. At that time, a Letter of Direction, signed by two of the signers on this account will need to be prepared for VanCity.
