Message from the Ministers

When we think about this past year, two things come to mind. We began the year with the fervent promise of vaccines—vaccines that would hopefully bring an end to a difficult pandemic—only to be thrust once more into a holding pattern as the year wore on.

At the same time, in the Church at least, we carried on as before, even while knowing we would need to adapt and plan for something new. And in August, we did, indeed, start something new: a unique and exciting partnership between our three communities of faith.

Staying the course while also embracing change is the nature of our faith. We do our best to remain engaged and committed, all the while aware that life throws things at us that we can't possibly anticipate. Yet, we trust that God will be with us to see us through these circumstances. We try to stay open to where the Spirit might be leading us. And we remain hopeful, with "open-eyed alertness for whatever God will do next."

We might be tempted to say that we don't have much to report this year, yet our Communities of Faith remained active, engaged and prepared. Between the three churches we continued to worship together online and then in-person. We made lunches that fed dozens of children, served up Turkey suppers, made pies, delivered little parcels to those who were isolated or lonely, studied scripture, offered warm jackets and winter gear, offered forums for conversation and learning, provi<mark>ded services and solace to those</mark> who suffered loss and grief, raised funds, and went on with the work of the church as faithfully as we could. We did our best to reflect God's light to the world.

Much of the year we found ourselves deeply grateful: for our new partnership; for the leadership in each congregation; for the support offered and received; for the small touches of grace encountered in the eyes of friends and strangers; for the health and wellbeing of many in our congregations; and most of all, for community.

Thank you for being the faithful, beautiful People of God that you are.

Message from the Board Chair

I'm sure we all thought that by now we would be "back to normal". As you know that hasn't happened and in fact, we're not sure what "normal" is anymore. In 2021, we continued to face each COVID road bump, developing closing and re-opening policies and protocols to allow our ministries to operate in the safest way possible. We pivoted, adapted, planned and replanned as have all of you. And in the midst of the uncertainty of COVID, we have actually had a good year of exploring opportunities and meeting challenges.

On the challenges front, we continued to negotiate with the Town of Okotoks regarding a shared parking lot with the new River Tract Development. In the end, we determined that it was not in our best interests to enter into that agreement. We continue to look for other ways to partner with our larger community. One of those ways was to install a new and improved audio-visual system this Fall. We are working to partner with musical groups and individuals to develop a welcoming and high-quality performance space. We will be looking to market this space more widely in 2022.

On the financial side of things, we noted a decline in income due to lower in-person attendance, fewer fundraisers and less rental income. This deficit was eased by the government subsidies we received, but that program has ended. Expenses, especially for the building - maintenance, insurance and utilities - are all increasing each year and we will need the income to cover these expenses to keep our building in a condition that will make it attractive to renters in our community. The Board is reviewing the 2022 Budget to see where efficiencies can be found.

As well, three members of the Board and Rev. Julia, attended a four-session stewardship course to learn best practices for ensuring that we can fulfill our call to be the church in our community.

Outreach to our community continued including one new initiative: The Affordable Housing Fund was added to Fund 2, providing a way for people to access affordable housing through the granting of funds for such things as the building of secondary suites.

The biggest change we all saw this year was, of course, our new partnership with The United Church in the Valley. Rev. Julia and Rev Matthew continue to work out the logistics of this new arrangement and we, in turn, have been blessed with two amazing preachers and a growing relationship with the members of the United Church in Turner Valley. The Chairs of the three boards met recently with the Ministry and Personnel Chairs and Rev. Julia and Rev. Matthew for our first review of the new arrangement. We identified where things are going well communication and enthusiasm for the new arrangement - and what we can do to streamline and support areas where the work could be rebalanced or reduced th<mark>rou</mark>gh more volunteer involvement.

Overall, it has been a fulfilling year, in large part because we have a Board that can debate, consider and make decisions in a spirit of collaboration and concern for our church. The differences in opinions and experiences are our strength. I am so thankful for every Board member, for our staff and for every volunteer who loves this church and shows it with willing hands and hearts.

We can take encouragement from the fact that we are still here, serving each other and our community, learning to love better and live more wisely. We have much to be thankful for and much to be hopeful for in 2022. Thank you for hanging in there with us.

2021 Year in Review

APRIL 2021

Apr. 1: We celebrated Maundy Thursday with a Seder Dinner. A Seder meal is a Jewish tradition that was set out in the book of Exodus as a means of remembering the original Passover when the Hebrews were finally freed from the clutches of Pharaoh. A Christian Seder takes the same basic preparation and elements of this Jewish meal and ritual, modifying some parts. It is celebrated on Holy Thursday as the Last Supper celebrated by Jesus and his disciples was almost certainly a Seder meal. This year we gathered in our own homes meeting via Zoom, reciting the story of Israel's redemption from bondage in Egypt.

Apr. 2: This year we did not have a Good Friday service. Instead, community members were invited to come to the church for a time of reading, reflection and prayer. People were invited to lay their struggles at the base of the cross.

Apr. 4: Easter at the Big Rock was held virtually.

Apr. 6: The Government of Alberta declared a "Day of Multi-Faith Prayer and Reflection". This day acknowledged the importance of faith and faith-based communities for Albertans, especially in responding to the difficulties of the COVID-19 pandemic. In these challenging times, connection to faith and community has played an integral role in cultivating hope and building strong, connected communities. Throughout the COVID-19 pandemic, it has been uplifting to see how faith-based organizations continue to play an essential role in maintaining social connection, supporting mental health, and building resiliency among their communities.

Apr. 8: Members of the church demonstrated outside the Foothills MP John Barlow's office in High River in support of the National Vigil Guaranteed Livable Income for all Canadians.

Apr. 11: Holy Humor Sunday

May 2021

Mackenzie Misura accepted the summer student position, funded by the Government of Canada. In her younger days Mackenzie was part of the congregation and returned as a summer student while she was between semesters at the University of Alberta. She worked in the office with Diane and Julia, as well as doing some odd projects around the church!

May 10: The Town agreed to sell 3.3 acres of land in the D'Arcy Ranch neighbourhood to Westwinds
Communitiies and the Brenda Strafford Society. The land is earmarked for an affordable housing development with rental units and transitional, secondstage housing for women and families fleeing abuse.

May 27: The Tkemlúps te Secwépemc (Kamloops Indian Band) announced that ground penatrating radar had located the bodies of 215 children in unmarked graves.

Next week is mental health week (May 3-9). Over the past year more Canadians have reported a deterioration of their mental health due to isolation, loneliness, and from living in this state of limbo with no certainty of the future. In these times we have to draw on the resources we have and find new tools and activities that give us some sense of purpose and resiliency and resolve. Research shows that recovery from a natural disaster can take up to 5 years.

Sermon: May 2 -Don't waste this time by Rev. Julia Kimmett

Travel restrictions with Covid-19 again prohibited our Mission Possible DR team from travelling to the Dominican Republic. However, we continued to support the T.E.A.R.S. charity through donations to the church, school and programs in the community. One special project that OUC funded in 2021 was the installation of the lights for the soccer field. In previous years we fundraised to help build up the land and grass to create the soccer field for the youth of the barrio. This will allow the soccer program to have practices and games past 6 pm when the sun sets. T.E.A.R.S. now has the only soccer facility in the surrounding area with lighting thus allowing not only the expansion of their program but the entire city of La Vega.



Consistent with our church's ongoing concern over the lack of affordable housing in Okotoks our Board has set up a stand-alone Affordable Housing Fund so we can continue to play a role in addressing this crisis. Members, adherents, and friends of Okotoks United can contribute to the fund and members, adherents, and friends of the church can access the fund to help create affordable housing in our town. The Fund is in its early stages of development but to date, thanks to the generosity of our church family, close to \$3,000 has been donated.

Residential Schools

Until 1969, The United Church of Canada was involved with Canada's "Indian Residential School" system, which resulted in a painful legacy for many Aboriginal people and their communities.

During the 19th and early 20th century, federal policies were undergirded by a conviction that First Peoples needed to be assimilated into Western European culture. Children were removed from their families and communities to attend residential schools. By discouraging First Nations' languages and cultural practices the schools played an important role in carrying out this policy of assimilation. There were day schools in some communities, but due to isolation and seasonal movements of First Peoples, it was often deemed more suitable to establish large residential schools in permanent settlements.

During the 19th century, both the Methodist and Presbyterian churches were highly committed to universal public education (for example, noted Canadian educator Egerton Ryerson was a Methodist minister). At the same time, there was little corporate understanding of the importance of cultural sensitivity in both education and gospel proclamation. Thus a mission goal of providing education and proclaiming the gospel was not tempered by respect for the existing culture, values and spirituality of First Nations.

With rare exceptions, the national policy of assimilation was not questioned by the churches. This uncritical approach to mission enabled the church to become an agent of government in promoting the schools. Between 1849 and 1925, the Methodists and Presbyterians operated a number of schools. In 1925, at the time of church union, the United Church assumed the responsibility for 12 schools of which the last one closed in 1969. The United Church also operated two residences (Kitimaat and Teulon) where children from out of the community attended day schools. In total, the Roman Catholic, **Anglican Presbyterian and United** churches operated some 130 Indian Residential Schools.

The United Church was involved in the following Indian Residential Schools: In British Columbia - Ahousaht, Alberni, Port Simpson, Coqualeetza; in Alberta - Edmonton and Morley; in Saskatchewan - Round Lake and File Hills; in Manitoba - Norway House, Brandon and Portage la Prairie; and in Ontario - Mount Elgin (Muncey). Of approximately 80,000 students alive today, about 10 percent attended United-Church run schools.

Residential Schools con't

As the school system evolved, it was the federal government that set the standards and provided the funding (often inadequate) for the schools, and legally required children to attend. The church was involved in suggesting to the government potential principals for the schools and also hiring other staff. The name of The United Church of Canada was integral to the identity of the schools and, aside from a few voices rarely heard by those in power, gave unquestioned assent to the policy of assimilation that informed the school system.

"We now realize that the offering of the churches and of countless faithful and caring servants of the churches, through their participation in the residential school system has tragically resulted in pain and suffering and injustice for many...." Repentance Statement of the 36th General Council, 1997

In spite of the harm done by this system, some students speak positively of acquiring an education that allowed them to move forward in the "White man's world," to gain cross-cultural skills, and to provide leadership to their people in transition.

In the past 20 years, the United Church has begun a directed, prayerful, and concerted effort to become more informed and responsive to the harmful affects of the residential schools on First Nations peoples and cultures. In 1998, the church offered a formal apology to former students, their families and communities. In an amazing sign of God's grace among us, it has been the outstretched hands of many Aboriginal people that has offered an invitation to healing. The journey toward reconciliation requires a long-term commitment. Initial steps have included the church's Healing Fund, its participation in the claims settlement processes, advocacy for a Truth and Reconciliation Commission, collaboration in the historic Indian Residential School Settlement Agreement, archival research and increased resources for reconciliation and right relations work.

Candice was contracted in 2015. Through this work she discovered a love for children that led her to return to St. Mary's University to become a teacher. Over the years she provided countless children's talks, Sunday morning lessons, games and crafts (working with congregants to add variety and help to build relationships between them and the children). She also directed many Christmas pageants and Palm Sunday plays, youth group activities such as mini golf, bubble soccer, ghost tours, Halloween parties and so much more. Candice also became a member of OUC and sat on the church board.

Jun.: Rev. Julia was available for Visits with the Vicar on the Veranda on Tuesdays, Thursdays and Fridays from 1-3 p.m. These physically distanced visits were intended for anyone needing a little time to get out, catch up or just share what's was on their heart and mind and included a time for prayer.

Jun. 27: The Northern Spirit Regional Celebration of Ministries Service was held at First United Church, Fort Saskatchewan, where Matthew Heesing was ordained.



Jun.: To date we know of 1323 unmarked Graves: Kamloops. Brandon. Cowesses First Nation. 1323 lives that were not acknowledged with their names.

Jun. 30: A heat dome affected much of Western North America from late June to mid-July resulting in catastrophic wildfires. The entire town of Lytton BC burned to the ground just days after reaching the hottest temperature ever recorded in Canada 49.6 C.

Jun. 30: A pride crosswalk was painted in front of the Elks Hall on Elizabeth Street. Members of the Affirming Ministry, Janet Page and Stewart Thomas, were in attendance.

OCTOBER 2021

Oct. 1: Youth group, for grade 6 and up, resumed from 6-8 pm on the first Friday of the month led by Rev. Matthew and his spouse, Marlee.

Oct. 3: Was a warm 20 C day that laid the way for our 2nd Turkey-to-go Supper. We sold 230 hot take-out turkey dinners and raised \$3,106.83 after expenses. About 40 volunteers cooked veggies, carved turkeys, baked pies and buns, dished out the meals, bagged the meals for pick up and cleaned up. We were done in record time.

Oct. 5: Plans for, "Faith Alive In the Home", were cancelled.

Oct. 5: A Social Justice group met once to explore how congregants could address social justice issues.

Oct 16: Mz behavin' and The Big Rock Men + 1 raised \$302.75 for Okotoks Food Bank. The concert was held outdoors in the East parking lot at Okotoks United Church.

Oct. 19: Jacket Racket was offered 6 times between Oct. 19 & Nov. 6 to anyone looking for winter attire. 137 people took items for 221 family and friends. The total number served may be more as two women collected for 2 teachers in need for their classroom. Nineteen volunteers helped to run this event. Excess items were distributed to various organizations.

NOVEMBER 2021

Nov. 5: Karen Pryznyk offered to help congregants who needed a Covid-19

Vaccination Record which required the use of the internet.

Nov. 10: Members of the Affirming Ministry met with Pam Rocker, to produce a video on becoming an Affirming Ministry process for other congregations.

Nov. 7: Sophia Su joined Okotoks United Church team as our Accompanist.

Nov. 20: "Extreme rain swamped rivers and farmland across southern B.C. and triggered mudslides that blocked every major highway connecting the Lower Mainland to the rest of the country."

2021 Year in Review

DECEMBER 2021

Dec. 1: The Federal Government voted unanimously to ban conversion therapy, the practice of attempting to change a person's sexual orientation, gender identity, or gender expression.

Dec. 4: An End of Life workshop was offered to congregants.

In The United Church of Canada a regional council is an administrative grouping of communities of faith in a local area. The role of the Chinook Winds Regional Council is to encourage and connect communities of faith of The United Church of Canada in Central and Southern Alberta. Chinook Winds Region extends from south of Highway 13 in Alberta to the Canada-United States border.

2021 was the third year of the Regional Council structure. With the continuation of COVID-19, The Regional Council staff continued to work diligently to keep our communities of faith in touch in many ways:

- They presented regular virtual 'town-hall' meetings where they provided inspiring speakers, gave members an opportunity to gather together and they shared information, including guidance in regard to safety measures for churches during the pandemic.



Most of the people we see are referred to us by local Social Service Agencies. If we have a walk-in client, we usually refer them to the Family Resource Centre for assessment as the Social Workers there are able to further assist the clients to access other resources and make a thorough assessment of needs.

The Benevolent Fund is funded solely by contributions from both Communities of Faith. No operating funds are designated toward the Benevolent Fund.

COVID-19 Financial Assistance



During 2021 both the Government of Canada and the Government of Alberta provided a variety of financial assistance programs to individuals, businesses and non-profit organizations impacted by COVID-19. Based on our own research and advice from The United Church of Canada we applied for assistance under 3 separate programs.

Government of Canada Programs

The CEWS (Canada Emergency Wage Subsidy) program which began in March 2020 was extended to October 23, 2021. The subsidy was intended to assist organizations and businesses with employee salary costs based on the decrease in their monthly revenues. The total amount Okotoks United Church received under the Canada Emergency Wage Subsidy in 2021 was \$14, 823.47. This program has now been terminated.

In 2020 we applied for and were approved for funds under the CEBA (Canada Emergency Business Account) program. The \$60,000 CEBA proceeds were received in January 2021. CEBA is a one-time loan from the Government of Canada. The \$60,000 loan is interest free until January 1, 2023.One-third of the loan, \$20,000, will be forgiven if the remaining \$40,000 is repaid in full by December 31, 2022.In December 2021 we repaid \$20,000 of the outstanding balance and plan to repay the remaining \$20,000 by December 2022.

Government of Alberta Programs

The Faith-based and Cultural Facility Relaunch Grant supports faith-based and cultural organizations that have a mandate which includes a religious, spiritual and ceremonial component and operate facilities which are used for cultural, religious, spiritual and ceremonial gatherings. The program was designed to offer one-time reimbursement funding to help offset additional costs incurred in meeting the public health directives for Albertans during the COVID-19 crisis. In June 2021 we received \$5,000.00 from the Faith-based and Cultural Facility Relaunch Grant program. These funds were applied to the upgrade of our Audio Visual system in preparation for reopening in September 2021.
