

Rules of Procedure

1. Voting Member Voting Body

The voting members will be seated by conference in the designated section and shall include: one woman elected by each congregational/intracongregational unit as well as the board of the Synodical Women's Organization.

2. Seating of Voting Members

Voting members shall receive their credentials at the convention registration table before being seated in the section reserved for them.

3. Quorum

A majority of the registered voting members shall constitute a quorum.

4. Privilege on the Floor

Seat and voice shall be granted to the Bishop of the NW MN Synod, or the Bishop's representative, to board members of the Synodical Women's Organization, representative of congregations not represented by a unit, and the representative of the Churchwide Women of the ELCA.

5. Appointment of Committees

The presiding chair at the opening business meeting shall announce the appointment of the following committee:

Committee on Reference and counsel - 4 members

Committee on Elections - 9 members

Committee on Credentials - 4 members

Committee on Claims - 4 members

6. Voting Procedure

To be eligible to vote, a voting member must be seated in the designated voting member section. No proxy or absentee voting is permitted.

- **A.** Two-thirds vote is required for adoption of:
 - 1. Amendments to the Constitution and Bylaws
 - 2. The Synodical Women's Organization budget
 - 3. Other action specified in Robert's Rules of Order, latest edition

B. Voting Cards will be used as follows

Affirmative vote: **Green** card Abstaining vote: **White** card Negative vote: **Red** Card

7. Elections

A. SWO Board Officers and Board Members will be elected to a two year term: All elections shall be by written ballot. The number of votes cast for each nominee shall be announced. Majority of votes cast shall elect.

B. Nominating committee

All elections shall be by written ballot. The number of votes cast for each nominee shall be announced. The person receiving the highest

Rules of Procedure (CONT)

number of votes shall be chairperson. The Nominating Committee members will be elected for a one year term.

8. Motions and Resolutions

Any delegate may make a motion or present a resolution from the floor if the motion or resolution is germane to the topic under consideration. If any delegate desires to add any item to new business that is a motion or resolution for general character and not germane to a pending question she shall:

- A. write a motion or resolution on the appropriate form
- B. provide the signature of five delegates
- C. Submit the form to the committee on Reference and Counsel no later than the opening of the business session

The committee on Reference and Counsel shall report to the Convention with its recommendation for handling such new business, which may include a recommendation that the matter not be considered Actions taken by the Convention shall be consistent with the documents of the ELCA and the documents of the Women of the ELCA.

9. Speeches

All speeches in general discussions, unless otherwise determined by a two-thirds vote of the convention, shall be limited to two minutes. No person shall speak more than twice on the same issue without the consent of the Convention and only after all others have spoken. Speakers must use the microphone, if available, and identify themselves by name, congregational/intercongregational unit, and conference number and name to be recognized by the chair.

10. Attendance

Delegates shall not absent themselves from any meeting of the Convention without valid excuse.

11. Promotional Activities

The wearing of promotional buttons or slogans, the distribution of materials or the carrying of placards to promote one nominee over another is not permitted at the Convention.

12. Governing Parliamentary Law

Roberts Rules of Order, latest edition, shall be the governing law of this Convention, except as otherwise provided in the rules of Procedure of this Convention.

- **LEADER:** As Women of the Evangelical Lutheran Church in America, we again gather at this convention in remembrance of Jesus Christ, our risen Lord and Savior. We come together in this place to worship, learn, and be encouraged in our faith journey. We thank you for safe travel and ask that you keep our loved ones at home safe in your arms during our absence.
- ALL: We praise you, O God, for all that we are and for all that we have. Keep us ever thankful and grant to us a measure of spiritual wisdom and understanding that we might know your will for our lives.
- **LEADER:** Loving God, we come as a diverse and gifted people, ready to serve you and those in our community. Teach us true discipleship and show us how we can use our gifts to make a difference in the world.
- ALL: Come now, Holy Spirit, and enter each of our hearts so that we can go forth in love and power and shine with God's Love and as Women of God Let our Faith bloom to grow in grace, and in the knowledge of our Lord and Savior Jesus Christ.

ALL SHALL UNITE IN PRAYER:

God of all life, be with those sisters who are unable to be present at this convention. Free us from those boundaries we set for ourselves that we might truly open ourselves to others. Enable us to be a joyful people, full of zeal, so that our actions will be a witness to you. Come now, Holy Spirit - dwell with us, comfort us, and strengthen us so we may grow and go to accomplish those tasks before us in the following days of convention. We ask all this in the name of our Lord and Savior, Jesus Christ, Amen.

THEN THE PRESIDENT SHALL SAY:

This Thirty-fourth annual convention of the Northwestern Minnesota Synodical Women's Organization of the Women of the Evangelical Lutheran Church in America is now declared open in the name of the Father, Son and Holy Spirit.

Thank you for all you do for Women of the ELCA! Your time, talents and treasures are needed now more than ever, not only to Women of the ELCA, but also in the world. You also make a huge difference in our churches and communities. Thank you again for all that you do and continue to do!



As promised, there have been some changes in Women of the ELCA. One of our biggest priorities is anti-racism work (you can find more information on welca.org). Here are a few examples:

- 1. A Leadership Event in February 2022 was a digital event titled, "For Such a Time as This: Spirit fed, Spirit led." It was based on the story of Esther. In addition to presidents, all synodical officers and board members were invited as were conference and cluster leaders. Following the event, more training sessions for WELCA leaders were planned. The training sessions were again via Zoom and open to everyone. Training and bringing up leaders are the responsibility of all of us, not just the few.
- 2. Bold Women's Sunday has been moved from the last Sunday of February to the first Sunday of March. Why you may ask because February is Black History Month; March is Women's History Month and includes International Women's Day. This way we do not dilute Black History Month and honoring our African American sisters and brothers.
- 3. Churchwide executive board members can now serve as the churchwide representative at her own synodical convention. As a reminder, a churchwide representative cannot be a voting member of her own congregational unit at her synodical convention. She is also there to serve as a resource not just for your convention, but after as well. God's special blessings on your time together! I am praying for you and your time together. Our Women of the ELCA Purpose Statement is carried out through three different perspectives: **Growth, Community, Action.** They cannot be separated any more than God the Father (Creator), God the Son (Redeemer) and God the Holy Spirit (Sanctifier) can be separated.

Our purpose statement makes it clear that we are a community of women living in relationship to God, one another, the church, society and the world. The Women of the ELCA is organized for mission and that mission is to mobilize women to act boldly upon their faith in Jesus Christ.

So, instead of wondering which issues, programs or resources belong to Growth, which belong to Action and which belong to Community, know that all issues, programs and resources need all three perspectives to be wholly addressed.

Together, the three mission areas provide a holistic approach to living the gospel of Jesus Christ in today's world; they provide opportunities for women to grow in faith and mission.

Mission: Community

Goal: to enable each woman to value herself and others as disciples created in God's image and redeemed through Jesus Christ, and to build up and celebrate relationships that are global, diverse and interdependent.

Mission: Community is about relationship among women of faith. These relationships are disciple relationships, which include God, family other persons of faith, the global. Community, Women of the ELCA units and the unchurched.

Functions:

- 1. communication Use SNOW newsletter, Churchwide publications such as "gather", the Stewardship Planning guide, The Resource Catalogue, and other mailings to call attention to projects, programs and events. Also use the Women of the ELCA website, www.womenoftheelca.org, to be aware of the most current information from churchwide. Share and display the information!
- 2. Stewardship interpretation Encourage a biblical understanding of stewardship. Inform about the purpose of offerings, projects etc.
- 3. Ecumenical Programs—Encourage and coordinate participation on World Day of Prayer, Nations Day of Prayer, Monday Noon Prayer and other community efforts beyond our congregations and denominations.
- 4. Cross-cultural Education Promote and use available community resources and speakers.
- 5. Affirmation of Women Support and uphold each other. Retreats and conventions are great resources.
- 6. Family Relationships Provide family and extended family events and us the community resources available.
- 7. Worship Bring "thanks and praise" to the forefront in our meetings using resources available through the "Resource Catalog of the Women of the ELCA."
- 8. Organization Growth Work toward insuring a welcoming atmosphere, program and schedule with are responsive to the needs of our women.

Diane Teigland Board Member **Mission: Growth Report**

The goal of Mission: Growth is to provide a variety of learning experiences which strengthen each woman as a whole person, develop her potential, and equip her for ministry, each congregation can develop their own ways of making this happen.

Each year at the convention we award First Timers Convention grants. These women that receive these grants appreciate the opportunity to attend the convention and are interested in learning more about the organization.

The Bible Study each month in our women's magazine, **Gather**, gives us an opportunity to grow together in our faith with other women in our congregations. **Gather** offers three multi-session Bible studies per year in winter, summer and fall and two, one-month devotional studies in May and December.

On the 4th Monday of each month we also offer the **Gather** Bible Study, on-line, lead by one of our board members. A link is found for zoom meeting on our WELCA web site. This is a new way to connect to other women and share in a comfortable setting in your own home.

Another way to grow in your faith and fellowship is to attend your spring and fall conference gatherings. These are great opportunities to learn and share, meet ladies from other churches and hear inspiring speakers. Try to attend a conference near you this fall, offer to help out at one, we can always use a new volunteer and remember each and every woman has a gift or talent that is worth sharing with others.

NW Minnesota Synod Women of the ELCA Mission Action 2021

As covid vaccines became available our church women returned to meeting for Bible Study and working on service projects and making quilts. During the shut down many quilts were assembled at home to be tied after they started meeting in person. Even though only 39 churches reported their numbers, it shows the dedication to outreach when people have experienced poverty, famine, floods, hurricanes, fires and war. Jesus asked us to love our brothers and sisters, our action projects are a tangible symbol of this love and concern.

Not only were quilts shipped abroad, but were also distributed locally to newborns, children in the hospital, fire victims through firemen or rescue squads, veterans, people in hospice and nursing homes, homeless shelters and crisis centers, and as gifts to high school graduates, confirmands and baptized babies.

Our women also collected new pillows, blankets and various sizes of sheets to distribute where needed at a variety of community shelters and places like Churches United and Someplace Safe. 306 prayer shawls were crocheted or knitted and distributed.

In addition to putting together kits for Lutheran World Relief, they also assembled personal care kits for local shelters and the homeless. Many hundreds of bags were sewn to hand out in Northwestern Minnesota. Thrivent members took advantage of grant money to purchase materials to put these projects together.

They held toy drives, soap Sundays, Undies Sundays, and collected food and garden produce for the local food pantry. They baked cookies and made soups and hot dishes to be warmed up for homeless people in need. One lady at Trinity in Detroit Lakes rolled 2600 bandages for Global Health Ministry.

I am so proud of the numbers we shipped to Lutheran World Relief.

A total of **540** quilts were made for other people or organizations for local use. Giving someone a quilt is like wrapping them up in love.

On a personal note, Julie and I have enjoyed our time on the synodical board and thank you for the little notes you sent along with your reports. It is with grateful hearts that we thank all of your for your support of our church's world wide outreach to help those in need. We know that your quilts are sent with many prayers for those who receive them. During this time of war in Ukraine and other places, we know the need for all these kits and quilts will be very high. Thank you all for being women of faith and love.

2021 Convention Minutes Northwestern Minnesota Synodical Women's Organization SWO 33rd Annual Convention September 17, 2021 Zoom Meeting at 1 pm

President Marilyn Grandstrand extended a welcome to the 33rd Annual Convention of the Northwestern Minnesota Synodical Women's Organization. She invited everyone present to turn to page 9 in the Convention Booklet to read responsively the Opening of Convention.

Official Call to Order: After the Opening of Convention, President Grandstrand declared the 33rd annual convention open at 1:16 pm, in the name of the Father, Son and Holy Spirit.

Roll call for Credentials Committee: Because we were using Zoom for the business meeting, a poll was taken on the computer with voting members checking in; we had 18 voting members; 6 board members, 1 guest and 1 non-voting member for a total of 28. President Marilyn declared that a quorum was established, and is now open for transaction of business.

Adoption of Rules of Procedures: Secretary Lois Balko moved the adoption of the proposed Rules of Procedure as printed in the Convention Booklet on pages 7 and 8. The adoption of the rules have been moved by the synodical board, no second required. Hearing no discussion, the vote on the motion, which must have a 2/3 vote to pass, was taken and motion passed.

Adoption of the Agenda with Flexibility: The adoption of the agenda with flexibility was moved by the NW MN SWO Board presented by Secretary, Lois Balko, as printed in the Bulletin of Reports; no second was necessary. Vote was taken and motion passed.

Churchwide Representative: President Marilyn shared a video greeting from Lisa Plorin, our convention churchwide representative.

Report of the Nominating Committee: President Marilyn Grandstrand gave a report submitted from board member and Nominating Committee Advisor, Sue Smith, on the following nominations: Vice president (2-year term), Amber Krafnick; Secretary, Sue Ellwanger (2-year term), Roxanne Goulet. Board Members: (Conf 1,2,3) Heather Grafstrom (Conf 4,5,6) Diane Teigland; and (Conf 7,8) Roxanne Swisher.

President Marilyn introduced the current Synodical Board.

Secretary Lois Balko was called upon to give a report of the Synodical Women's High School Scholarship program. She asked everyone to turn to page 45 in the convention book, and expressed the importance of supporting our high school youth as they attend an ELCA College/University of their choice. She also encouraged all of the congregations to send in money to support the program.

President Marilyn announced the nominees for officers. Amber Krafnick has been placed in nomination for Vice president; asked for additional nomina-

tions from the floor; there were none. Sue Ellwanger was nominated as Secretary; no additional nominations were from the floor. The number eligible to vote was 26. Roxanne Swisher made a motion to accept the ballots by a show of "Thumbs up" for easy counting. Pam Olson seconded; motion carried. By a show of thumbs, Amber Krafnick and Sue Ellwanger were both unanimously elected to their respective positions. President Marilyn announced that an election has occurred.

President Marilyn called for the ballot for board members. The following were placed in nomination for board members: Heather Grafstrom (conf. 2,3 &3); Diane Teigland (conf. 4, 5 & 6); and Roxanne Swisher (conf. 7&8). President Marilyn asked for nominations from the floor; there were no additional nominations from the floor.

Again, by a show of thumbs, Heather Grafstrom; Diane Teigland; and Rozanne Swisher were unanimously elected. President Marilyn announced there an election has occurred.

New Business: Patricia Cummins from First Lutheran in Detroit Lakes brough forth a question from her church: will the LWR dates remain the same as written in in convention book; and because many women miss emails or don't have access to the website, can information be done by mail again. President Marilyn replied that the board is looking into ways to get information out in a better manner to each congregation.

Reference and Council Committee Resolution: Roxanne Swisher brought forth a resolution from a congregation in conference 8 regarding the SWO Board establishing a Scholarship Fund for College Women who plan to go into the ELCA Ministry. Ardys Horner made a motion to look into the resolution, determining the cost and where the money will come from; Roxanne seconded the motion. After discussion, Luella Thom from Esther Lutheran Church in Parkers Prairie stated that she donate the first \$350 to the scholarship fund. A vote was taken; motion carried.

President's Report: Marilyn Grandstrand that the "Gather" Bible study will continue this fall until December, with board leaders lined up to give it. Since the in-person convention had to be cancelled for this year, President Marilyn said that the Memorial service for women of our synod who died since March 2020 will be held at next year's convention. We will also hold the 52nd Anniversary of the Ordination of Women into the ELCA Ministry next convention too. She also noted that churches who have completed tie blankets, donate them to their local charities/organizations. If they have just the fabric, they can either keep it until next year or finish them and donate them.

SWO Treasurer, Terry Pipho was invited to address the body and highlight the treasurer's report that is found in the convention book. She presented the budget for the year 2022-2023. Terry made a motion on behalf of the board to adopt the budget; no second was needed; motion carried.

President Marilyn Grandstrand called upon Bonnie Wagner for a report on the Mary Magdalene Awards. Bonnie asked everyone to turn to page 47 for a list

of the women who were nominated for an award. The awards, with a rose pin, will be sent to each women, or a family member for those who have died. She encouraged everyone to be thinking of those women who should be nominated for next year.

Report on Offerings: Terry Pipho reported that offerings of \$2410 were received and that 50 percent will be sent to churchwide; with the other 50 percent split five ways equally to Pathways Bible Camps; Lutheran Bible Camp; Crossroads Lutheran Campus Ministry, Moorhead; Lutheran Campus Ministry, Bemidji; and the People's Church in Bemidji.

President Marilyn called upon Roxanne Swisher to give a report on those that received the First Timers Grant to attend our NW MN SWO Convention this year. Their names are listed in the convention book on page 46. Since the convention was cancelled this year, their grant will be extended to next year's convention in Fall 2022. Roxanne invited everyone to ask friends, particularly younger women, new to the synod or their congregation to apply for next year.

President Marilyn called upon Roxanne Swisher to give an update on the Silent Auction. She encouraged everyone to be thinking about next year and bringing an item for the auction. We are still looking for larger ticket items that will encourage increased giving as the money collected goes to support any women in our synod who will be going the to Triennial Convention in 2023.

President Marilyn introduced this years Convention Committee and extended her heartfelt thanks to them for a job well done.

The 34th Annual Fall Convention of the NW MN Synodical Women's Organization will be held at Bethlehem Lutheran Church in Fergus Falls, Sept. 16-17, 2022. Jacqueline Bussie has agreed to be our keynote speaker then.

President Marilyn introduced the outgoing board members and thanked them for their dedicated service to the SWO.

We closed with the Lord's Prayer.

At 2:34 pm, President Marilyn declared the 33rd annual convention adjourned.



Terminology

Assembly: ELCA's term for the gathering of delegates for decision-making or legislative functions.

Churchwide: Designated term for the whole organization.

CWO: Churchwide Women's Organization.

Cluster: Groupings of congregational units and intercongregational units within the territory of a Synodical women's organization.

Conferences, Clusters, Coalitions: Terms given to groupings established by ELCA synods for the purpose of fostering interdependent relationships among congregations, institutions, and Synodical and Churchwide units for mission purposes. Women of the ELCA clusters normally will follow the same boundaries.

Congregational Unit: The women's organization in a congregation; this may be made up of a smaller group of women in the congregation, but is the term designated for the total women's activity/organization within the congregation.

Convention: Term for the gathering of delegates for decision making or legislative functions within Women of the ELCA.

Intercongregational Unit: A local organization of women from two or more congregations that have no congregational units.

Membership: Refers to the congregational / intercongregational units who have affiliated with Women of the ELCA; it does not refer to individual women.

Reference and Counsel Committee: Reviews resolutions made at the Triennial Convention which are not germane to the stated agenda (that is, new business) and makes recommendations regarding them to the delegate body.

Synod: One of 65 territories of the ELCA.

Synodical Women's Organization: Congregational/ Intercongregational units which are located within the territories of the geographical synods of the ELCA.

SWO: Synodical Women's Organization.
