- We can have a minimum of 3 to a maximum of 5 elders according to our bylaws.
- We appreciate Tim's Spiritual walk, educational journey, and maturity.
  - This is a good step as there are two leaders coming off next year.
- In our discussions through staffing, we completely forgot to think about Tim as an elder because our discussions were so focussed on staffing.
- It took time to discern, knowing the future was uncertain for the Goodwins and Tim's calling.

#### 7. Leadership Update

Tyler Graftaas, Lead Pastor

- Refer to page 7 of the meeting package Vision for 2022
- The areas we focussed on were:
  - Scripture is the word of God
  - Prayer
  - Community
- In looking back we saw these focuses in action. We went through 3 books:
  - "9 Marks" by Mark Devers
  - "Emotionally Healthy Discipleship" by Peter Scazzero
  - "A Church Called Tov" by Laura Barringer and Scot McKnight
- We did not agree on everything, but we did foster growth and development.
- We are in a healthy place, we needed to have uncomfortable conversations about staffing, but it was open, honest, direct, and caring. There was uncertainty, but confidence in one another.
- We started asking questions about what will CHBC look like in 6 years (when pastor Tyler will be 60 years old). Where we currently are, there will be many deaths, what does that mean for us as a church as we look to the future?
- We need to invest, train, and raise the next generation. When deciding on staffing we needed to focus on who are the 1.5 people who will lead in this direction.
  - Youth and the next generation are the focus going forward.
  - Intentional discipleship of the leadership, giving the leaders real-life experience.
  - 10-15 youths are attending on Friday nights with the hope they will encounter Jesus and come to their own faith in Jesus.

## 8. Financials and Proposed Budget

George Day, Treasurer

Motions to accept the 2021 audited financials

We, the members of Crescent Heights Baptist Church Society accept the audited 2021 financials as presented.

There are no significant changes from the unaudited financials from March.

 We ended the year with a surplus, due to an estate gift from Merrill Lathem. 2 gifts totalling 25,000 in 2021. Without this gift, we would have ended in a deficit.

#### ii. Motion to appoint the auditor for the 2022 financial report

We, the members of Crescent Heights Baptist Church Society, appoint Masone and Company, CGA, to audit the 2022 financial records of Crescent Heights Baptist Church Society.

As we are a society, we are required to have audited statements each year.
 Questions/Comments - none.

#### iii. 2022 Financial update

- Correction: The Year-to-date (YTD) Actual should read September 30.
- Forecast 2022 is the Sept amount divided by 9 and multiplied by 12.
- In May/June our bank account was getting low, we asked the staff to take a reduction. Tyler and Angela took 15%, and other staff reduced hours.
- We are currently showing a \$5K loss for the end of the year.
- General fund income of \$247,556 follows the same forecast formula, however, removing any estate gifts from 2022. However, we did receive another gift of 20K.
- With the passing of Les Drew, we received an estate gift
- We are anticipating a gift from the closing of the CHBC Foundation.

#### Questions/Comments:

- Are any of the estate funds going to a special spot or will they go into the general fund?
  - All of the monies have gone into the general fund.
- What would wisdom be in that?
  - We currently have 20K in memorial-designated funds. Where we need the funds is in our general fund. It makes the most sense to apply these gifts to our deficit in the general fund.
  - If we were in a better place financially, then yes it would be good to set the funds aside.
- The cost-sharing in the building and from the other 1212 churches, any surplus goes to a reserve fund (restricted) for maintenance and building improvements.
- For most of the year, we have had a positive bank balance.
  - The reserve funds are often more than our bank balance, if we were to spend the reserve funds, we would have a negative bank balance.
- Where is the reserve fund in the report?
  - It is not detailed in the budget forms.

- On page 15 of the meeting package. We are currently borrowing against reserve funds, to pay for general expenses.
- We are an ongoing business, so we are able to borrow from our own funds. If we were to close down we would be in a hard position to pay out the reserve funds.

#### v. Motion to approve the proposed 2023 budget

We, the members of Crescent Heights Baptist Church Society, approve the 2023 proposed operating budget for Crescent Heights Baptist Church Society, as presented by the Treasurer.

George D. / Weyers D. - Carried

- Background George prepared the first go round of the numbers, then the leadership reviewed, prayed, and edited.
- The focus for staffing was determined to be on youth, and how should we use the staff to further ministries. Unfortunately, we did not have the resources and position for Tim Goodwin. Angela Graftaas has been asked to dedicate half of her time to youth and children's ministry and half to administration.
  - Her salary is now half admin, half ministry.
- Salaries were given according to the CBWC 2023 salary grid. The salary cuts made by staff will be restored according to the grid including an Increase of 3.4% cost of living for Neil and the administrator.
- What does this mean to our congregation how much will general offering and giving need to increase to meet this budget?
  - Many of the options considered meant a 15-20% increase in giving. We felt this was unreasonable.
  - Operating contributions will go up by 5% for the current year.
- The 2023 budget includes 5 weeks of Natalies Salary for when she returns
- Our garbage pickup contract expires on December 7. We are changing companies and going with the City of Calgary, this will save us 7K over the year.
- The Children's choir had received a generous reduction over COVID.
   An increase is planned for January and September, and by 2024 we will be back to the pre-COVID rates.

#### Questions/Comments:

- We are now like a little country church wehere we all need to pull together. We need to have more particiaption from our congregation with one pastor.
- What does colour coding mean on the budget?
  - Green subtotal of grey lines

- Grey subtotal of the white lines
- Yellow shared costs with the 1212 churches.
- In past years we did not charge a standard rental rate, but a portion/percentage of the yellow lines.
- Thank you George for all of your hard work.
  - The process of going through the budget is an agonizing process, we hope that the Holy Spirit was along with us, and we are hopeful for the future.
- Thank you for the good meal and time together.

#### Comments from Lisa on behalf of the Goodwins:

- January is unsettled for Goodwins, we know that Tim has been put in this position. We have received confirmation through friends and Pastor Tyler over the years. With the loss of Tim's employment at CHBC, we don't know where we will be, or who will be paying the bills.
- There is potentially an opportunity for us to move to Crescent Spur to engage in ministry with the Gabert Family.
- We are readying our hearts for change. There are many open doors and will continue to be faithful to God's call.
- Tim and Hudson are home ill today, they are not avoiding the meeting and do appreciate your prayers.

 Update on Tim Goodwin's Ordination Journey Comments Tyler Graftaas

- A couple of years ago Tim returned to school to finish a Master of Christian Studies. He completed the course and will have his graduation ceremony in May 2023. Because of finances at the church this year he was not continued on as paid staff. Tim is ministering as an Elder and we will continue to support him on his pastoral journey with the process of ordination. Different denominations have different procedures. Within our denomination, the church ordains the pastor. Tim will attend a denominational week-long ordination prep course. At the conclusion, he will write a paper and then go before the ordination council made of pastors from across the denomination. Tim will then stand before the ordination council and be challenged theologically, procedurally, and personally. Upon completion, the council will recommend the candidate and provide any alerting concerns. Once all procedures are completed, we will have an ordination ceremony and celebration here at the church.
- Today we begin the process for ordination, God has been working on this for the last 50 years.
- Ordination is recognized within baptist churches, if Tim were to move to a church outside of the denomination, he may need to do ordination procedures with the new denomination

#### Question & Answer

Tyler Graftaas / Tim Goodwin

- How long will this procedure take?
  - The ordination council only meets at assembly (Which is happening this year in June)

- Can Tim take on ministries before he is ordained?
  - Yes, he can get work as a Pastor
     If he were to get a job with another church, we would just pass off the process or ordination to the new church.
  - Tim is a Pastor, he has been credentialled. Ordination is the next level.
  - Being ordained he can perform marriages and can also be a chaplain.



My prayer is that as God's people we will continue to lift up and encourage one another through 2023. Amen!



# Finance

2022 was full of up-and-down events. Early in the year, I was very encouraged by the generosity of the love gift given to Pastor Tyler and Angela, but then in the middle of the year, I was discouraged by our low bank balance and the need for us to ask staff to take a reduction in salaries. Salaries from July to December were \$16,441 under budget. During the budget process at the end of the year, I was saddened when I realized we could not offer a pastoral position to Tim Goodwin.

Some unusual expenses for the year were:

TV for Nursery \$508, Firemen Lockbox replaced \$579, Sump pump repair \$1,649.

Special Income items totalled \$32,000 in July in addition to the sponsoring of our Stampede Breakfast by Calgary Comfort by Design.

We did finish the year with a surplus of roughly \$10,000 and a bank balance of \$63,000. Our income for the year was a little over budget again because of estate gifts. We are thankful for these gifts.

# Vision 2023

For nearly two decades churches of other ethnic backgrounds have used the building at 1212 as a gathering place for worship and a launching pad for ministry: Blessed Christian Church is a gathering of mostly mainland Chinese immigrants. GoodTree Christian Fellowship had its roots as the English ministry of Calgary Korean Baptist and has grown through second and now third-generation Asian Canadians. Greenhills Christian Fellowship is comprised of predominantly Filipino Canadians. And although CHBC has mainly been a caucasian congregation throughout its 114-year history, over the last five years people from South Africa, India, Columbia, and Hong Kong are finding themselves at home here.

Communities such as ours at 1212 - 1 Street NW can only survive when there is a unifying force which is bigger than their differences. The Apostle John saw this in the new Jerusalem...

"...the Lord God Almighty and the Lamb are its temple. The city does not need the sun or the moon to shine on it, for the glory of God gives it light, and the Lamb is its lamp. The nations will walk by its light, and the kings of the earth will bring their splendour into it....The glory and honour of the nations will be brought into it."

Revelation 21:22-26

John sees that the new Jerusalem is multi-ethnic and is unified around the Lord Almighty and the Lamb. As a church situated in a Canadian culture of growing diversity and disunity, I believe God is calling us to be an ambassador of his coming kingdom, where despite our differences, the triune God binds us all together.
