

Release of Liability and Indemnity Agreement

I understand that being around LIVESTOCK-including but not limited to: horses, cattle, goats, sheep, etc. is inherently dangerous because they are living creatures and are not predictable. In consideration for being allowed entry into and participation in activities (the Activities) associated with Salt Branch Cowboy Church, herein referred to as SBCC the undersigned hereby releases and discharges SBCC, the American Fellowship of Cowboy Churches, herein referred to as AFCC, their insurance carriers, their legal representatives, their present and formal directors, officers, employees, agents, and representatives, and the respective heirs, administrators, executors, successors, and assigns of any of the foregoing (collectively, SBCC) from any and all claims, causes of action, suits, or demands for personal injury, death or property damage, accrued or to accrue in the future, known or unknown, relating to or rising out of any neglect. gross neglect, accident, and/or intentional acts on the part of the (i) SBCC and/or the (ii) undersigned in connection with the undersigned's entry to or participation in activities.

The undersigned further agrees, on behalf of himself/herself and on behalf of any and all of his/her heirs, successors, assigns, to DEFEND, INDEMNIFY and HOLD HARMLESS SBCC from any and all claims, all costs, expenses and legal fees incurred in defending the same, made by, through or against the undersigned, or on his/her behalf, relating to or arising out of any negligent, gross negligent, accident, and/or intentional acts on the part of (i) SBCC and/or the AFCC and/or (ii) the undersigned in connection with the undersigned's entry into and participation in any activities.

The undersigned warrants that he/she has read this AGREEMENT and fully understands it to be a release of all claims, known or unknown, present or future, that he/she has or may have against SBCC or the AFCC. The signing of this AGREEMENT shall remain in full force and effect for the period of one (1) year from date of signature.

The undersigned GRANTS PERMISSION to be VIDEOED, PHOTOGRAPHED, or INTERVIEWED in connection with participation in the Activities. The undersigned understands that any such photograph or interview may be used by SBCC for television, film, video, visual, graphic or printed media. The undersigned agrees to RELEASE and INDEMNIFY SBCC with respect to any claims related to the usage of such photographs or interviews by SBCC or the AFCC or any media.
