MOTION 25-2020: To accept the minutes of March 5, 2020 as amended and the March 23, 2020 minutes as presented. Moved by Sandra Annesley. Seconded by Million Abawana. CARRIED

 - 4.1. Contract Employees
 - All currently employed are paid via ADP and will be covered by UCC National SHOULD we be at risk of bouncing a payroll

 Recommendation is to liquidate this fund and transfer the funds to the general RBC account

MOTION 26-2020: That the Council directs the Trustees to have the investment managers liquidate the Legacy Fund account. Moved by Derek Carroll. Seconded by Bill Hanley. CARRIED

4.4. Friends of Haiti

- We are not in a position to accept or disperse funds to Friends of Haiti
- We currently have a \$9,772.87 balance of funds on the books designated for the Friends of Haiti project. As these funds are in the general bank account we cannot release any of these funds at this time.
- Dave will contact British donors and direct them to the US affiliate
- Once we have more details regarding funding for the church in general we will revisit (before end of fiscal year 2020)

5.1. Beauty & the Beast Ticket Purchasers

- Draft letter is approved for distribution

6. M&P & Financial Update

6.1. Payroll

• UCC National will cover bounced payroll IF it happens

6.2. CEBA (Canadian Emergency Business Account)

- Interest-free loan up to \$40,000; if we repay before deadline December 2022; will apply through the Bank
- If we receive these funds they will be held in a separate account and only use it as absolutely needed

MOTION 27-2020: Council to direct the Trustees to approve the application for the Canadian Emergency Business Account Ioan. Moved by Derek Carroll. Seconded by Rick Wedel. CARRIED.

6.3. Wage Subsidy

- Up to 75% subsidy up to a max of \$25,000 per employer
- To be eligible we have to be able to show that we have lost 30% of our income; will have to reapply for each month showing those losses (year over year); is only good for 3 months (at this point)

MOTION 28-2020: To direct the Trustees to apply for the wage subsidy so generously provided by Justin Trudeau. Moved by Derek Carroll. Seconded by Bill Hanley. CARRIED.

6.4. Church Emergency Response

- Supplements the federal program; needs-based; bridge revenue
- There is no process in place at this time but will have more details soon

6.5. Cash Flow

- Have asked RBC to increase Line of Credit from \$30,000 to \$50,000
- National Church will guarantee the application for this Line of Credit (have provided RBC rep with Erik Mathiesen – CFO of UCC National)

MOTION 29-2020: To direct the Trustees to approve the application to increase the Line of Credit with RBC from \$30,000 to \$50,000. Moved by Derek Carroll. Seconded by Judy McKearney. CARRIED.

- Good Food Box program is still functioning; will need volunteers to delivery boxes on April 22nd – stay tuned for further details closer to that date
- Grocery/Pharmacy pickups: would like to coordinate this form of outreach with the congregation

- Leslie currently has 2 helpers assisting with call-outs for shut-ins
- Will investigate resurrecting something like the 'Pastoral Care Zone' that used to be in effect at Southwood. Rick has volunteered to assist with calls if needed.

7.4. Caring Ministries

 Providing DVD copies of the services to 3 individuals who have requested, as well as 6-7 others who have requested a paper-copy of the service

7.5. Southwood Church Women

• World Day of Prayer was held on March 6th, 90 people, 9 churches, raised about \$1300 for the Women's Inter-Church Council of Canada

7.6. Children's & Family Ministry

- Providing "ZOOM TO CHURCH" on Sunday's after the Live Stream service is complete; Student Leaders "breakout" with their kids for deeper interaction – had more kids the 2nd week
- Family Challenge each week (find an object, fort, this week wear RED for Palm Sunday and make their own palms)
- Building more interaction on the parent page on Facebook
- Individual contacts being made with families

7.7. Youth & Young Adult Ministry

- Micro-engagements throughout the week (Instagram live)
- 2 Macro-engagements on Wednesday and Friday nights playing games on Wednesdays and modified teaching on Fridays
- Also connecting on the phone
- Setting up another Zoom connection point for the Young Adult ministry

7.8. Worship Notes

- Riley is running all of the tech for the Live Stream and is also running "Fellowship Hall" meeting time after service on Sundays
- 2 Live Streams have been done and very well received; the second has 96 concurrent people watching on YouTube and 249 view since, 40 concurrent views on Facebook and 246 views since
- Hit over 100 subscribers on YouTube and now have a dedicated URL, which makes it easier to share our information
- Sam thanks the Staff for their flexibility and willingness to dive into this format
- Virtual Communion
 - Sam has expressed discomfort with offering virtual communion; "we
 ought not to treat the sacrament as something to which we are
 entitled"; will explain this on the Live Stream; will host an Agape Meal
 for Maundy Thursday
- Agape Meal (Love Feast)
 - Traditionally held when communion isn't available
 - Will be recreating this virtually on Maundy Thursday
 - Zoom call for the entire church: inviting people to make a meal and gather around their webcam and "feast together" at 5:30 PM followed by a simple liturgy

- Good Friday
 - · Live stream service
- Palm Sunday
 - Will hand out palms on Saturday, April 4th (drive-by palm pickup as per newsletter) – will be gloved and will disinfect between palms
