- 3. Approval of Minutes from Previous Meetings (April 12, 2021)

MOTION 15-2021: That the Council accept the minutes of April 12, 2021 as presented. Moved by Sandy Annesley. Seconded by Bill Hanley. CARRIED

#### 4. Financial Update

- Period ending 30-Apr shortfall of \$15,781, averages about \$4000 loss per month
- Have drawn down \$25,000 on LOC shortfall of \$13+K
- Need to look at ways to cut expenses
- CEBA Loan has been extended \$40,000 we haven't accessed, have also approved a \$20,000 extension which we could apply for
- Be transparent with the congregation about the financial crisis pending

- ACTION: Derek to put together blurb for congregation re: appeal for funds
- ACTION: Complete 2021 input into Quickbooks ASAP
- ACTION: Donna Transfer \$10,000 May 3, 2021 to Line of Credit and \$5,000
   Wednesday to clear Line of Credit
- ACTION: Derek to review Canada Recovery Hiring Program
- ACTION: Donna to review Rent Assistance subsidy on CRA

MOTION 16-2021: Ask RBC to increase CEBA loan by \$20,000. Moved by Derek Carroll. Seconded by Neena Chikinda. CARRIED. (This motion requires approval by the Board of Trustees before action is pursued.)

# 5. Business Arising from Past Minutes

- Student minister "Next Steps" and "FAQs" have been sent to Council and the congregation; interview to be set up
- Custodian is back, volunteer support is no longer required
  - Volunteer response was lacking which speaks to a deeper problem within the congregation regarding service to the church
- Downspout contraption has been secured and working well

## 6.1. Rental Update - new COVID Restrictions

- Lucid Martial Arts has moved outside
- Four Strings & a Bow can no longer meet in person but has asked to use rooms a couple times/week for virtual classes but cannot afford full cost

  would be for travel/accommodations. Consensus: good idea, Sam can go
  ahead and investigate further.

- Yesterday's service Sam addressed feedback received about experiencing struggles with watching the Live Stream – "COVID fatigue", we are making some small changes to the service to refresh engagement
- Pastoral Letter planned for prior to summer
- Discussing idea for launching outside services for July and August (depending on AHS guidelines) – Council is fully onboard –
- ACTION: Donna to look into any possible bylaw licenses required, as well
  as notifying Austin Nixon and providing leaflets to the closest neighbors
  to let them know what will be happening
- Costs: may need to rent some sound equipment as we don't have portable sound equipment, singers' masks, computer mount to be able to move the iMac safely; may ask for sponsors for these costs
- June 27<sup>th</sup> would do a dry-run of setup/tear down for outdoor services; there will be no Live Stream that week
