

### Southeastern Minnesota Synod Council Meeting Minutes September 23 & 24, 2022

## FRIDAY, SEPTEMBER 23, 2022

**GATHERING** 

 The synod council gathered on Friday, September 23 at 6:00pm, and joined in a meal to begin its time together.

#### SHARING OF INFORMATION

- Following dinner, council members who had attended the 2022 ELCA Churchwide Assembly in Columbus, OH shared information and highlights from their experience.
- The Office of the Bishop Staff then shared information on their work within the synod.

#### <u>SATURDAY, SEPTEMBER 24, 2022</u> GENERATIVE WORK

- The council gathered again on Saturday, September 24, 2022 at 9:00am and began with devotions, led by Vice President Lisa Dierks.
- Conflict of Interest & Confidentiality forms were reviewed and completed by all council members.

#### ORIENTATION TO SYNOD COUNCIL

- Director of Evangelical Mission (DEM) and Assistant to the Bishop Rev. Emily Carson then led the council in a time of orientation, going over the roles and responsibilities of synod staff, as well as the purpose of Synod Council and the Synod as a whole. Rev. Carson walked through the synod constitution as it relates to the work of the synod and the council's role within this work.
- Following this, the council moved into a time of reflecting on Generative Leadership, where Bishop Regina Hassanally led the discussion using lessons from her continuing education. She walked through the three main areas of the council's work as a governance board: fiduciary, strategic, and generative work.
  - Fiduciary: She reminded the council that they hold the primary financial responsibility for the synod's finances. Roster status is also a part of the council's fiduciary work and is all done in executive session. This work is highly confidential and only actions are reported out, not discussion.
  - Strategic: The council is called to think about how the actions it takes affects its current actions as well as people and actions that may happen in the future.
  - Generative: This work is related to strategic work but is also related to vision. What is the framework in which we operate?
  - She then walked through the responsibilities of a governance board, such as establishing an organizational identity, providing oversight, ensuring resources.

At 10:30 am, the council took a break before moving into the council agenda for the day.

#### **BISHOP'S COMMENTS**

- Bishop Regina Hassanally gave the following comments to the council:
  - The Bishop noted that it has been a busy fall season. She and the staff have been reinstituting things that had been done less frequently throughout the last three years due to the pandemic.
  - She lifted up that the Fall
    Theological Conference is coming up in November.
  - There will be a New to the Synod event held in October.
  - A retired rostered leaders gathering is also happening in October.
     Bishops Usgaard and Nycklemoe will be coming to speak at the event.
  - The Synod Staff recently held a staff development day, which included meeting with a representative from Lutheran Social Services, who is working to grow their presence in southeastern Minnesota.
  - Region 3 bishops and Assistants to the Bishops will be gathering in November.
  - The Office of the Bishop staff has worked to be in every congregation of the synod. Bishop Hassanally noted that they will have completed this task by the end of the calendar year.
  - The Bishop updated the council on her recent invitation and experience to the Lutheran World Federation in Geneva, Switzerland.

- She lifted up that the Conference of Bishops will be meeting soon.
- The Minnesota Council of Churches will be celebrating their 75<sup>th</sup> anniversary this year. A Celebration service will be held on October 25, and Bishop Hassanally will be "casting a vision" during the service.
- The Bishop will be attending the consecration of the new bishop in Tanzania.

#### FINANCIAL REPORTS

- Bishop Hassanally and DEM Rev. Emily Carson then updated the council on the finances of the synod. The August financials were presented and discussed.
  - Rev. Carson began by sharing some information that helped orient the council members to financial documents.
  - She reminded the council of how spending plans are approved, that they are always approved a year before they are in effect (i.e., the current 2022-2023 Spending Plan was approved at the 2021 Synod Assembly).
  - She then walked through the five channels of generosity.
  - Bishop Hassanally then went into detail on the August financials.
    - She noted that mission support is a bit behind at this time, but that more tends to come in towards the end of the year.
    - She also noted that rent has returned to the prepandemic level of \$4.000/month.

- some of the best practices that have been put into place over the past several years around the synod's finances.

## 2022 ASSEMBLY RESOLUTION DISCUSSION/ACTION

 Two items, one from the April 9, 2022 synod council meeting, and the other from 2022 Synod Assembly, were in need of action.

- The item from the 2022 SEMN Synod Assembly came from Resolution 2022-2: To be a United Church that Cares for Community. The action item is as follows: "Resolved, that the Synod Council shall organize a three-year Housing Insecure Task Force for the purpose of guiding Synod participation to address this need, by 1) Encouraging its congregations to consider becoming member congregations of the JRLC. 2) Informing member congregations of the opportunities for pursuing advocacy for the housing insecure through the JRLC, and 3) Encouraging member congregations to consider being active in finding solutions for those who are housing insecure in their own community; be it further resolved, that the Southeastern Minnesota Synod of the ELCA include in its 2025 annual report the activities of the said Task Force at the end of its three-year work, with appropriate celebration thereof"
  - Bishop Hassanally has asked Rev. Glen Munson to chair the task force, as this resolution came out of his congregation. He has agreed to do this. There will also be a liaison from the Office of the Bishop staff that will be on this task force.
- o The other item to be addressed came from the last synod council meeting on April 9, 2022. The motion in question is: "SC22.05.24 Motion to create a task force, under Bishop Hassanally, to explore the office space of the Office of the Bishop, to begin its work after the 2022 Synod Assembly and to bring an update to the 2023 Synod Assembly. Motion approved."
  - As of this meeting, no one had been asked to be on this task force. More work on creating this group will happen within the near future. They will be tasked

with exploring all options and locations that might be feasible for the synod office, as well as exploring what our needs for space are at the current time and in the future.

#### **ADJOURNMENT**

 Vice President Dierks declared the meeting adjourned at 1:01pm.

The next meeting will be held on November 12, 2022. This meeting will be held in person, with the location TBD.
