

## Southeastern Minnesota Synod Council Meeting Minutes November 12, 2022

The Southeastern Minnesota Synod Council met on November 12, 2022 via Zoom.

#### **WELCOME & DEVOTIONS**

- Vice President Lisa Dierks welcomed the council to the meeting.
- She then began the meeting with a devotion.

## REPORTS FROM STAFF, COMMITTEES, & TABLES

- Reports from the staff were discussed by the council. Highlights from the reports were:
  - Lifted up the extra work that Rev.
     Emily Carson is doing right now and asked if she needs some assistance with this at this time.
  - Noted that many churches are in the same situation right now and are struggling with staffing issues and open calls.

#### VICE PRESIDENT'S COMMENTS

- Vice President Dierks then gave the following comments to the council:
  - She noted that the call committee is beginning its work and highlighted the positions that they will be working to fill before the next Synod Assembly in May 2023.

#### **BISHOP'S COMMENTS**

- Bishop Regina Hassanally gave an update on the work and ministry of the Office of the Bishop. Some of the items lifted up were:
  - The Bishop has just returned from her first global visit, which was to Tanzania. Covid had put this off until now. She had made the visit for the consecration of the new bishop to the Central Diocese of Tanzania.
  - The annual Fall Theological Conference for Rostered Leaders will be coming up November 13-15.
  - Following the Theological Conference, she and her staff will be attending the Region 3 gathering of bishops and Assistants to the Bishop in Alexandria.
  - The Bishop will be working with the staff after Thanksgiving to recalibrate and readjust job descriptions following the recent shifts within the staff.
  - She noted that the synod Assembly planning team is beginning its work.

- The New to the Synod and Retired Rostered Leaders gatherings took place recently.
- Advent worship services will be held in December for Rostered Leaders and other church leaders.
- She mentioned that the Housing Insecurity Task Force is coming together but is in need of a few lay members.
- The Synod Office Space Task Force is also in need of a few people.

#### FINANCIAL REPORTS

- Treasurer Jeff Chestnut reviewed the September financial reports.
- Jeff noted that our investments have taken a significant loss, which shows up in our profit/loss documents.
- He lifted up a report from Rev. Carson that shows our current Mission Support pledges compared to what has been given. We are currently \$400,000 behind in those pledges. He noted that some will come in closer to the end of the year.
- Mary Veiseth made the motion to receive the September financial report.

#### 2024-2025 BUDGET DISCUSSION

- Bishop Hassanally presented an updated timeline for this year's budget approval. This allows for more discussion of changes before assembly, rather than have it all happened on the floor of the assembly.
  - The goal is to release the Proposed Spending Plan for Mission and Ministry with the pre-assembly report, rather than as an addendum later, with the Synod Council recommending the budget for approval at its February meeting.
- She then presented the first draft of the 2024-2025 Spending Plan for Mission and Ministry (or Budget).
  - She lifted up Mission Support Trends over the past years to give the council an idea of where to start with income numbers, as well as a summary of the Dedicated and Restricted accounts.

- She then walked through the 2024-2025 Budget, lifting up highlights and changes that are being proposed in this plan from previous plans.
- The council then discussed the draft document.

## MINIMUM BENEFITS & COMPENSATION GUIDELINES COMMITTEE DISCUSSION

- Rev. Barb Streed, who is the liaison to the Minimum Compensation & Benefits Guidelines Committee, requested that the council discuss an opening for a council member on this committee.
  - She sent along a message, noting that the makeup of this committee is changing, and that all positions are filled except for the council member position.
  - Rev. Kris Ferkin put his name forward to serve on this committee.
- Matt Huggenvik motioned to cease nominations.
