

Southeastern Minnesota Synod Council Meeting Minutes April 9, 2022

VICE PRESIDENT'S COMMENTS

- Vice President Dierks then presented comments to the council.
- She continues to meet monthly with all the Synod vice presidents.
- Nominations are also taking up a lot of her time in preparation for Synod Assembly.
 - She noted that a few positions are still open. All positions have nominations, but not to fill the slate at this point.
 - Youth and Young Adult members for synod council are still needed.

BISHOP'S COMMENTS

- Bishop Regina Hassanally updated the council on her work and the work of the Office of the Bishop.
- The staff recently hosted a First Call
 Theological Retreat. It was a good time and
 had a decent turnout. She noted that many
 of the First Call participants speak well of
 the work of Continuous Growth Pathways,
 which receives funds from our synod.
- She recently attended the Conference of Bishops in March, which was the first in person Conference of Bishops meeting held in a while. The emphasis was on anti-racism training.
- The synod hosted Councils As Leaders on March 20. Just under 150 people registered.
 This event was held as a hybrid option.
- She mentioned that, on April 3, she ordained Rev. Hannah Olson, who serves as a chaplain in the synod, and noted that there will likely be another 3-5 ordinations over the summer.
- She continues to take courses at Duke University in non-profit management for continuing education.
- 2022 Churchwide Assembly registration will be opening within the next week or so.

2022 SYNOD ASSEMBLY UPDATE

- Bishop Hassanally then gave an update on the upcoming Synod Assembly.
- It will be a one-day assembly in Mankato.
- She noted that the cost of renting the Civic Center in Mankato is about a third of the cost of holding the assembly in Rochester.
- The theme is "Imagine".

- At this point, registration is a bit lower than usual, which is a trend also being seen in other synods.
- Overall, planning is going well.
- She reminded the council that all synod council members are voting members, either for their council or congregation. She also reminded them of the covid requirements that are in place: proof of vaccination or negative covid test.

FINANCIAL REPORTS

- Treasurer Jeff Chestnut then updated the council on the synod's finances.
- Treasurer Chestnut noted a positive balance of \$46,000 at this point, also noting that this is just the first month of the fiscal year.
- There are a few large expense items that are not reflected in the books at this time, such as rent. We are currently being charged a reduced rate for rent, as we cannot use the space as usual due to COVID protocols at Assisi Heights. He noted that, at some point, this will change within the budget.
- Dr. Mary Veiseth made a motion to receive the financial report.

MINIMUM COMPENSATION & BENEFITS GUIDELINES

- Rev. Jay Dahlvang from the Minimum Compensation & Benefits Task Force presented the 2023 Minimum Compensation & Benefits Guidelines Document, which had been presented at the previous council meeting. Rev. Dahlvang walked through the process that went into this year's Guidelines document, as well as a brief history of the preparation of this document in the past.
- This year's document showed a \$1,125 increase, which includes a \$500 increase plus the step increase.
- Rev. Dave Knox recommended that language be added in that notes that the current increase does not meet the Cost of Living increase.
- Following discussion on the guidelines, Burton Svendsen made a motion to receive the document, and to forward Resolution 2022-01: "2023 Minimum Compensation and Benefits Guidelines", to the Committee on

- Reference and Counsel recommending its adoption by the 2022 SEMN Synod Assembly. The text of Resolution 2022-1 is as follows:
- Whereas, St. Paul writes, "and each will receive wages according to the labor of each. For we are God's servants, working together," (1 Corinthians 3); and
- Whereas, †S6.03.01.a in the Constitution for Synods states that the responsibilities of the synod include "providing for pastoral care of congregations, ministers of Word and Sacrament, and ministers of Word and Service in the synod"; and
- Whereas, the Southeastern Minnesota Synod Council has reviewed the 2023 Minimum Compensation and Benefits Guidelines; therefore be it
- Resolved, that the Southeastern Minnesota Synod of the ELCA adopt the document 2023 Minimum Compensation and Benefits Guidelines for Ministers of Word and Sacrament, Ministers of Word and Service, and non-rostered lay professionals serving in congregations in the Southeastern Minnesota Synod.

2024 SPENDING PLAN FOR MISSION & MINISTRY REVIEW

- Treasurer Chestnut and Bishop Hassanally then reviewed the 2024 Spending Plan for Mission and Ministry.
- The 2024 Spending Plan was presented, with proposals discussed around the amount in Mission Support to the Churchwide organization and what alterations to this amount opens up for mission in the synod.
 - Currently, the SEMN Synod gives 48% of mission support received to the Churchwide organization. If the 2024 budget maintains this 48%

- level, the 2024 Spending Plan shows a negative \$46,000 balance.
- Two other Spending Plan proposals were given, each lowering mission support: one to 40% and another to 43%. In the Spending Plan proposal with Mission Support set at 40%, a line item is set aside for Ministry Initiatives within the synod.
- During this discussion, the council also discussed how to present any change to the level of Mission Support to the Synod Assembly.
- Other Spending Plan changes, such as rent and the location of the synod office were discussed, to increase the margin in the Spending Plan. It was felt that this could be looked at in the future but would not affect this Spending Plan. Rev. Jenna Couch motioned to create a task force to explore office space usage for the Office of the Bishop and explore alternatives.
