

#### 12. Call Meeting to Order

#### 15. Update on Timeline & Process leading to the CBWC Assembly & Vote in June 2023

Randy Gauthier noted that there are 4 proposed motions that the CBWC has put forward to be discussed at the Assembly in June. All CBWC churches have been given the opportunity to submit amendments to the proposed motions by February 28, 2023. Following this process, attendees at the CBWC Assembly will vote on the motions reflecting the will and decision made by the CBWC church members.

TBC council members met on January 31 to discern and discuss the motions put forward by the CBWC and unanimously voted to affirm the motions as written. Following this, communication was sent to the congregation asking for any feedback/proposed amendments to the motions. One amendment was proposed as the term 'CBWC Board Members' in proposed Motion 3 is slightly ambiguous and may lead some to conclude that Motion 3 requires members of CBWC local church boards to affirm agreement with the Identity Statement.

**Moved** by Robert Litschel and seconded by Kerry Schnell that Trinity Baptist Church affirm the 4 proposed motions put forward by the CBWC to be voted on at the 2023 Assembly.

#### 17. Motion to Accept Proposed Amendment to Motion 3

**Moved** by Pat Litwin and seconded by Cal Haws that Trinity Baptist Church submit the proposed amendment to Motion 3 by adding the following statement:

#### "For greater certainty, this resolution does not apply to members of CBWC local church boards."

Some discussion occurred regarding the wording of the above statement and concerns over using the word board. It was suggested that the words board/council could be used interchangeably and that because there are so many different church structures, using the word board with a lower case b would be appropriate.

#### 18. Updates to the Membership

#### 7.1 Bylaw Review

The Bylaw Review Committee was deferred from last year. Randy Gauthier and Kurtis Streeper will be serving on the committee and the process has begun on searching for others to serve on this committee and begin the process of reviewing our current bylaws before year end.

#### 7.2 General Finances

The bank account is currently healthy at ~\$250K with ~\$110K in restricted funds.

#### 7.3 CBWC Assembly

Jeff & Ambra Gullacher will not be attending the CBWC Assembly in June as their daughter is graduating. Ashley & Kevin Winkel will be attending along with Randy Gauthier and Pat Litwin. Trinity is eligible to send up to 5 delegates based on our current membership numbers.
