Pre-Authorized Remittance

"What shall I return to the LORD for all

What is Pre-Authorized Remittance?

To accomplish the mission entrusted to us by Christ, St. Michael & All Angels' Church depends entirely on the generosity of our parishioners. Pre-authorized Remittance (PAR) allows you to give to your parish intentionally and faithfully through scheduled monthly debit from your bank account or by credit card.

On or near the 20th day of each month, your offering will be processed as you have specified. These funds are then deposited directly into the parish's account.

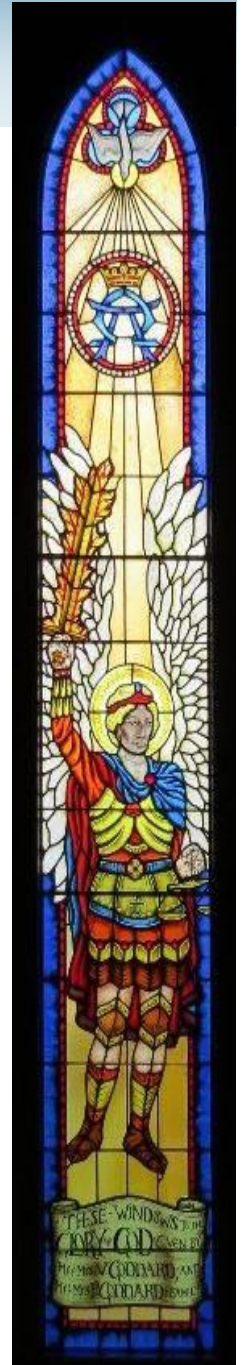
This system replaces the previous PAG as a more cost-effective process administered by the United Church of Canada for churches of many denominations across Canada.

To enroll simply fill out this form and put it in the offering plate or to the parish office.

How do I know what to Give?

To help determine the amount of one's monthly contribution based on current weekly giving - multiply your weekly offering by the 52 weeks in a year, then divide this annual contribution by 12.

Our hope is that parishioners will contribute an offering that is meaningful, sacrificial, and that honours the abundance with which the Lord has blessed each of us.



Why should I participate?

There are various benefits of participating in pre-authorized remittance, both for you and for St. Michael's Church.

Advantages for you:

- Convenience. Your offering is received automatically every month.
- Continual support of your church when you are away.
- Continual support of ministries and programs.
- Changes may be made any time with written notification.

Advantages for St. Michael's Church:

- Regular, dependable contributions to the parish
- Reduction of paperwork
- The ability to plan parish programs and activities more effectively.

Will I still get an envelopes?

Yes! While your offering will be transferred electronically, the parish will continue to provide envelopes to those who enroll in pre-authorized remittance. These envelopes can be used to:

1. Add to your pre-authorized gift for special occasions (e.g., Easter and Christmas)
2. Add to your pre-authorized gift for special outreach programs (e.g., Christmas Help Program)

When will the payment happen?

If you enroll, the authorized withdrawal from your bank account or charge to your credit card will occur on the 20th of each month. These funds will be deposited into St. Michael's bank account on the same day.

Will I receive a charitable receipt?

Yes! Receipts will be issued for all pre-authorized remittance along with any other giving.

How can I cancel payments?

You may stop your pre-authorized remittance by simply writing a letter or email with 30 days' notice to St. Michael's Church.

Is there a fee?

There is a small fee of fifty cents (\$0.50) per donation for automatic withdrawals by debit. The fee for credit cards is 2.5% of the donation. The fees are paid by the parish as a deduction from the donations for the month.
