• Synod Assembly Delegates – Pastor Jason shared the names of delegates from the congregation who will be attending the Synod Assembly in Columbia this summer.

New Business

- Property Committee Update Pastor Jason and Mary Keisler updated council on:
 - Special locks being installed to further protect the preschool

- o Repairs needed for a roof leak. Quotes are being obtained.
- Landscape Committee clean up day on May 25
- The capital asset schedule developed by the Finance Committee to forecast project timelines and estimated costs.
- A quote to remove several dying cypress trees is \$1,100. To remove all 21 trees is \$9,500. It is likely that these trees will all experience issues due to their temperament and need to be removed. The trees will be mulched and used for the playground.
 Allison Van Cleef made a motion to take all trees down now. Melissa Rawl seconded the motion. The council unanimously approved.
- IT Contract Pastor Jason updated council on an opportunity with an IT consultant to assess the technology needs as SSLC continues to grow. The initial agreement would be for five months, six hours per month, at a cost of \$2,100. After that period, the agreement would be reassessed. Eric Wessinger made a motion to move forward with the IT consultant. Sheridan Perry seconded the motion. The council unanimously approved.
- Preschool Advisory Board Recommendation Pastor Jason presented a recommendation from the Preschool Advisory Board to hire Katy Wood as a preschool teacher for a 4s classroom and provided her resume for review. Melissa Rawl seconded the motion. The council unanimously approved.
- Cemetery Columbarium Task Force Recommendation Pastor Jason and Mary Keisler presented
 the council with an overview of a columbarium presentation. The Task Force made a motion to
 spend \$8,500 on Conceptual Design Services to look at sites on church grounds, present a
 conceptual drawing and submit an estimate for the project. Cathy Mathias seconded the
 motion. The council members unanimously approved.
