Instead of taking out a temporary loan, a surplus in parish funds were used to cover project costs while pledges are fulfilled. We anticipate receiving most pledged funds by the end of 354,702.87 \$ 585,323.77 this fiscal year.

WHAT TO NOTICE ON **INCOME**

- While the School and KCDC had nearly identical income compared to the prior year, the Church experienced a significant increase due to a sizeable increase in tithing of nearly 200k!

WHAT TO NOTICE ON EXPENSES

- Salaries and benefits accounted for 60% of the overall expenses.
- Assessments to the Archdiocese and the Topeka region accounted for 12% of the overall expenses, among which is assistance to Hayden High School.
- The School and KCDC accounted for 66% of the overall expenses.
- In February 2021 a winter storm resulted in a substantially larger than normal natural gas bill. Litigation over the bill was finally completed this past year and a payment on the lower bill was made resulting in an increase in utility costs.
- School Maintenance & Repair expenses significantly increased due to needed bathroom upgrades and a new water line that was installed.
- KCDC Operational Expenses significantly increased due to necessary roof improvements and the construction of a new playground.



The largest expense each year at Most Pure Heart of Mary is for Catholic education. It is the largest Catholic school in our Archdiocese outside of Johnson County. The 2022-2023 school year was another memorable year thanks to our dedicated teachers and staff. As many Catholic schools experience decreasing enrollment around the country, our enrollment is projected to increase for the coming school year!



ENDOWMENTS

Most Pure Heart of Mary is blessed to have multiple endowments. These endowments are managed by CoreFirst Bank & Trust and the Catholic Foundation of Northeast Kansas (CFNEK), which ensures that investments adhere to Catholic moral principals. Although the principal of the endowments cannot be touched, the parish receives periodic distributions of the interest and earnings that offer financial assistance in many different ways.

Endowments are an excellent way for someone to ensure that their financial contribution continues to benefit the parish in the future. KRISCHE CHILD DEVELOPMENT CENTER

The Krische Child Development Center was established in 1996. It currently has six classes totaling 80 children ranging in age from 2 1/2 to 5 years of age. Due to the popularity of KCDC and the challenges faced by many of filling staffing positions, there is currently a waiting list to get in. Over this past year, we were able to build a new playground thanks to various grants we received.

FINANCE COUNCIL

The Finance Council is as an advisory committee to the pastor in his administration of the parish finances. The Finance Council meets periodically throughout the year to review the parish finances and offer guidance to the pastor.

The Gift of Treasure

As Christians, we are called to a new way of life—the Christian way of life—of which stewardship plays an important part (Mt 25:14-30; Mk 12:41-44; Lk 12:42-48). We recognize that everything we have is a gift from God—our time, our talent and our many treasures—and because of that we want to be good stewards of those gifts not just for our own good but for the good of our Christian family.

The word 'tithe' comes from a word meaning "to pay one-tenth." It has been a long standing tradition that Christians tithe at least ten percent of their annual income to their parish and/or other charitable causes in gratitude for the blessings they have received.
