1. Call to order

Lenore called the meeting to order at 8:00 p.m.

3. Approval of Agenda

5. Reports

5.1.Minister – J. Tenford

Jim has enjoyed having so many in attendance at the services and being able to hear everyone singing. He is the Saskatchewan liaison to the national church for refugee work. He continues to work on the wedding and baptism policies. Jim will hold a Blue Christmas service on December 21; Council agreed to move the December Council meeting if one is required.

5.2.Past President – Wayne Clarke No report

5.3.President – L. Bewcyk

South Regina United Community (SRUC) is not a legal entity. Motions that affect congregational life must be passed by both Wesley Council and Sunset Board. The following come from Sunset's meeting September 14, 2023. Wesley Council needs to consider these motions.

Motion 2023-105: Wesley United Church council proposes a Refugee Committee be struck under the South Regina United Community.

M/S Glenn Schmuland/Catherine Maloney – carried.

Motion 2023-106: Wesley United Church Council proposes sharing the cost of moving property related to amalgamation with Sunset United Church.

M/S Linda Gunningham/Glenn Schmuland – carried.

In the amalgamation process the resources of both communities are combined for the benefit of everyone who will be worshiping together in the future. An interest has been expressed in moving the following to 177 Sunset Drive, SRUC's new home.

- Exchange Wesley chairs for Sunset's chairs. This will provide comfortable seating at our new home but still leave adequate seating for any rental events at Wesley.
- Upright piano
- Possibly the grand piano
- All the vinyl tables and carrier if space can be found to store them safely.
- Shed with garage door
- Tablecloth cupboard in the kitchen lounge (this is extremely heavy and will need to be moved by movers when the piano goes.)
- Two plastic kitchen carts
- Office guest chairs and desk chair from the minister's office
- Three hymn book rollie carts
- More Voices

Lumsden Beach Camp has expressed interest in some small kitchen and housekeeping items.

Lenore will make an announcement at the October 22nd decommissioning service for Wesley congregation to let us know what items they want to bring with us to Sunset.

Keira will look into what should be moved with regards to the sound system.

After our meeting with the realtor September 15, 2023, this transfer of goods is on hold as some purchasers might want to buy a building with contents. We need to create a list of items to be excluded from the sale (ie. stained glass at the back of the auditorium.) Once the purchaser has been chosen and what they want clarified, the list above will be revisited.

50 Wesley chairs and some office furniture will be moved to the Sunset building in the near future.

The dispersal committee will be meeting to put together a recommendation of what we want to do with the proceeds from the sale of the property. There will be an announcement on Sunday. LBC requests that Wesley consider the LBC dining hall as a financial priority.

5.4.Treasurer – J. Chernick

Our deficit is lower than forecasted as reflected in the financial statements.

5.5. Finance & Investments – G. Schmuland

Givings have remained strong and staffing has been reduced. We will not be making a budget at this time; Jim and Glenn will bring any concerns to Council.

Motion 2023-107: To accept the financial statements as circulated M/S Jim Chernick/Darwin Roske — carried.

5.6. Property & Service – D. Roske

Parking lot is repainted. Rentals are steady.

The bid form and marketing brochure for the sale of church property has been finalized and a sign is on the church lawn. Bidding deadline is November 7 and the closing date of December 20 is flexible. Council will meet November 23 to decide on the bids.

Garage Sale October 27 and 28 with proceeds going to Wesley general revenue. Jacque will work additional hours that week.

5.7.Stewardship – L. Gunningham

Linda will speak on stewardship during the announcements, but will not be sending time and talent forms this fall.

5.8. Revenue – K. Stoddart

June is covering for Karen while she is away. No report.

5.9.Trustees – C Maloney

Catherine will set a meeting date for the trustees shortly after the November 23 special Council meeting. Trustees will need Council's recommendation of where they would like the proceeds from the sale of church property to go. Jim Tenford will talk to Regional Council about increasing our percentage to LBC.

5.11. JAT – L. Bewcyk

JAT met yesterday. A grief workshop is in progress.

The amalgamating groups have the first choice for surplus items. Once the Wesley building sells and the contents are no longer required for rentals, and we have chosen what we will jointly use, the United Church Policy states surplus items must be offered free of charge to other United Churches in the region. If there is no interest, they may be sold or donated to another interested group.
