The desire of the staff and officers of the church is to use this tool to provide accountability to those who support our ministries.



Message from the Ministers

".... Then their eyes were opened, and they recognized Jesus — and in that moment, he disappeared from their sight. They asked each other, 'Were not our hearts burning within us as we walked and talked with him along the road?'"

-Luke 24: 31-32

It is an odd and disorienting experience, to compose a report that will be distributed six months after the time of writing. When you read this, our pastoral relationship will have already been concluded for some time. I can only imagine what might be emerging in its stead!

Nevertheless, for eight months of 2022, we journeyed side-by-side: through news of war in Ukraine; through difficult deaths and illnesses in our own families and communities of faith; through celebrations like Pride Festival in Okotoks and a UCV backyard potluck picnic in June; through an intense, ten-week Bible Study titled *Exodus, Jesus, and Us*; through sermon series such as *And a Little Child Shall [Read] Them, Where Do We Go from Here?* and *Freeing Jesus*; through COVIDwaves and quarantines; through a variety of Holy Week services; through joyful Youth Group events; and through the process of my resignation and planning for next steps.

In the midst of these major occasions, there were all the "smaller" happenings too: short encounters in the hallways, pastoral conversations in the office, informal coffee chats... filled with our personal stories of the past, opinions of the present, and feelings of the future.

For *all of that*, I am so grateful. It was an incredible privilege to accompany each other through all of the extraordinary milestones *and* every-day moments of ministry together.

In such a way, we echo and embody how the Holy accompanies each of us: not just in the "mountain-top" experiences, when we are dazzled by the awe-filled presence of the divine, nor only in the "valley" times, assured, as we are, that the sacred Shepherd walks with us, but also in all the *winding roads* that take us back-and-forth between the two extremes. It is in those winding roads—those short encounters, pastoral conversations, and informal chats—that, even if we do not recognize it at the time, "our hearts burn deep within us" (Luke 24:32) as well.

Looking back over the past eight months, I can now see many moments when *my* heart was burning deep within *me*: burning with the presence of the risen Christ, filled with the warmth of Holy light. I take all these glowing embers with me, as I move into a new pastoral relationship—

and I hope that *you, too*, can carry similar life-giving glimpses of Christ into *your future*, with whatever, and whomever, it might bring.

Mission Possible

Mission Possible Baseball Camp July 2022 It had been 3 years since a mission possible team had travelled to the Dominican Republic to work in the barrio of Maria Auxiliadora due to the Covid-19 pandemic. However in July a small team (Gary Dzurka, John Dzurka and Curtis Carlson) made the journey to host an eight day baseball camp for 75 children.

Through several generous donations they were able to bring down hundreds of pairs of baseball shoes, gloves, bats, baseballs, helmets and new uniforms for the camp and to help support the new baseball program at the TEARS school. Prior to the camp there was no organized program for the girls in the community. However, a math teacher from the TEARS high school volunteered to take on teaching a group of 18 interested girls and has continued the program after the camp ended.

There are now close to 100 children in the community baseball program and plans are in place for a second baseball camp in July of 2023. This year Reverend Julia and Olivia Herbst will be joining Gary, John and Curtis with hopes to expand the number of children that can attend the camp.

The Healing Pathway ministry of OUC as well as many others continued to be on a roller coaster hoping for return in person and practice.



Partnership Between Diamond Valley (formerly Turner Valley)

Three-Community Partnership

On August 1st, 2021 a new partnership was formed between Okotoks United Church, St. Andrew's United Church (De Winton) and United Church in the Valley (Diamond Valley). All Communities of Faith signed a three-year Memorandum of Understanding that would take the partnership to June 30th, 2024. The partnership meant that resources, including ministers, and programs would be shared among the faith communities. Ministers would alternate leading worship within the communities and would share in offering programs (such as youth group, bible study, justice work, etc.)

In spring of 2022, Rev. Matthew Heesing (the minister called to United Church in the Valley) indicated that due to personal reasons, would be asking for a change in call. That change took place as of September 2022.

A short-term Executive Team consisting of the Chairpersons and M & P Chairs of each Community of Faith along with Rev. Julia Kimmett was convened to look at providing direction and continuity for all three congregations. The Team met regularly to coordinate worship and to discuss areas that needed to be considered for the future of the partnership. Information was disseminated to each Community of Faith on a regular basis and feedback was solicited.

Each Community of Faith was tasked with creating Living Faith Stories that will be posted on ChurchHub. Looking to the future, Diamond Valley Pastoral Charge will be creating a job description in preparation for issuing a Call and the work continues as we look at how we can better serve our communities through each congregation.

Ministry and Personnel

The role of the Ministry and Personnel Committee (M&P) is to provide support and assessment for all staff and contractors of Okotoks De Winton PC, aiming to maintain positive working conditions and relationships for the team in their various capacities within the church congregational life. As I reflect on 2022 I am humbled and awed by the passion and dedication of our amazing team of staff, contractors and volunteers. The passion and dedication of each person combine to make our two congregations vibrant and caring communities.

2022 in review:

Committee members were Sally Salter, Jack Parsons, Stewart Thomas and Wayne Stordahl. At year-end we had 2 permanent staff members & 7 contracts for the two churches combined.

April

Gail Lafond was contracted as the Congregational Care Liaison for Okotoks United Church.

May

Rev. Matthew Heesing requested a change in pastoral relations from United Church in the Valley effective August 24, 2022. This significantly impacted the Three Church Partnership and the related staffing.

June

A team from all three congregations began meeting to plan the staffing of the Three Church Partnership for the period August 1, 2022 through June 30, 2023. This included Julia returning to full-time ministry for that period and infilling the worship calendar for all three congregations with pulpit supply. Diane Willis announced her plans to retire August 31, 2022

August

Lorna Schiefner was hired as our new Office and Facilities Administrator effective August 15, 2022.

October

Gail Lafond resigned from the Congregational Care Liaison contract.

We formally said good-bye to Diane Willis after 5 years as our Office and Facilities Administrator.

General

We continue to support staff and contractors via face-to-face meetings, phone calls and emails. Provided support and assistance to the Boards in their discussion of the 3 Church Partnership in light of Matthew's departure.

Performance Reviews were completed for both Matthew and Julia and an Exit Interview was conducted with Matthew.

There are too many people to thank individually, so on behalf of the M & P Committee and the congregations of Okotoks De Winton Pastoral Charge let me extend blessings and heartfelt thanks to each employee, contractor and volunteer for your generosity of time and talent. Also my personal thanks to the members of the M&P Committee for their support and wisdom.

OUC Living Faith Story

Okotoks United Church Living Faith Story

Okotoks - De Winton Pastoral Charge is located approximately 20 minutes south of Calgary, Alberta. It is comprised of two congregations. Okotoks United Church is located in Okotoks, a town of approximately 30,000 people. St. Andrew's United Church is located in the hamlet of De Winton within Foothills County.

Okotoks United Church

We see ourselves as a living story of God's call to be the church. Within that story we have identified outreach, faith and community as being particularly important to us as a community of faith.

- <u>Outreach</u> which we describe as making a difference, helping others, following in the way of Jesus. Changing lives gives meaning and pride to the community.
- <u>Faith</u> makes us distinct from other community groups, it is our foundation, it is the reason we do what we do.
- <u>Community</u> is both who we are and who we connect with. We see ourselves as a progressive faith community, with a focus on social justice and outreach.

History

Our presence in Okotoks dates back to the 1880's through both the Methodist and Presbyterian churches. On June 24, 1917 the Methodist and Presbyterian churches joined to become The United Church of Okotoks, a full 8 years before The United Church of Canada was created. The resulting United Church of Okotoks met in the Methodist building which had been built in 1906. We worshiped in the beautiful brick church on the corner of Elma Steet and Centre Avenue for nearly a century.

In 2002, with proceeds from the sale of the church building and a financial commitment from its members, the congregation purchased the Ginger Tea House property, turning it into a centre for mid-week activities and outreach programs. An addition with a sanctuary and chapel was completed in 2011. The sanctuary was designed to be a multi-purpose facility, acting as both a space for worship and a space for performing arts groups in the community to hold events. The sound system was updated in 2022.

There are two themes that run through these momentous decisions: working together to support our community and being physically located in the heart of the community so that we are both visible and available. These themes continue today.

Structure

Okotoks United Church uses a Governing Board and Board of Trustees structure. We employ an Office and Facilities Administrator to oversee the building and provide support to the minister, boards and volunteers. We also have a contract Bookkeeper.

OUC Living Faith Story (cont'd)

Okotoks United Church has 147 active households under pastoral care. Like most churches attendance has declined in recent years. Prior to 2019, Sunday attendance was in the low 100's. In 2019 and the pre-Covid months of 2020 attendance was in the mid-80s. Our average attendance today is in the mid-50s. The congregation is predominantly over 60 years of age but we do have some younger families.

At Okotoks United Church, we strive to be good stewards of our resources. We maintain several separate Funds that give us a snapshot at any time of where we are financially. We know that money and our budget are indicators of what we do and how we do it. Money is simply a tool to help us do what we want to do: build a world where all are safe, loved and supported no matter their age, race, gender identity, sexual orientation or even beliefs. If God is a God of love, as we believe, all are welcome and deserve to be cared for.

Outreach

Community outreach and social justice have always been at the core of who we are, both locally and internationally.

Locally we have maintained a physical presence in the heart of Okotoks, we are visible and available. To meet many of those local needs we have a well-endowed Benevolent Fund. Our close working relationship with the Okotoks Family Resource Centre allows us to provide support to families in need across the Foothills region. Other examples of our local outreach are our support of the local PRIDE committee in establishing a local PRIDE festival, our annual Jacket Racket which provides warm clothing to the community, the School Lunch program which provides nutritious meals through the school system, our support for Recovery Groups who meet in our space and support for affordable housing initiatives.

Our building is used by a variety of groups from Okotoks. Rooms are used by groups to hold meetings, hold a variety of classes and host gatherings on local issues. Our commercial kitchen, which meets Alberta Health regulations, is well-used for food preparation.

We have a history of overseas support and mission education trips starting with a trip to Guatemala in 2006, Africa in 2008 and in 2012 we began a long term relationship with T.E.A.R.S. (https://www.tearsdr.org) in the Dominican Republic and Partners in Deed (www.partnersindeed.com) of Calgary. Over the years we have sent 8 teams to serve the community of Maria Auxiliadora in the city of La Vega. These teams support community development projects in the areas of education and health care. We have worked alongside in-country volunteers to paint, built walls, move rocks and dirt, plant trees, serve meals, coach baseball and worship with the local community. Ten years into the relationship we have seen the school grow from a few classrooms to providing education from preschool through high school. Medical and dental clinics have been established as well as a new soccer field that supports a soccer program for the whole community and a summer baseball camp.

In partnership with St. Andrew's United Church and Diamond Valley Pastoral Charge we have an active social justice group looking at issues that impact our local community and how we can make a difference. The current focus is affordable housing.

OUC Living Faith Story (cont'd)

The Chinook Winds Region maintains their administrative offices in our building. The Region maintains two offices on the 2nd floor and hosts regular meetings of its committees and groups in our building.

Faith

Our worship goal is to provide relevant, thought-provoking, meaningful messages. Sunday worship takes a mostly traditional format with scripture, sermon, prayer, and hymns from VU and MV. We do have a choir. We also support other non-traditional worship styles including, but not limited to, Easter Sunrise Service at the Okotoks Erratic, Maundy Thursday services, a Blessing of the Animals service, and table groups with communion.

Midweek Worship started at Okotoks United in September of 2021 as a way to provide a short, simple, contemplative worship service during the week. This service is an opportunity for individuals to "come and find the quiet centre," "catch their breath and pause," and "be reminded of God's presence." Up to this point, these services have been in the style of Taizé Prayer and leadership is shared amongst the attendees.

For us, faith formation also takes non-worship forms. We have a weekly bible study and we sometimes hold special events or workshops, such as a workshop on aging. Traditionally our bible study group chooses two themes or topics for the year, one for the fall and one for the winter. In some years, a third theme may be chosen to highlight a specific part of the liturgical calendar, e.g. Advent or Lent. While the leadership often comes from our minister, the members of the bible study take an active role in the weekly discussions.

We have a small Sunday school which we are working at revitalizing. Our youth group is held in conjunction with St. Andrew's United Church and Diamond Valley Pastoral Charge. The youth meet monthly sharing a mix of play time and growth time.

Community

We are an open, compassionate and caring faith community. We encourage each other with unconditional, non-judgemental love as we strive to meet each other's needs. Our goal for congregational care is every person cared for. Reaching out, supporting, encouraging and compassionately caring for one another is part of being a faith community. Sometimes, regardless of age or life stage, we all need help and support to get through life's challenges. And so, we serve one another through kindness, humility, patience and gentleness – always aware of God's great love.

Current congregational care is done through a network of activities, including but not limited to member call outs, volunteer visitation (phone and in-person), prayer shawls, prayer team, card ministry, and Healing Pathway ministry. The minister provides urgent congregational care as needed.

Small groups and informal gatherings are another way we look after ourselves with activities like book club, soup and sandwich luncheons, coffee hour, the annual turkey supper, and the Harmony Group. Our book club chooses a wide range of books to read each year with topics ranging from faith, to social justice, to mystery, to biography. The Harmony Group functions much like a UCW, raising funds and sharing fellowship in the kitchen and around the table.

Outreach and Justice

Applying our faith to such issues, we agree that our tradition has a long-standing practice of caring for those who struggle to get a



strong footing in our society. Looking at various aspects of many subjects related to justice, we debated just how to do justice and how it is different from charity. The food was good and the conversations lively. Fall 2022 saw us settling on Affordable Housing as our primary focus for the year. In November Lauren Ingalls from Westwinds Community Housing joined us to educate us about what affordable housing looks like in Okotoks and the surrounding area. We will continue to ponder

Chinook Winds Regional Council

In The United Church of Canada a regional council is a grouping of communities of faith within a defined area. Laypeople and ministers meet to oversee the work of the church within each region. There are 16 regional councils in The United Church of Canada.

Okotoks De Winton Pastoral Charge is a member of Chinook Winds Regional Council. The role of the Chinook Winds Regional Council is to encourage and connect communities of faith of The United Church of Canada in Central and Southern Alberta. Chinook Winds Region extends from south of Highway 13 in Alberta to the Canada-United States border.

The Regional Council staff work diligently to keep our communities of faith in touch in many ways, including:

- monthly virtual 'town-hall' meetings with inspiring speakers and opportunities to gather together to share our stories.
- other events and webinars. Some to inspire, some to provide emotional support, some to teach and some to share ideas.
- a weekly newsletter to keep us up to date on happenings in the Region and the wider church.

The 4th annual Regional Council General Meeting was held in Red Deer May 5th to 8th. The theme was A Place at the Table. Rev. Janet Gear, the theme speaker, spoke about learning the languages of faith (the first language is life). She asked, "What is your faith leading you to do?" because how we live our faith is most important. She also discussed "Hope" – look around and see God's blessing at work. How the church lives expresses what it believes just like how individuals live expresses what they believe. Her final message was "differences do not divide, our judgement of others creates division". We also conducted the business of the Region, including a motion that the Chinook Winds Region continue the process of becoming an Affirming Regional Council. This process is about discerning, within our region, what it means to be Public, Intentional and Explicit in our declaration of solidarity with the 2S LGBTQAIP+ community and our Affirmation that all people will be included in our Regional ministries, and in all aspects of the Region's life and leadership without limitations based on identity, expression or orientation.

Our United Church creed states 'We are not alone, we live in God's world.' Being part of the Chinook Winds Region is a tangible reminder of how true this is.

(As per the UCC Manual 2022-B.7.3.2: Term of Office - the congregation or pastoral charge is responsible for setting the term of office for the elected members of the governing body.) The Board

would like to change bylaw 1.2.2 to allow for more than two terms for

Board members. People who are on the Board love to serve the church this way and there doesn't

seem to be any reason to stop them from doing so after two three-year terms. They will still have to

be re-elected every three years and, of course, step down at any time they choose.

i. Current:

Term of Office

A Board member (including the Chair) shall be elected for a three-year term. A A Board member shall serve no longer than two consecutive terms in any capacity and then must vacate the Board for at least one year.

ii. Proposed

Term of Office

A Board member (including the Chair) shall be elected for a three-year term. A Board member may serve unlimited consecutive three-year terms.

There was some discussion regarding the value of Board members serving limited terms vs. unlimited terms and leaving when they felt ready.

Moved by Diane McNeill, seconded by Ellen Kneiss, that the Okotoks bylaw 1.2.2 be amended to say "Term of Office: A Board member (including the Chair) shall be elected for a three-year term. A Board member may serve unlimited consecutive three-year terms." Carried with one abstention.


