- -saint benedicts table is currently working on a parish profile and then they will post the position
- Rev. Murray has retired from St. Stephen & St. Bede and they have sold their building. The congregation is not disbanding but will now be worshipping out of St. Mary, Charleswood.
- -The Ven. Dave Labdon will be retiring from St. Aidan's as of December 31st 2023, Thanks were given to Dave for being a wonderful minister in our midst and great wisdom to this council.
- -We have hired a Diocesan Discipleship Developer, his name is Ryan Turnbull and he is based out of St. Margaret. He will be preaching at Eucharist at Faith Horizons and will be introduced to the community there.
- -We have a new RLNews Editor, Misha Pensato, please reach out and welcome her.
- We also have brought in Rev. James Gomez from Calcutta India. He is serving two parishes part time, Church of the Acension Stonewall and St. Paul's Middlechurch.

- -G. Russell shared that the workbook he did up on Franciscan / Indigenous Economics for the Franciscan Congress in Phoenix and it was very well received.
- -Our attempt to repatriate the west land of St. Peter Dynevor to the people of Peguis is still underway. Our lawyer is nearing completion on the MOU to have the land transferred back to the people of Peguis
