Message from Rev. Karen Hollis

The Holy Spirit was clearly at work when I was called to Comox United Church and arrived in January. This year has been nothing but an affirmation that this call is the right fit at the right time and blessed by God.

My first project was to get to know the Comox United community. I met with existing small groups, visited with people after church—thanks to M&P members,



who often handed me a cup of tea in the entry way. I built relationships with staff members, the church council, and clergy colleagues. In the spring we set up neighbourhood gatherings that were mostly hosted in people's homes. Around dining room tables and in living rooms, I heard people's stories, thoughts about our congregational values, and hopes for our church as we look to the future. My summer preaching series on our congregational values was significantly influenced by these discussions.

Early in the year I was invited to a clergy lunch with the United, Presbyterian, and Anglican ministers, where we made a high-level plan for shared services during Holy Week and the month of July when many clergy go on holiday. The Comox United contribution to Holy Week was a Maundy Thursday dinner liturgy in the hall, which I co-led with Ingrid Brown from Weird Church. The hall was packed with people and had representation from all six churches. Ingrid and I also led a small and heart-felt All Saints/Souls service on November 1st at No. 6 Mine park in Cumberland, with candles, silence, photos displayed of loved ones, names spoken aloud, and cello music.

I have also enjoyed getting to know Arran Morton, the Unitarian minister. We met several times over Zoom before we finally met in person in the fall. Arran and I did a preaching swap in October. He led our morning service, and I led their 4pm service in the hall. I was warmly welcomed into their beautiful worship practice and their community, which has strong commitment to being church together.

As an Affirming congregation, we are in an ongoing dialogue about what Affirming means for us today and how to shape this ministry. After talking with the Affirm committee – and hearing requests from congregation members for Bible — I began offering Queer Bible Study. Queer Bible Study is for everyone

and is a place where we query the text . . . we ask why did they tell it that way? What happens when we step into it? How do we clear away the baggage of misinterpretation? We studied the book of Acts in the fall and even queered the boundary between what we do and don't consider scripture by including a tangential story to Acts that was written in the 1st or 2nd century but wasn't included in the Bible.

I had the honour and privilege of walking with several families as they navigated the death and dying process with a loved one and planned services of remembrance. Each service was as unique and beautiful as the individual.

I was also invited to perform three wedding ceremonies over the summer. One was an at-home wedding — I enjoy the intimate environment of home for such an important life moment! The other two were outside, among the trees with beloved family and friends gathered. It's always a joy to walk with people in this way.

When I arrived at Comox United, I heard from the church leadership that they wanted to continue on where the visioning process left off by creating and implementing a strategic plan, make our governance structure work better for who we are now, and possibly hire some more staff. So, this year we've been working away at this project. I began leading a strategic planning process in the fall, which is continuing into 2024. We're asking questions like: How do we live into our values? What is important to do first? What is standing in our way? What is still our ministry and what is not currently ours to do? What do we need from our governance structure? This is big and important work, which we are doing with intention and generosity toward one another.

Alongside strategic planning, I invited the council to read the book, *How to Lead When You Don't know Where You're Going,* by Susan Beaumont. She teaches about how to navigate as a church community liminal seasons — the seasons in between — by leading with presence, tending the Soul of the institution, deepening group discernment, shaping institutional memory, clarifying purpose, and engaging emergence. So far, we have found the chapters thought-provoking and useful in the context of CxU.

We have enjoyed a rich worship life this year thanks to all those who work together on the various aspects of the service! We've made some tweaks and changes along the way, like inviting some lay people to be on a roster for prayers of the people so that the prayers can truly be "of the people." To increase communication about worship, I began sending an email after the service each week to those who helped to lead the service asking for feedback. I then organize the input and send it out to the relevant people. So far, we have

found it very helpful. The worship committee and I hope the changes and conversation have a net positive impact on the congregation's ability to worship together.

In December I planned various services for Advent and Christmas, beginning with a couple of Taizé services, which were held here on a regular basis back in the day. We collaborated again with the Hospice Society on the Blue Christmas service. There was some confusion as to our involvement this year after Hospice opened their new building; however, once we had clarity, we pulled together a service that was extremely well-attended and received. The staff and volunteers affirmed that Comox United is the right setting for the service and they look forward to continuing our practice of collaboration. We had one Christmas eve service this year — "Lessons and Carols" at 8pm — which was packed with people, music, candlelight, and the joy of the season.

The year flew by and here at the end of it, I am grateful and excited to be here in ministry with you all! We're just getting started! We're getting to know each other in a deeper way, learning how to work together more efficiently, getting clearer on our needs as a community, and much more. With the help of the Holy Spirit and our church community, I look forward to much more in 2024!

Message from Past Chair of Council

(The position of Chair of Council is currently vacant)

2023 was a year of hope at Comox United Church.

Rev. Karen Hollis began her ministry with us on January 8, 2023. Comox United Church entered into a covenant relationship with Karen during the worship service on March 12, 2023. As minister and congregation, we are gradually getting to know each other—our strengths, our personalities, and our dreams. We are so blessed to have Karen as our minister. This relationship seems to be a "match made in heaven"! Please read Karen's report to learn more about what has been happening from her point of view.

Wayne Hughes concluded his ministry with Comox United on January 31, 2023, and a formal farewell to Wayne happened on February 12, 2023. We are grateful for Wayne's presence with us over the previous three challenging years.

Beginning in November, our office administrator Lorna Tutte, took a 3-month leave to deal with health issues. We welcomed the energy and joyful presence of Karasima Brands who capably filled in for Lorna from November 2023 until February 2024.

One area of focus this year for Council members (and anyone else interested) is the Strategic Planning sessions facilitated by Karen. This is work is based on the Visioning Process of 2021-2022. Now we are looking at how to live into our values of Spirituality, Radical Love, Openness, and Care for the Common Good. We are looking at how to make the most of our gifts (physical and financial) and how to address our challenges. We've also been discussing our Governance structure — what is working, what needs adjusting, and how to do the work of the church by involving the right people and without burning out our volunteers. Everyone in the congregation is invited to attend and participate in these Strategic Planning sessions. Please watch the newsletter for the dates and times of the next event. More people mean more ideas, better discussion, and better results. Let's hear from you!

Another area of focus during Council meetings is discussion of the book *How to Lead When You Don't know Where You're Going* by Susan Beaumont. This book is very timely for Comox United leadership as our church navigates during this liminal (threshold) season. If you are interested in any kind of leadership at Comox United, I encourage you to read this book.

Leadership Changes:

- In February, Robin Giles, our Treasurer for over 6 years, handed over the reins to Gisèle Plouffe, a retired high school principal. Gisèle embraced the Treasurer's responsibilities and is passionate about the financial well-being of our faith community.
- After doing a great job of steering our Worship team through COVID, Joyce Wagland retired as the chair of the Worship Committee. Marni Fisher is the current chair of Worship.
- Mike Stewart is stepping down as chair of the Ministry & Personnel Committee, though he will continue on M&P.
- Bev Agur wrapped up the activities of the Becoming Team and stayed on Council as a Member-at-Large. We continue to appreciate her wisdom and perspective.
- At the end of June, I retired from the position of Council Chair. I am still active as Past Chair.
- As of September 2023, Andrew Black took on the duty of chairing the Council meetings only.

Comox United is blessed with wonderful, willing volunteers. Over the year, people in leadership roles moved on, changed positions, took a break, or returned from a break. Many more volunteers continue to do the "small jobs" around the church, from changing light bulbs to writing newsletter articles. Thank you ALL for giving your time and energy so graciously.

This year Comox United demonstrated "Care for the Common Good" in at least two ways:

- In January 2023, two heat pumps (including air conditioning) were installed for the sanctuary, and our fossil-fuel furnace was decommissioned. Thanks to Joan Gillies and the SAGE team for pushing us to reduce our greenhouse gas emissions.
- Our building continues to host the Comox Bay Care Society, its Care-A-Van, and its donation sorting hub. From their website: "Comox Bay Care Society Care-A-Van is a non-profit, community funded mobile outreach health unit, providing no fee health care and social development services directly to clients on the streets of Comox Valley."

Revenue Initiatives:

• A Venue Team was created in April to seek and welcome more outside groups to use our building. Revenue from "Facilities Usage" in 2023 increased 32% over 2022. The Venue and Property teams continue to improve the physical appearance of the church. (continued.../)

- The Matthew Mystery Project, inspired in faith by Matthew 25:14–30 and initiated by Elaine Brown, began in October 2023. Over 80 people are enthusiastically multiplying their \$20 bill in fun and creative ways. One Market Day was held on November 19th and another one is scheduled for March 17th. The project will wrap up on April 28, 2024 with a celebration.
- "Called to Be the Church", a month of education about stewardship, ran during October–November, led by Alan Brown, Beverly Sparks, and myself. The success of this campaign is detailed elsewhere in this report.

Policies:

Two new policies were approved by Council in 2023. One was the "Serving Alcohol at Events" Policy, which was endorsed by the congregation at the Annual General Meeting in February 2023. The other was the "Event Booking Cancellation" Policy. Council also adopted a Policy Template to be used for new policies. A small team has been assembled to reformat existing policies using this template, with the aim of completing this work in 2024.

Relationship with Comox Valley Unitarian Fellowship (CVUF):


As many of you know, we have been in a covenant relationship with the Comox Valley Unitarian Fellowship (CVUF) since 2010. This means sharing our building and collaborating on joint initiatives like climate action, social justice and *Our Whole Lives* sexual education program. This year CxU and CVUF held a joint picnic at Kin Beach Park complete with food, games and live music. There was a pulpit exchange in October between Karen and Aaron Morton, the CVUF minister. In December we renewed both our covenant and our lease agreement with the Comox Valley Unitarian Fellowship for another 3 years.

As you will see by reading the rest of this Annual Report the volunteers and committees of Comox United Church achieved much during 2023. Additional volunteers are always welcome. 
Yes, 2023 was a year of hope. For me, this hope sparked joy and excitement about our future. Together may we live into being the open, loving, spiritual community we know is possible.

Reports from Church Council Committees & Groups

Becoming Team/Visioning

The Becoming Team was formed in 2016 with the mandate to look at what Comox United Church could "become". Since then, the team facilitated a number of small groups within the congregation and partnered with Comox Valley Senior Peer Support Society to provide Creative Caregivers workshops.

The team added two members in 2021 and, as the Visioning Team, spearheaded the visioning process in 2021 – 2022 under the leadership of Rev. Debra Bowman.

Visioning and strategic planning are now being overseen by the Church Council and, with the approval of Council, the Becoming Team was disbanded in October 2023. Funds that remained of a ProVision grant for the Creative Caregivers program will be administered by the Pastoral Care Committee.

Faith Exploration

(formerly Congregational Education)

During 2023 the Congregational Education group changed its name to Faith Exploration. Our activities during the year continued to provide several book studies and opportunity to explore the faith of Christianity and other spiritual traditions. Spirituality and Indigenous History were explored jointly with the Unitarian Fellowship during the year through in-person sessions and Zoom.

The Faith Exploration group wishes to thank those who developed and delivered the various programmes and book studies including Robert McDonald, Howard Robertson, Margie van Binsbergen, and Dayna Andrews. The church's new minister, Rev. Karen Hollis, is now the group's staff liaison. She has provided both excellent leadership and active faith exploration during services. The library in the fellowship hall continues to be a resource for faith exploration. Our group's work is hampered, however, by a paucity of committee members which severely limits the development and delivery of new programmes.

Below are some details of our activities during 2023.

Adult Activities

- Bible Study: Rev. Karen is now offering a Bible study ministry in 6-week sessions spaced out over the year. Each round of sessions focuses on a particular topic or theme. In 2023, she held a 6-week session in October and plans to continue this ministry in 2024.
- Dialogue Group: This group met three times in March and April to explore the topic of "Expanding Spirituality." Average attendance was 13-16 people. All were engaged with the discussion and appreciated the opportunity to talk about experiences and not just concepts.
- The Gospel of Thomas study group: This group took a hiatus for the first half of the year but then resumed in September. They tackled the challenging book by Jack Miles entitled *God: A Biography*. They plan to continue to meet in 2024 with a new book. The group meets every other Monday and is attended by 13 people via Zoom.
 - Indigenous Canada: Our church co-sponsored with the Comox Unitarian Fellowship a new program providing education and group discussions about the Indigenous peoples. Wayne Wilson served as the representative for our church. The program was a free online course offered by the University of Alberta. It consisted of 12 modules, running from January–April.

Youth and Children Activities

- Sunday service youth and children: The pre-COVID procedures for youth and children coverage continued to be provided for when any youth or children attended services.
- Annual Summer Day Camp hosted by St. George's United Church: No CUC youth attended in 2023. However, we continued to support this activity as our commitment to providing United Church youth opportunities in the valley. Each year we donate \$250.
- Comox Valley Youth (CVY): This group started in Oct. 2020 and is a collaborative effort by St. George's United Church and St. Peter's Anglican Church. As with the Summer Day Camp, we are limited to supporting this program financially. That support began in 2023 with a \$200 donation.
- OWL: Rev. Karen provided the following brief description of OWL: "OWL stands for *Our Whole Lives*, sexuality and our faith. It is a comprehensive sex education program for all ages, created by the Unitarian Universalists and United Church of Christ (sister denomination to the United Church of Canada) in the States." The Unitarians have asked our church to sponsor the program by providing church space. Teachers trained in the programme for K-1 level would be the leaders. A 2024 spring start-up is projected. The programme falls under the umbrella of the Faith Exploration group. There has been some discussion of the programme being extended to other age groups. If so, we have expressed a concern about us sponsoring the programme for other school age levels until the school board(s) are consulted to prevent any conflict or overlap with possible similar programmes offered by the schools.

Church library

 Our library continued to operate as usual. During the year's annual cleanout, many dated and underused books were removed. They were offered to the congregation for free in the church hall after two church services. The remaining books were given to the Rotary Club for its book sale.

Broadview Magazine

- The church continued to offer the congregation a group subscription.
- As in past years, announcements were made in the church newsletter to renew or start a subscription to the magazine.

Congregational Life

We started 2023 off with much excitement, joy, anticipation, and cake with the arrival of Rev. Karen Hollis in early January. It has been such a delight getting to know Karen. We appreciate her gentle leadership approach, warmth, intelligence, and deep faith.

Comox United Church is a vibrant hub of activity that serves both our surrounding community and our own congregation. Sunday morning services and coffee hour after church are the cornerstones of Congregational Life, but there is so much going on during the week and calendar year that both challenges us and helps create a supportive faith community.

Activities included: Bible studies, potlucks, meals with combined congregations, Soup & Bun luncheons, UCW lunches. Knitting and walking groups, Men's Shed, and monthly Men's Breakfasts are just some of the activities and events that have been ongoing in 2023. Within the Comox community, congregants enjoy weekly Coffee & Conversation at the Comox Golf Course, and Super Singles sometimes meet at local parks. We participated in the first Courtenay Pride Parade (thanks to Merrilee for creating a beautiful CUC banner), as well as Coldest Night of the Year which supports and brings awareness and understanding to the homeless population in the valley.

We had a variety of entertainment events throughout the year including Gloria Herauf's annual *Have a Heart* musical. Over the years, the musicals have raised much needed funds for our church and many other important charities and organizations throughout the Valley. Thank you to Gloria and all those who are involved on stage and in behind! We enjoyed a Talent Show, a Christmas Singalong, and the Charles Dickens reading as part of the Matthew Mystery Project (see *Fundraising*).

Looking ahead — we have booked Camp Homewood on Quadra Island for the fall. Please save the first weekend of October (4th–6th) and come join us as it will be a time of relaxation and community building in a beautiful and peaceful setting. We will plan for a Hanging of the Greens potluck and service at the beginning of Advent, it was missed this past year.

I offer my grateful thanks and appreciation to all the volunteers who give of their time and energy to the groups who compile Congregation Life. To Elaine and Ruth who took care of the Congregational Life table for many years, to the dedicated volunteers who prepare coffee and tea for us to enjoy after the service each week. Thanks to those who made soup, brought buns, helped set and clean up after events.....so many thank yous! Knitting Group

The knitting group meets weekly throughout the year. During the summer months we met outdoors and the rest of the time we met at the church. The group has about 12 members.

Members of the group knitted and crocheted a variety of projects — slippers for the Comox Valley Transition House, items for the church bazaar, prayer shawls and socks as well as projects of their own. The socks are given to the "Sock it to 'Em" program — a project run by a Comox Valley woman who sells handmade socks and uses the proceeds to buy heavy duty socks for the disadvantaged in our community. Some of the proceeds from the bazaar were used to purchase yarn for prayer shawls. Additionally, a donation was made to the music ministry program of Comox United Church which covered the cost of additional music stands and folders for music for the choir.

Not only do the members enjoy knitting and crocheting together but they also provide companionship and support for those living alone.

New members are always welcome to join us, whether they are wanting to learn to knit or crochet, experienced, or somewhere in between. Come for community and friendship — lively discussion guaranteed!

Men's Shed

Men's Sheds or Community Sheds are non-profit local organizations that provide a space for a making of things and for social interaction. The movement originated in Australia around the 1980's as a way to improve the health and well-being of older men. There are over 900 Men's Sheds located across Australia, with thousands of active members. Men's Sheds can be found also in the United Kingdom, Ireland, the United States, Canada, Finland, Estonia, New Zealand and Greece. On Vancouver Island there are Men's Sheds in Victoria, Sooke, Sidney, Salt Spring Island, Bowen Island, Parksville, Nanaimo and Comox. In the province of BC there are 49 registered Men's Sheds.

An important slogan for Men's Sheds is "Shoulder to Shoulder", shortened from the original expression, "...men don't talk face to face, they talk shoulder to shoulder..."

The first Men's Shed was opened in Tongala, Australia on July 26, 1998.

(Men's Shed continued...)

Sheds were inspired by backyard sheds, where a man would go and carry out tasks such as restoring furniture or repairing lawn mowers. Men's Sheds can be seen also as an extension of the original nineteenth-century idea of working men's clubs in the United Kingdom and Australia that provided recreation and education for working class men and their families.

Our Story

About four years ago, a handful of men from Comox United Church and the Comox Valley renovated an abandoned room in the basement of the Comox United Church building. Unwanted items were taken to the landfill. An old cupboard system was removed and replaced with a cupboard system sourced by one of our men. We painted the walls. A workbench was constructed by one of the men. Tools and books found their way into the Shed. A refrigerator was donated by a church family. A used sofa, chairs and a coffee table found a home in the shed. The Covid-19 pandemic slowed us down, but we continued to meet outside in parks. When the pandemic disappeared, we moved back into the Shed again.

What does a week in the life of the Comox Valley Shed look like? On Fridays from 10–12 noon, we enjoy coffee, cookies and conversation. There is usually a check-in time where we introduce ourselves and share a bit of our story. Our attendance has varied from 12 – 20 men: some are from Comox United Church or the Comox Valley Unitarian Church, but a good number come from the greater community. When we have extra participants, we can spill over into an adjoining room. There is a certain richness and meaning in getting to know one another as we stand "shoulder to shoulder" in conversations that unite us in joy, laughter and mutual support.

On Thursdays, from 9 – 12 noon, we open the shed to men who want to make something out of wood. Currently, men have constructed two library book holders which will be put on posts and placed somewhere in the community. Used books will fill the book holders which will be available for folk who enjoy reading and who also may have some books they want to donate. The wood that we used has been from recycled materials.

We are experimenting with offering opportunities to learn to play cribbage on Sunday afternoons from 3 – 5 pm. We usually put on some coffee. You are warmly invited to come and be a part of this new activity. In addition, from time to time, we go out for dinner in a restaurant and we are planning a visit in good weather to Port Alberni to have a day trip on the MV *Frances Barkley*.

We also like to 'give back'. The ways in which we do this is to be responsible for cutting the church lawn and for raking leaves and keeping the parking lot tidy in the spring, summer and autumn months. Recently, we used our own funds to purchase an electric, cordless lawn mower and cordless trimmer. When spring arrives, you will see one of us out on the property, keeping the lawn looking cared for. We sometimes also carry out odd jobs around the church.

On behalf of the Shed Executive, a warm invitation is extended to all men to be a part of "The Shed". If you are looking for interesting conversations and a place to call 'home' with other men, please drop by on a Friday at 10 am in the Shed (in the church basement). We will be glad to see you!

I enjoy working and problem-solving with Gisèle. She has developed a good understanding of everyone's roles, including that of the bookkeeper, and has implemented process efficiencies that will save time and help us work better together.

Karasima, who is providing relief in the Church Office, is a bright, positive individual and has been a delight to work with. Lorna, of course, is always helpful. I also appreciate the assistance of members of the congregation to distribute tax receipts, which saves on postage.

In addition to the routine pieces of my role, this fall I was heavily involved in the Stewardship Campaign (receiving confidential responses, implementing Pre-Authorized Remittance (PAR) changes, liaising with Council members, etc.). As well, I was responsible for receipting Matthew Mystery profits, following up with individuals and the co-ordinator for clarification and ensuring adherence to Canada Revenue Agency guidelines.



The annual level of giving below includes ten occasional donors and 16 onetime donors who were not on PAR and who did not give regularly via envelopes or Interac.



In 2023, 28 envelope sets* were issued, as compared with 29 in 2022:

- one envelope holder passed away;
- two envelope holders switched to PAR;
- the church gained two new envelope holders.

Nine individuals chose Interac as their means of donating to the church. The last of the individuals who were giving via direct deposit from a bank account passed away in 2023.

Eighty-two individuals/families were on the United Church of Canada's PAR system at the end of 2023, the same number as the previous year. We lost two PAR donors due to death and three for other reasons, but we gained five new PAR donors during the year. Throughout 2023, 11 PAR donors increased their offerings by a combined total of \$265 per month. On the other hand, the monthly amount lost from the cancelled PAR/Direct Deposit deductions totalled \$680 per month.

Forty-one donors gave generously to Special Appeals in 2023. Please refer to the Treasurer's Report for totals.

The budget has some points of interest:

Investment: The Finance Committee has been reviewing our investments to make sure they align with the church values e.g. no oil or tobacco. The investments were adjusted to continue to be diversified. The committee targets 70% in medium risk and 30% in low risk.

M&P changes: Increase in the salaries of the minister, the office manager and the bookkeeper and the number of hours of the Bookkeeper.

Addition of a clerk administrator to do administrative tasks in order to relieve Minister Karen Hollis of administrative tasks to spend more time in pastoral care.

F&M Upgrade tools: the congregation is now fully active and the Accountant Sage tool free version 2016 was no more accurate. Sage 2024 will be downloaded and we will have upgrade course to get it efficient.

The income and statement 2023

After Covid, it is the resumption of activities in all spheres of the congregation. With the arrival of Minister Karen Hollis, her vision, her leadership and her youth, we have seen different forms of life rise from the ashes or take shape. The energy is palpable. In the income, we can see life in a tangible way especially with the involvement of several community members in the Mathew Mystery Project.

On the expenditure side, consequently, we see the normal increase in the cost of living. Otherwise, this income statement appears to reflect the usual expenses of the congregation. We end the year with a surplus of \$32,384.



Interesting point in Balance sheet

Assets: The church investments are under Canoe Defensive Global Balanced Fund. The new balance is \$301819.08. They included \$145,715 for bequest, ProVision and other accounts in the balance sheet. By the way, ProVision grants are awarded by the Pacific Mountain Region ProVision Fund Committee and it is possible to make requests to get new funds.

Consequently, Church has a \$156,100 for good stewardship. It was time to talk about our risk tolerance for this account, the investment objective and the time horizon. The FM committee seat to make recommendations about the investments. The funds are modified and the process is done. The funds are available if needed.

Property history:

- 1). Several years ago, we put aside many dollars to put towards eventual roof costs from one of the bequests, as we knew that our 4 separate roofs each have their own history, and are potentially costly.
- 2) In the Fall of 2019 we commissioned a "roof condition assessment" to be done to give us a road map and a plan for doing work and maintenance on the roof. I want to get back onto that road again. Of course, maintenance is way cheaper than repair!!





2024 Strategies and treasurer recommendations:

To be wise, from my point of view, we should talk more about the Pastoral Care of the congregation members. We should increase the investment in an administrator paid for his services because a treasurer is not an administrator employee working for free as a volunteer. The first chair M&P committee should be responsible of ADP file till a full time administrator will be officially in place.

Thanks

I want to thank everyone for their support, especially Heather and Claude Dalley, Midge Swedberg, Joanne Wiens, Cheryl McMahon, Karen Hollis, the board members and Ruth Giles as responsible of the counters committee. These people were present, supportive to keep me on the path of Life by their way of being and the help provided in my work is very appreciable. It has been a privilege to work as treasurer for the community. I am blessed. May God's love continue to guide me.

Fundraising

At the May 2023 Comox United Church Council meeting, Council approved a \$2000 expenditure to fund a special one-time fundraising initiative to be coordinated by congregation member Elaine Brown. This expenditure was approved in faith with only our minister Rev. Karen Hollis knowing the details of the project. Council was promised that the \$2000 would be returned to the church with additional funding added in the spring of 2024.

On October 1, 2023, the project titled *The Matthew Mystery Project* launched. Each member of the congregation was surprised by being gifted an envelope containing a \$20 bill and instructions to multiply the provided 'seed money' as much as possible before the project concluded on April 28, 2024. Inspired by scripture (Matthew 25: 14-30), Rev. Karen encouraged congregation members to use their talents to grow the \$20 to assist Comox United to fulfill its mandate of Spirituality, Openness, Care for the Common Good, and Radical Love.

Throughout the fall, congregation members enthusiastically began their individual projects including a Ukrainian dinner, an afternoon tea, and Healing Touch sessions as events. In addition, there was a Matthew Mystery Marketplace on November 19th where 28 vendors sold baking, crafts, and services in support of the project.

At the conclusion of 2023 many more projects were underway with some participants starting to turn in some of their profits from early fundraising efforts. Just over \$5000 was raised in the first three months of the sevenmenth project.

Ministry & Personnel

The Ministry & Personnel Committee is charged with the responsibility of looking after the church's staff. The work includes maintaining meaningful contact with each staff member, being a listening ear and lay counsel to the extent we are able. The job also involves dealing with many routine personnel tasks from approving leaves to discussing career plans, training needs, evaluating staff performance, and acting as a resource to congregation members in case of misunderstandings or questions regarding our staff and their work among us. All this is done with confidentiality.

In the past year we have solidified our relationships with staff, learned to deal with the church sick leave plan; have increased our knowledge of the ins and outs of the committee, our roles, and the work required. We have accomplished some staff evaluations, and another is in process.

I feel fortunate to work with a group of thoughtful, intelligent, caring, and creative folks. When I'm stumped, someone else has a good idea or solution. My thanks to the committee members for their work to date and for their willingness to continue on next year. After Marg Silman stepped down from M&P in the spring, Dale Erhart joined us as a replacement, and he has been a welcome addition.

We need a new chair. I have been M&P chair for 17 or 18 of the last 30-odd years, and I don't feel I have energy to continue that role. New leadership is needed, but I will stay on as a committee member and offer my support to a new chair. We have found 6 or 7 members is a good number; it offers a variety of viewpoints and experience, and some depth in dealing with issues and crises – usually one of us is available to step up at any given moment. I have also found that an increasing number of computer-based requirements have made it harder to do the prime work of supporting and overseeing staff & their effectiveness within the congregation.

I also want to thank Treasurer Gisèle Plouffe who has worked with us to help solidify some processes and fiscal issues we hadn't understood all that well, all while she was learning a huge new job, herself. Thanks also to our capable and engaged staff and the past members of the M&P committee who have been helpful and supportive all along.

Ministry Profile & Search (MPS)

Following the resignation of the Rev. Keltie van Binsbergen in 2021, a Ministry Profile & Search (MPS) committee was formed to assess the ministerial needs of our church, and then to find a suitable candidate to fill that need. The MPS Committee found that the work of the Visioning Team completed in 2022 was extremely useful.

In May 2022, the MPS Committee recommended to the congregation that Comox United needed a full-time minister to fill the vacancy, and this recommendation was accepted.

Property

This past year has seen lots of basic maintenance and upgrades to our building. We continue to work at sharing our space with an increasing number of groups, both within our church and within the broader community. - We also liaise with our various contractors we have contracts with a company for cleaning the building three times per week, and a contract for snow clearing, a separate one for clearing our sidewalks, and one for outside security.

As a committee we want to give a big thank-you and a shout out to the many individuals, and also to several private contractors who donate their time and talents to the maintenance of this dear building of ours.

We are also very grateful to the diligent, loving attention each of you give this building, checking doors to ensure they are locked when you leave, turning off lights and turning down thermostats, reporting to us (through admin or directly) when lights are burned out, chairs broken, water dripping, toilets not flushing or windows left open etc.

Queer Vespers: Due to a lack of volunteer leadership, Queer Vespers did not happen in 2023; there are plans for the future.

Taizé: Rev. Karen conducted two Taizé services during Advent that were attended by small groups of people.

Sanctuary:

Care: Heather Flint took over leadership of the "Church Mice" and added a few new members to this group. See their report appended to this one.

Liturgical Decorations: Barb Craig faithfully changed banners, cloths, plants, etc. for the first 8 months of the year to reflect the church seasons. She then went on an extended RV trip and Marni Fisher has been learning the meaning of colours and symbols for the seasons. A couple of altar cloths were made for the small table on the platform. We are unable to hang the long banners at the front since that is where the Power Point is projected.

Technology Committee (Tech Team)

In 2023 the Tech Team focused on sound quality and operating the live-streaming of our Sunday morning worship services. An average of 45 homes watched our worship services via the live-stream on Sunday mornings or at various times during the week. Many of our recent newcomers watched our on-line services before walking through the door.

The Tech Team also live-streamed memorial services for 5 members of our faith community. These were well received by family and friends who were unable to attend the memorials in person.

The projector and sound system in the Gathering Hall are well-used by rental groups. Additional renters have been attracted by these capabilities. The lower-level room, L1, also has a projector and screen that can be used by renters.

Our website and Facebook page continue to be important parts of our communication with the community. Thank you to Joyce Wagland and her team for their work in keeping the information current and informative.

In the spring a "Hearing Task Force" surveyed people who were experiencing sound issues during Sunday worship services. Recommendations were made and some were implemented in 2023. We plan to implement other recommendations in 2024, including a teaching session about how to use the available hearing assist devices.

In the fall, Ross and team installed a large screen monitor in the sanctuary which enables the choir to see the PowerPoint slides on Sunday morning. Thanks to Bev Sparks and Dave Talbot for arranging the donation of this screen.
