# **Church Council Committee Update**

The November checking account reconciliation showed an unencumbered operating balance of \$2,289.

This year's apportionment is \$20,712. As of December 10, we have paid \$15,841. The district fund of \$777 has been fully paid. Our balance due to meet 100% of our apportionment is \$4,871.

The end of the year 2024 looks to be another "down-to-the-wire finish" for the financial obligations of Concord UMC. We have offered the church members the "Triple Dog Dare You" Challenge (see details on this page) to help raise the money to meet 100% of our apportionment.

The church's assets include trust funds and endowments that are managed by the United Methodist Foundation of West Virginia. These accounts were valued at \$297,525.62 at the end of September.

We had been insured by Church Mutual Insurance Company for years and years. This year Church Mutual gave us notice that the insurance would be cancelled on December 10, 2024, due to several roof shingles apparently showing need of repair. Jack Fredeking worked diligently on finding us new insurance. We are now insured by the Lewis Insurance Agency in Princeton. Jack's company, Fredeking-Stafford Construction Company, Inc., has paid our first quarter installment for 2025 as a charitable donation to the church. The church is insured!

The exterior lights have been repaired and a spotlight was installed on the back porch to point toward the corner of the building for better security.

In response to the devastation of Hurricane Helene, our congregation raised \$2,200, which we contributed to the UMCOR US Disaster Response and Recovery organization.

The Trustees approved the purchase of *The Faith We Sing* Accompaniment CDs, so we are now able to use both hymnals during our service. The CDs were paid with designated funds from the Memorial Music Fund.

## The "Triple Dog Dare You" Challenge

As we approach the end of the year, we are \$4,870 shy of paying 100% of our apportionment — also known as "fair share giving." Sooo...as your pastor, I would like to challenge the congregation to pay the remainder of our obligation. Here's how we can do this.


We will call this the "Triple Dog Dare You" Challenge.

We have received \$2500 toward what's left on the apportionments. I would like to challenge each of us to give a "second mile" gift to help pay our apportionments. This will be your gift, above and beyond what you would normally give to the General Budget — we need to continue to fund the daily operation of the church.

Between now and the end of the year, for every dollar given toward the remainder due of the apportionments, it will be matched by an additional dollar, up to and including \$2500 given by the congregation. So, if you give \$50 to the challenge, the apportionment total would realize \$100. Where do you get that kind of return on your investment?


Let's all work together and show our faithfulness to Concord UMC, the Annual Conference mission and ministry, and your faithfulness to God.
