Agency Membership in the Foundation

Agency Members of the Foundation have the advantage of placing “permanent endowment funds” with the Foundation under a revocable asset administration agreement. Funds placed with the Foundation under this program are commingled with other endowment funds of the Foundation for investment purposes. Income is allocated quarterly and distributed or reinvested according to the instructions given to the Foundation by the Agency Member.

Agency Membership in the Foundation is open to any of the committees, commissions, councils, local churches, charge conferences, corporations, trusts, or other bodies which are affiliated with or which are agencies of the South Carolina Conference of the United Methodist Church. The Foundation defines endowment funds as permanent long term funds in which the principal is invested and reinvested and only the income or a percentage of the income is used.
