

Bishop Anna and Maggie Enwright, acting Regional Minister for the UCC asked me to put together a proposal for St. Columba Port Hardy, to help out from September to December 2024. Your warm embrace has been uplifting and a blessing.

I was able to provide you with a worship service in September, two in October, and one in December at an afternoon time of 2 or 3 PM. Having office space and renewed presence in Port Hardy has helped me begin to facilitate better flow and grace in reestablishing relationships throughout all of our NI communities. This helps me to enhance the sacred need of a *ministry of presence* in reconnecting with community partners, both Indigenous and non-Indigenous. I was able to provide: continued pastoral care and home communions; come back to the Morning Sanctuary which I missed dearly; visitation at Port Hardy Hospital; help out with administration and receive love and encouragement from my St. Columba family all at the same time!

I have had the pleasure to meet and get to know our minister and friend, the Reverend Bob Gilbert and look forward to learning from and working with him as we journey together on this Jesus Way.

My friends, Pehgee Aranas and her husband Dan, who attend St. Bonaventure Catholic Church, were able to join us and help out at our Morning Sanctuary program. We have since hired Pehgee as staff for the program and the Sunday Meals that are delivered to folks each week.

It has been wonderful to be back in Port Hardy with you again, beginning new and restoring old relationships. In May, I am hopefully graduating with my Master of Divinity at *Vancouver School of Theology* in the *Indigenous Studies Program*. I will continue to attend the *VST*, *ISP Summer School* in July as mentor and friend.

Indigenous Ministry Report 2024

Sanctuary: Nearly every morning the church is open from 7 AM to 9 AM or later. We provide a warm space, a listening ear, and open hearts to support anyone who comes. We serve coffee tea and juice as well as light breakfasts, such as hot or cold cereal, hard boiled eggs and fresh fruit. Many of these friends are First Nations, some homeless, some marginalized. This year we had 3500 contacts averaging 9.6per day. Included in this number were 94 new individuals.

Food Security: There are multiple branches to this ministry. Hot Sunday Lunches have been provided to approximately 50 people each week. Gwadzi Managed Alcohol Program (GMAP) is an Indigenous lead program who visit their clients daily. They pick up and deliver 36 meals on their Sunday rounds. The remaining 14 meals are distributed from our hall. The Blessing Box provides 6-8 items of mainly non-perishable food items daily to anyone who passes by. The St Columba Sanctuary in addition to warmth and compassion provides beverages and food. We have hosted the Loaves and Fishes food bank (L&F) every two weeks from 2019 to November 2024. They have now moved their "free food market" to their location on Market Street. On the opposite weeks we have continued to collect food from the L&F agency pickup and split it between the G & N Elders Center, Kwakiutl Health and ourselves. Our share goes to support the blessing box, Sunday lunches and St Columba Sanctuary.

Grants have been secured to hire Anna Marchand for 15 hour per week to support St Columba Sanctuary and the Sunday Lunch program. She has been doing an amazing job since she started early in 2023. This fall Sheila Cook recruited Pehgee Aranas as a paid part time employee. Over 6800 meals have been served at Our Sanctuary breakfast and Sunday lunch. About 3000 food and personal care items have been given out through the Blessing Box or hampers.

Accompaniment: In order to walk a good path with our First Nations brothers and sisters we try to be present in their lives and communities. Community events such and the March for Missing and Murdered Indigenous Women and Girls and the National Day for Truth and Reconciliation are important events that bring us in small steps towards healing and forgiveness. Church members and clergy participate as members of the public in these events and we raise funds to help defray the costs of the organizing committee. Our Community Partner, Cathie Wilson advises us on what we can do to help and how best we can accompany our First Nations friends. We also thank the Rev. Sheila Cook for expanding our impact in the community.

Community Garden: The garden fell into disarray with a lack of committed volunteers. We will not be renting space in the community garden this year.

Fundraising: We had fewer fund raisers this year; only the Shrove Tuesday Pancake dinner. In addition to funds raised, we fondly remember the friendships we develop when we work together.

Camp Spirit: In early August we hosted Camp Spirit summer day camp. There were 13 children registered and a crew of workers who put together a fun and positive programme of music, crafts, worship and games. Feedback from parents was positive and we look forward to a return visit in 2025.

Worship: Weekly worship continued throughout the year. Robert Fyles was licenced as a Lay Worship Leader and led services at least once a month. The Rev. Christine Muise led the majority of services up until she moved away in mid August. Pulpit supply was provided by the Rev. Elaine Julian in the spring and the Rev Brenda Riley came and led a Wild Church service in August. The Rev. Bob Gilbert and the Rev. Sheila Cook provided several services each in the fall. Special services included: Ash Wednesday, World Day of Prayer, Good Friday, Easter Sunrise and Christmas Eve

Nativity scene: The nativity scene was set up on a rainy November 30 to welcome a new liturgical year with the beginning of Advent. Six of us gathered to work indoors and out as we "Prepared the Way of the Lord".

Pacific Mountain Regional Council Report

Pacific Mountain Regional Council continues to hold annual meetings around the province each year in hybrid form. This allows communities of faith (church) representatives like myself to attend even when circumstances or travel distance is prohibitive. However, in 2024 | was not able to attend the AGM as the meeting was held just as I was arriving back in Canada after almost a month away from home. It was held in Vancouver with keynote speaker Patty Krawec who is an Anishinaabe/Ukrainian writer and speaker belonging to Lac Seul First Nation in Treaty 3 territory and residing in Niagara Falls. The usual fully packed agenda from Thursday late afternoon through Saturday evening featured multiple worship times; keynote speeches and workshops on the theme "Connecting Collaborating Cultivating"; motions received and debated; and reports from various committees. The Sunday worship (broadcast publicly, so I watched it a week later) featured 15 people being admitted or ordained, some of whom are known to our community here. Rob Shearer was admitted to the United Church (he's been our liaison for our church LeaderShift funded plant (St Columba Sanctuary). Cathy Cryder was ordained. She spent a few years working in Port Hardy (teaching at GN School; working at the Crisis Centre) and returned a few years ago as the coordinator for Camp Spirit; and Pam Evans who is PMRC First Third (folks under 30) team lead. Among the recent retirees was our own Bob Gilbert (but that didn't last long).

Pacific Mountain Region and Chinook Winds Region (southern Alberta) grieved especially for the passing of Rev. Brenda Fawkes in a tragic car accident in September. She served both regions as their vocational minister, guiding student ministers on their path to ordination. Also noted was the passing of Rev. Kris Jensen who in the past occasionally led worship for us at St. Columba as a visiting minister.

Our regional minister Rev. Gail Miller has been on medical leave since August and Rev. Maggie Enwright has been supporting the Profile and Search committee through the long process of discerning a new way of part-time paid ministry for St. Columba's Church and St. John's, Port Alice.

The next PMRC annual meeting will be held in Nanaimo at the end of May 2025, but I will be in Alberta that weekend. So even though the gathering is closer to home, I will need to attend online if I continue as your PMRC representative, though an alternate could attend in my place.

Synod Report

Our Regional Meeting was held on Saturday October 26, 2024, at St. Anne & St. Edmunds, in Parksville — our first in person meeting since COVID. At that time we elected 1 Clergy person to sit on diocesan council, a lay person to sit on that same council and a Regional lay vice-chair. There was then a presentation by the Chancellor, Isabel Weeks, and Executive Archdeacon, the Ven. Eric Partridge, discussing the work completed by Canons Committee updating all of our Canons which have been the same since the late 1800's! The complete review was to give us a full picture of what we will be voting on at Synod.

Synod was held the following weekend with Eucharist held at Christ Church Cathedral on Friday, November 1/24 and the Synod meeting on Saturday the 2nd at the Baumann Centre of St. John the Divine on Balmoral Road. There was an opening message from Bishop Anna followed by all the business of the Synod, including nominations and elections for various committee appointments, a review of the diocesan Ministry Reports, the Treasurer's report and the amendments to the Constitution, Canons and Regulations which were passed unanimously. Synod will meet again in 2026.

Bob Gilbert expressed interest in the position and we decided, on the advice of Bishop Anna and Maggie Enwright, to split the position into two ¼ time appointments. At the time of this writing, a motion to accept the final recommendation of the committee had been accepted by the council and was awaiting congregational approval on February 2, 2025.

The committee would like to thank Judy Fyles for her support in developing a financial viability review and her work in setting up payroll for Sheila and Bob.




