Dear Friend,

When I first arrived in Canada, I thought I knew what to expect: polite small talk about the weather, ice hockey references I didn't understand, and an abundance of people apologizing to one another. But what this year has proven beyond doubt is that Canadians are not just polite. Canadians are courageous, compassionate, and committed to justice.

This past year, we proved that, as Canadians, we don't just care about justice—we actively chase it down. From Parliament Hill to church pews, classrooms to conferences, we showed up. We stood up. And we spoke up. Together.

In April, we launched the Scale of Harm report where we stood alongside survivors to communicate a clear and pointed message to Canadian leaders that our country can't just be a bystander in the fight against online child sexual exploitation. We are a country where thousands of perpetrators of online child exploitation live, and we must act.

In May, I delivered the keynote address at the National Prayer Breakfast, which led to a country-wide surge of interest in our work. In the following months, we received requests for partnerships, invitations to meet with government leaders, and witnessed Christians across Canada united in prayer. Month after month, our team experienced encouraging advocacy wins, which you can read more about in this report.

We held meetings with ambassadors, made strategic recommendations for the federal budget, met with the Prime Minister's Office to discuss government action on the livestreaming of online child exploitation, and so much more. And while all that happened in Canada, you and other justice-seeking Canadians supported IJM's work around the world, leading to rescue and restoration for thousands of victims of violence.

Because of you, Canadian compassion is becoming an even stronger force for global good. Children are safer. Women are healing. Systems are changing. And because of you, 2025 looks less like a question mark—and more like the beginning of a movement for change for the most vulnerable.

So, let's not slow down. Let's keep going.

For the one still waiting,
for the child still hurting,
for the survivor who's rising—

Let's keep building a Canada known not just for kindness, but for courage.

OUR VISION

Rescue millions, protect half a billion and make justice for people in poverty unstoppable.

Violence is a global problem. We know the solution.

WHO WE ARE

IJM is a global movement committed to bringing an end to the violence experienced by children, women and men in the world’s most vulnerable communities.

We are a global team of lawyers, social workers, community activists, professionals and donors working towards a unified goal: safety and freedom for all.

Our 28 years of experience have made it clear that violence thrives when laws are not properly enforced to hold perpetrators accountable, deter crime and protect the vulnerable people in the community. **But when laws are properly enforced, violence plummets. Every time.**

The future of freedom is in our hands.

Every day, people in vulnerable communities around the world are trafficked, enslaved, exploited and abused because the local justice systems aren’t equipped to protect them.

But throughout the past year, you helped change that reality for thousands of children, women and men.

Thanks to your support throughout FY25, communities once vulnerable to violence are living in freedom today. Children who were abused and exploited are now safe and protected. Men and women who were victims of violence are now survivors and leaders in their communities.

OUR COMMUNITY PROTECTION MODEL



We rescue and restore victims of violence by partnering with local authorities to remove individual survivors of violence from harm and restore them to safety and stability.



We bring criminals to justice by working alongside justice system officials to ensure perpetrators of violence are held accountable, breaking the cycle of violence and deterring others from abusing vulnerable people.



We strengthen justice systems by equipping local governments and community leaders with the tools they need to respond effectively to violence, serve survivors, deter criminals and create safer communities.



We scale demand for protection by convening and empowering champions to advocate for protection as an essential, achievable and tangible reality for everyone.

YOUR IMPACT GOES BEYOND RESCUE

Your support makes it possible for IJM and our partners to send urgent, life-saving rescue to victims of violence who are trapped in situations of exploitation and abuse. But it doesn't stop there. IJM's goal is to end all types of violence against vulnerable children, women and men by protecting them from ever experiencing it in the first place.

And because of people like you, that future of protection has already become a reality for more than 10 million people! Within the last decade, **IJM has concluded nine justice strengthening programs** in different regions around the world. Externally verified data shows that **these projects have reduced slavery and violence between 50% and 85%.**



And we’re not done yet. IJM’s teams around the world have a plan to scale this protection to 46 new regions, with the potential to protect 490 million more people from slavery and abuse.

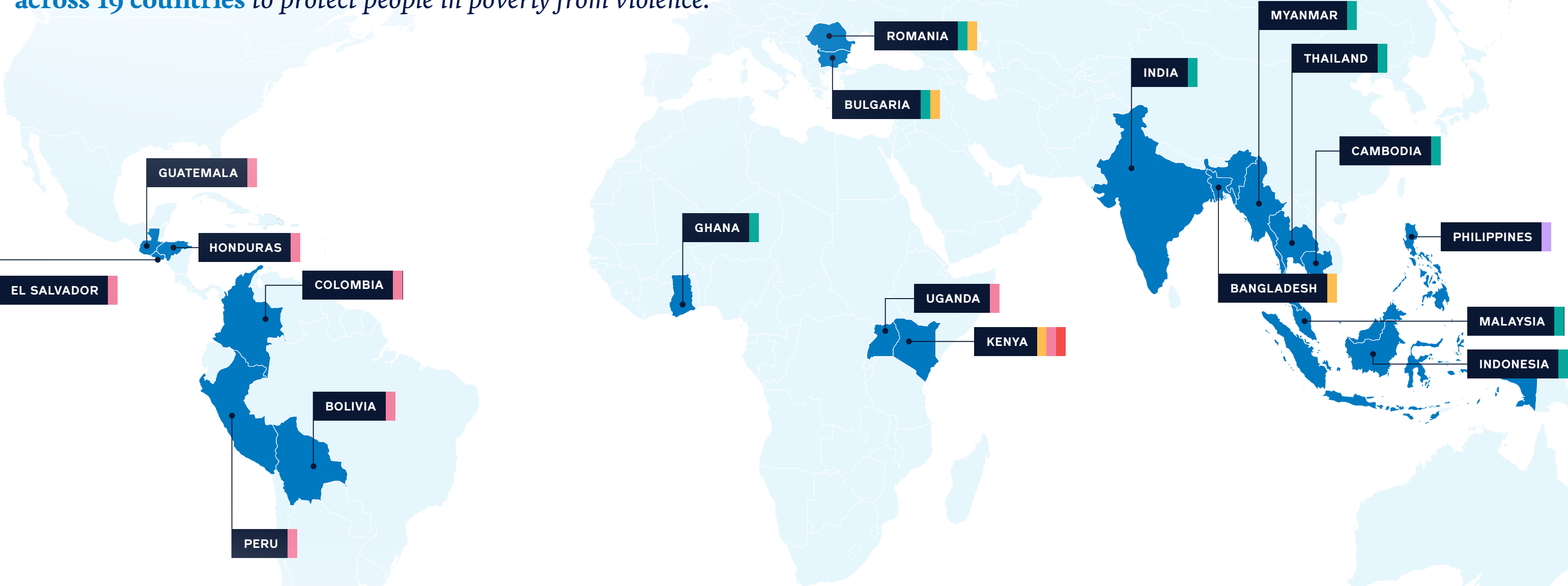

OUR MISSION

Protect vulnerable people from violence

by rescuing victims, bringing criminals to justice, restoring survivors to safety and strength and helping local law enforcement build a safe future that lasts.

THE IMPACT OF YOUR SUPPORT

In 1997, we were told it would be impossible to rescue even one child from a brothel. Since then, IJM has brought freedom to nearly half a million children, women and men suffering from violence, and protected over 10 million people from ever experiencing abuse and exploitation in the first place.

FREEDOM

IJM works with local partners and authorities to rescue children, women and men from violent abuse and exploitation.

INDIA

Six victims of bonded labour brought to freedom through consecutive rescue operations

With support from local IJM partners, the Tamil Nadu government led three back-to-back rescue operations that brought freedom to six victims of bonded labour. Three of the victims were rescued from a brick kiln, two from a duck farm, and one from a goat farm. All of them received **Release Certificates** and have begun their journeys of restoration.

Release Certificates

A **Release Certificate** is a government-issued document that formally clears bonded labourers of false debts and legally affirms their freedom.

INDONESIA

569 trafficking survivors return home after being freed from forced scamming compound

Following a large-scale government crackdown on forced scamming operations in Myanmar, 569 victims of trafficking have been successfully repatriated back home to Indonesia.

Forced scamming is a growing form of trafficking in which vulnerable people are trapped in compounds and forced to conduct online scams. IJM works with local partners in forced scamming hotspots to facilitate the process of helping survivors return home. In this case, four IJM Thailand staff supported authorities by providing translation and assisting survivors throughout the government's victim screening process.



GHANA

A mother reunites with her sons thanks to a survivor-led awareness campaign

During a community outreach event, members of Ghana's **Global Survivor Network** chapter went knocking on doors to educate locals about trafficking. A woman they met shared that she sent her two children to work with a fisherman, and in return was promised they would be enrolled in school. When she learned they were being mistreated, the fisherman refused to let her bring them home.

The survivor leaders connected her with IJM, who worked with local police to rescue her boys and arrest two suspects in the case.

Global Survivor Network

In 2019, IJM launched the **Global Survivor Network (GSN)**, an international group of more than **4,000 survivors from 12 countries** who are shaping and leading a movement to protect people from violence.



RESTORATION

When victims of violence are brought to safety, IJM works with partners to help survivors receive the critical support needed to heal and reintegrate safely back into society.

INDIA

From bonded labour to business owners: seven survivors craft new lives in freedom

Udayonmukha Handicrafts is a survivor-led business launched to help other survivors earn a steady and reliable income through dignified work.

The business employs seven survivors who craft jewelry, household textiles, laptop bags, scented candles and other goods. With IJM's help, the business actively works with local organizations and government agencies to create business opportunities and host skill development workshops. Recently, government officials ordered 250 laptop bags to encourage the survivors' artistry and celebrate their skills.

All profits are divided among the artisans, with a small percentage set aside to help support the rehabilitation and empowerment of other survivors of bonded labour in their community.



Assesment Survivor Outcomes

IJM's aftercare teams use a resource called the **Assessment of Survivor Outcomes (ASO)** to measure a survivor's progress towards restoration. This IJM-built tool sets the standard for determining improvement in a survivor's ability to live in freedom without fear of being trafficked again.



SOUTHEAST ASIA

Free to be Me follows the story of a child trafficking survivor and her reunion with the IJM staff member who coordinated her rescue

IJM partner Bloom Asia has released a documentary that tells Nary's story of restoration after being trafficked at a young age. The film captures Nary's heartfelt reunion with Sharon Cohn Wu, IJM's President of North America, who was central to her rescue.

Of her experience reconnecting with Nary, Cohn Wu says, "It was a once-in-a-lifetime moment."

KENYA

After his wrongful imprisonment, a survivor of police violence receives life-changing restitution

Just two weeks into Collins' new job as a night guard, he overheard an argument between some other guards and a police officer. When he went to investigate, the police arrested him and charged him with a crime he didn't commit.

With IJM's support, Collins spent years fighting the charges until he was acquitted and awarded compensation in 2017. But systemic barriers in the legal system prevented Collins from receiving that money for years.

More than a decade after his wrongful imprisonment, Collins finally received the compensation he was owed.

"Receiving my compensation validated my suffering and provided a financial means to rebuild my life," he recently told IJM.

Collins is now a leader in his local GSN chapter, passionately advocating for justice in his community. He has invested his restitution money into constructing rental homes, hoping to generate a reliable income for his family in the coming years.

JUSTICE SYSTEM STRENGTHENING

IJM trains justice system officials to enforce laws more effectively and prevent violence from happening in the first place.

CÔTE D'IVOIRE

IJM partners to protect children online through training



IJM joined NCMEC, Meta, the RCMP and several other public and private organizations to lead a five-day law enforcement training session in Côte d'Ivoire.

The National Center for Missing & Exploited Children's (NCMEC) CyberTipline is the world's leading reporting mechanism for public and electronic service providers to report instances of suspected child exploitation. But the volume of

reports is so high that law enforcement can't act fast enough to effectively access, assess and act on them.

In response, this highly collaborative session trained police to use the Cybertipline report as a means of identifying offenders and protecting children. Previous trainings in Kenya and Nigeria have already led to improvements in justice system responses.



PERU

More than 250 police officers attend workshops on how to provide trauma-informed support for child victims of violence

Children who have experienced the trauma of sexual or physical violence require sensitive and appropriate care. Through a series of workshops, IJM Peru collaborated with the Peruvian Police Division for the Protection of Children and Adolescents to train more than 250 officers on how to serve children who have experienced violence.

The workshops used interactive, practical and dynamic methodology to enhance the capabilities of police officers to protect and provide sensitive care for children and adolescents who are seeking help at police stations.

The sessions were conducted by peers who had been previously trained, giving facilitators the opportunity to reinforce their knowledge and strengthen their leadership skills.



BANGLADESH

IJM trains over 50 police officers to combat human trafficking

IJM's newest field office in Bangladesh has already made meaningful progress to combat human trafficking in the region. Together with the International Criminal Investigative Training Assistance Program (ICITAP), IJM led a 10-day program that trained more than 50 police officers on responding to human trafficking and victim care and management.

This collaborative training program established IJM among local authorities as a credible expert on human trafficking and a trusted collaborator.

COMMUNITY TRANSFORMATION

As local authorities become more effective and confident protectors of their communities, a new precedent of justice is established. Perpetrators are held accountable, crime is deterred and daily life becomes safer.

HONDURAS

Local IJM partner secures first conviction in a case of sexual abuse against a minor, proving empowered communities can be agents of change

After just one full year of collaboration between IJM's local partner Centro de Desarrollo Humano (CDH) and an Indigenous community, justice has been served for a child in a rural community in Honduras. A man has been sentenced to seven years in prison for sexually assaulting his 13-year-old niece, Emma.*

When Emma and her mother reached out to a neighbour for help, the neighbour knew exactly what to do. She had previously done community work with CDH and connected Emma and her mother with a CDH-trained community advocate. The advocate helped them file a complaint, seek legal advice, and provided emotional support through the trial.

This sentencing shows that when communities are empowered with knowledge to stand against violence, and when local organizations are equipped to support people, aggressors are stopped, women and children receive justice and other potential aggressors are deterred.



THAILAND

Trafficker sentenced to 30 years in IJM's first forced scamming conviction

In close collaboration with the local government, IJM secured its first conviction in a forced scamming case.

The trafficker was convicted of several crimes, including conspiring in human trafficking and forced labour of minors and was ordered to serve more than 30 years in prison and pay fines worth \$58,000 CAD. Trafficking sentences exceeding 30 years are rare in Thailand.

For the four Thai citizens who sued the trafficker, the court's verdict marked justice and safety. For criminals across Thailand, this conviction sent a clear message: trafficking people for forced scamming is a serious crime that merits serious consequences.



PHILIPPINES

Supreme Court affirms woman's conviction, sending strong message of justice to would-be perpetrators

The Supreme Court of the Philippines has upheld the strong sentencing of a woman who livestreamed the sexual abuse of her six-year-old niece.

The perpetrator will spend up to 40 years in prison after IJM worked with local officials to bring her to justice. The Supreme Court denied her appeal to reverse her sentence sending a forceful message to perpetrators across the country.

"Serious legal consequences await anyone who sexually abuses and exploits children online. May this conviction, and the many others achieved in the past, remind would-be perpetrators that the Philippine criminal justice system does not take lightly this grave offense against our precious children," said a local prosecutor.

Statistics on the Philippines

Together with Philippine authorities, IJM has seen more than:

- 1,335** victims and children-at-risk brought to safety
- 417** suspected perpetrators apprehended
- 244** perpetrators convicted

GLOBAL MOVEMENT OF JUSTICE

IJM collaborates with corporations, governments, non-profit organizations and community groups all around the world to stop violence before it starts.

COLOMBIA

IJM advocates for child safety in front of world leaders at conference in Colombia

IJM joined government leaders, survivors, civil society organizations and experts from around the world for the inaugural Global Ministerial Conference on Violence Against Children. IJM made five key recommendations on how to implement better strategies to end violence against children.

This was an unprecedented opportunity for IJM and survivor leaders to advocate for better care and access to justice for children in front of leaders from 119 different countries.



ROMANIA

Romania passes critical new laws to crack down on trafficking

IJM's collaboration with several Romanian branches of government has led to the creation and approval of two laws that will help combat trafficking and protect victims. Romania currently has one of the highest rates of trafficking among European countries. Government leaders have responded with urgency by voting unanimously in favor of both bills, drafting and passing these new laws in record time.

These bills are part of a broader initiative by IJM and the Parliamentary Commission to strengthen criminal legislation in Romania in order to respond more effectively to the problem of human trafficking.

PHILIPPINES

IJM launches awareness campaign to protect children in the Philippines

After IJM's 2022 Scale of Harm study revealed the extent of online sexual exploitation of children (OSEC) in the Philippines, it became clear that action would need to be taken at the community level to ensure that crimes are being faithfully reported to the justice system.

In response, IJM launched a national campaign to shift cultural norms so that OSEC is not minimized as a "family issue" but a crime that must be reported to local authorities immediately.

Philippines President Ferdinand R. Marcos Jr. has publicly expressed his support for the campaign and has committed to adopting a unified nationwide approach to address the crime and better protect children.

ADVOCACY IN CANADA

IJM Canada is becoming a recognized and trusted thought leader across the country, leveraging our expertise to help Canadians lead in the global fight to build a safer future for all.



APRIL 2024

IJM launched the Scale of Harm report with a national press conference and briefing with MPs and policy advisors in Ottawa.

IJM stood alongside the All-Party Parliamentary Group to End Modern Slavery and Human Trafficking, the Embassy of the Philippines and Canadian leaders to confront the reality that 1 in 100 children are victims of online sexual exploitation in the Philippines. And Canada is among the top four countries sending money to pay for this abuse.

The message was clear: Canada cannot be a bystander in the fight against child sexual exploitation.

MAY 2024

IJM Canada CEO Anu George Canjanathoppil keynoted the National Prayer Breakfast in Ottawa. What followed was extraordinary: a surge of awareness, partnership and prayer across the Christian community to end violence and exploitation.

IJM met with Latin American ambassadors in Ottawa to build trust, listen, learn and discuss the shared goal of protecting women and children.

Soon after, we hosted our first Leaders Breakfast in Mississauga, creating space for honest dialogue between Canadian citizens and global justice experts.

AUGUST 2024

IJM Canada submitted five strategic recommendations for the 2025 federal budget—making a strong statement that dollars should be spent where they matter most: protecting vulnerable women and children and ending online sexual exploitation.

OCTOBER 2024

IJM released new Protection Studies from Bolivia, El Salvador and Guatemala, highlighting the urgent need for improved access to justice and stronger community support for women and children affected by violence

The reports and Anu's keynote at the National Prayer Breakfast caught the attention of Canada's leaders, and IJM Canada was invited to present our work to Global Affairs Canada and the Prime Minister's Office.



NOVEMBER 2024

IJM was invited to speak at provincial and international conferences and a special G7 working group to address child sexual exploitation and abuse.

We launched a national faith-based guide for the 16 Days of Activism against Gender-Based Violence with our partners World Renew and Citizens for Public Justice.



DECEMBER 2024

IJM Canada submitted five clear recommendations to the Standing Committee on Justice and Human Rights regarding Bill C-63. Though the bill was withdrawn, we will be advocating to reintroduce online safety legislation to address livestreamed child sexual exploitation and abuse in the next Parliament.

JANUARY 2025

IJM presented Scale of Harm study and recommendations for Canada-Philippines online child sexual exploitation investigations to the RCMP Transnational Offences Unit.

MARCH 2025

IJM created a resource to help Canadians encourage election candidates to reintroduce online safety legislation to protect children everywhere from Canadians abusers.



THE PATHWAY TO PROTECTION

If rescue is a candle in the dark, protection is the rising sun at dawn.

IJM exists to stop the violence that consumes vulnerable communities. While sending urgent rescue to those who need it most is important to our work, protection is vital to stopping this abuse entirely. That's why IJM is equipping local justice systems to protect future generations from ever experiencing harm in the first place.

PHASE 1: ASSESS

- Identify communities where people in poverty experience violence.
- Ensure local governments are open to collaborating with IJM to stop it.
- Assemble local teams to foster relationships, evaluate the community's needs and start building solutions.

IJM BEGAN WORK IN TAMIL NADU IN 2001

South Asia has the largest number of people in bonded labour. Traffickers target vulnerable individuals in urgent need to trap them in an endless cycle of false debt. The government in Tamil Nadu showed a willingness to address it in their community.

PHASE 2: PARTNER

- Establish trust with government authorities and build relationships with local partners.
- Collaborate on projects that reveal justice system weaknesses that prevent laws from being enforced effectively.
- Strengthen the weaknesses we identified to build a strong justice system that lasts.

In Tamil Nadu, IJM collaborated with local authorities and partners to build the capacity of law enforcement officers to recognize human trafficking, bring relief to victims and prosecute criminals.

PHASE 3: EVALUATE

- Continue collaborative projects to build justice system capacity.
- Collect data that determines the success of justice system transformation, including whether we built community confidence and reliance, and reduced violence.

IJM's collaboration with the government from 2001 to 2021 helped free 8,000 children, women and men from bonded labour. IJM also trained 50,000 government officials, police, prosecutors, judges and other community members to better enforce laws and protect vulnerable people from bonded labour slavery.

PHASE 4: EMPOWER

- Publish data that proves violence has been drastically reduced.
- Ensure government and local partners are equipped to sustainably protect their communities on their own.
- Conclude the project—and celebrate!

In 2022, external evaluators documented an 82% relative reduction in bonded labour within Tamil Nadu. Based on this reduction, we estimate that there are 380,000 fewer people in this form of modern slavery. The project is now completed and we are working to replicate its success.

WHAT COMES NEXT?

To date, IJM has drastically and measurably reduced violence in nine different regions. But the work is far from over. We have identified many more regions where justice system strengthening projects could protect hundreds of millions of vulnerable people. And the only way forward is alongside people like you.

In December 2023, IJM began Phase 1 of a new program in Bangladesh. Our team is now working with government agencies and local partners to study the current state of human trafficking and design an impactful program to rescue victims, bring criminals to justice, restore survivors and strengthen the justice system.

JUSTICE IS FUELLED BY PEOPLE LIKE YOU

A movement of justice driven by hope and compassion is growing in Canada. And it’s moving us closer to a world where safety and freedom are a reality for all. Thank you for being a part of it.

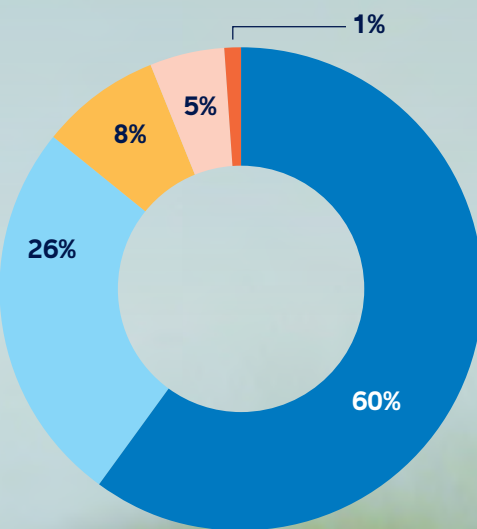

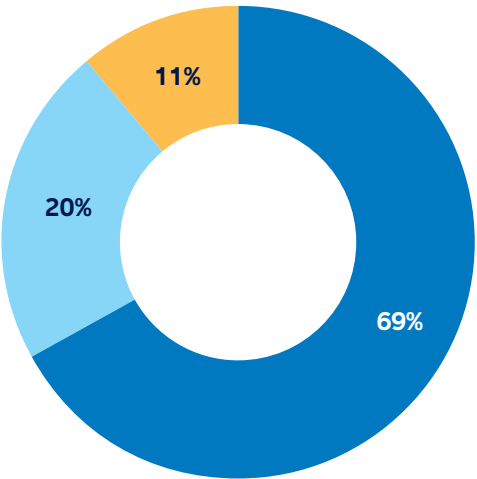
