The Presbyterian Church in Canada accepts gifts-in-kind of appreciated securities for its ministries, missions and congregations. To facilitate your gift transfer, please complete this form and send: 1) A copy to your broker who will initiate the transfer. 2) A copy to Stewardship and Planned Giving Department. Unidentifiable transfers may make it difficult for the PCC to cash the stock and issue the tax receipt.

The charitable tax receipt will be issued reflecting the market value of the stock on the day it is deposited into the PCC's brokerage account, the number of shares and the date that it came in. The stock is sold shortly after it is received. Stock price often changes – sometimes up, sometimes down – from the day it is received and when it is sold. The net proceeds, less the broker fee, are transferred to the PCC and then allocated as designated. The PCC does not charge anything for processing the donation.
