  - The nominations workbook is completed and ready to go. This was ready for the Fall Theological Conference so that rostered leaders may begin to think about these positions.
  - The Committee on the Election of a Bishop is in the midst of its work, and a further update is to be given later in the meeting.

#### **BISHOP'S COMMENTS**

- Bishop Regina Hassanally gave the following comments to the council:
  - She and her staff have been navigating some end-of-call situations.
  - The staff is working on a new Synodically Authorized Worshipping Community, the Noor Community Congregation, which will be presented for approval later in the meeting.
  - Three ordinations are coming up in the near future.
  - The First Call Retreat will be happening soon.
  - The Fall Theological Conference was held in October and overall responses have been positive.
  - The SEMN Synod will host Region 3
     Bishops and Assistants in
     Alexandria, MN.
  - The Synod will hold a Chrism Mass, which is a time to recommit to ordination/baptismal vows for rostered and lay leaders in Advent. This will be open to all rostered and lay leaders in the synod.

- Councils as Leaders will be held in March. The planners are aiming to offer practical skills for leaders.
- Conference Assemblies are set for February 16<sup>th</sup>. All will be held on the same day.
- Bishop Hassanally noted that she is on the executive board for MN Council of Churches and that they have just hired on a new CEO.
- CGP has been invited to apply for another Lilly Grant, which was granted, called Prairie Fire Preaching. This will involve inviting people from all types of fields (preaching, auditory, etc.) having them instruct preachers on how those fields can impact their preaching.
- She continues to serve on the Committee for a Renewed Lutheran Church and updated the council on the work being done here.

#### FINANCE 101

 Assistant to the Bishop and Director of Evangelical Mission Rev. Emily Carson and Synod Treasurer Tammy Dahlvang walked through the various financial reports that are presented to the council and instructed council members on how the synod finances function.
