

Southeastern Minnesota Synod Council Meeting Minutes September 7, 2024

The Southeastern Minnesota Synod Council met on September 7, 2024, at St. John's Lutheran in Kasson, MN.

GENERATIVE WORK

WELCOME & INTRODUCTIONS

- Vice President Lisa Dierks welcomed the council and began with devotions.
- The council members then introduced themselves.

CONFLICT OF INTEREST & CONFIDENTIALITY FORMS

 Conflict of Interest and Confidentiality forms were distributed and discussed. Council members were asked to read, sign, and return these forms.

MAKING CONNECTIONS WITH CONCENTRIC CIRCLES

 The council then participated in an icebreaker exercise to get to know one another.

LUTHERAN SOCIAL SERVICES (LSS)

 Rev. Amanda Simons from Lutheran Social Services was invited to share about Lutheran Social Services of Minnesota.

- She shared the mission, vision, and origins of LSS.
- LSS is the social service arm of the ELCA.
- There are 1,200 ELCA congregational partners of LSS.
- Rev. Simons noted that LSS of Minnesota serves 1 in 63 Minnesotans and that they serve more people outside of the metro area.
- She discussed some of the services that LSS provides, and the ways that congregations and LSS work together to help our neighbors. Services fall into categories for older adults, people with disabilities, and children, youth, and family services.
- She noted that LSS is looking for people or a group to "adopt" a group home to do yardwork (fall and spring). Right now, the staff has to do this. This also allows for volunteers to get to know the residents and build healthy relationships.
- She encouraged council members to lift up the financial counseling program that LSS provides, the above mentioned "adopt a group home" request, and to ask congregations to consider holiday giving for group homes, as this is very meaningful to those who receive it.

ROLE OF THE COUNCIL

- Director of Evangelical Mission and Assistant to the Bishop Rev. Emily Carson was invited to discuss the role of the synod council and the Constitution of the synod.
- She noted the role of the constitution and constitutions in general and walked through a brief history of the ELCA.
- Bishop Regina Hassanally noted the work of the Committee on the Renewal of the Lutheran Church, which is reviewing our current governing documents and evaluating if they work for our current time.
- She then walked through S10.03. of the synod's constitution, which discuss the synod council's function. The council discussed these functions in detail.

VICE PRESIDENT'S COMMENTS

- Vice President Dierks then gave the following updates to the council:
- Minimum Compensation Guidelines Task Force Update & Tentative Timeline
 - She gave an update on the timeline for this Task Force and the changes that were made to this last year. The task force is currently working on this document and will have the document ready by September 20. A public review period will be open from September 20-September 30. In early October, a special synod council meeting will be held to approve these guidelines.
- Committee on the Election of a Bishop
 - An election of a Bishop will be occurring at the next synod assembly.

- She noted that 21 synods will be electing bishops this year.
- At this point, the Committee on the Election of the Bishop is waiting for the Conference of Bishops and Churchwide to meet and offer some guidance on the process. This meeting will happen in November.
- The council discussed the Landscape Survey, which was completed prior to the last Bishop election in 2018.
 - Vice President Dierks reached out to other Synod Vice Presidents to see if they did a similar survey process prior to a bishop election. She noted that there were two big responses from the group: Some did the Landscape Survey; others created their own google form with a few questions and sent these out for respondents to answer.
 - The council discussed if another survey should be done, and how in depth it should be. It was felt that some of the main themes pulled from the prior survey are still pertinent and could be of use to the upcoming work of the Committee.
- Treasurer Tammy Dahlvang made a motion to have the Committee on the Election of the Bishop review the 2018 Landscape Survey and return to the council if they feel any further survey work needs to be done.

BISHOP'S COMMENTS

- Bishop Regina Hassanally gave the following comments:
 - Personnel and Administration
 Updates
 - Director of Communications Ashley Corbett will be taking a 4-week medical leave. Other staff members will be covering her tasks during this time.
 - A signed independent contract was completed with DEM Rev. Emily Carson to help separate some of her financial duties from her DEM work.
 - A job description is in process for a youth event coordinator for the synod.
 This job will be posted soon.
 - A synod vehicle driven by Rev. Matt Larson was in an accident and is currently being totaled. Bishop Hassanally noted that they don't have the intention of buying another vehicle at this point.
 - Task Forces continue to work on updating the Personnel and Sexual Misconduct Policies, and Rev. Carson is working on Financial Policy updates.
 - Summer Activity Updates
 - Youth Gathering
 - Bishop Hassanally attended the Youth Gathering over the summer in New Orleans. Everyone had a great time

- and around 700 kids from the synod attended.
- The Bishop was invited to attend an advocacy trip in Washington DC in June.
- She lifted up that MN ELCA bishops were invited to meet with the governor's office, in order to have a line of communication with them.
- Bishop Hassanally went on a visit to our companion synod in Columbia, the Evangelical Lutheran Church in Columbia, She went with Assistant to the Bishop Kathy Chatelaine.
- Supporting Rostered Leaders
 - She has taken part in in an ordination recently and has a few more coming up in the fall.
 - She noted that there is a larger number of people going through approval right now, but the numbers drop off following that.
 - The Fall Theological Conference is coming up in October.
 - The New to the Synod gathering will be next week.
- Supporting Congregations
 - "Councils as Leaders" date has been set. This event will have practical sessions and resources for council leaders.
 - The Bishop and her staff continue to work at visiting all congregations of the synod.
- o Updates on the wider church
 - She continues her work on the CRLC and sits on the Planning and Report Committee and Governance Committee.
 - Bishop Hassanally will be at the Conference of Bishops in November.
 - She continues to serve on the LSS and Augsburg boards.
