# Pastor's Report July 16, 2025 Pastor Jordan Miller-Stubbendick St. Mary's Lutheran Church, Kenosha, Wisconsin

On July 12, I attended Kenosha Pride to represent the Kenosha ELCA congregations who are Reconciling in Christ.

I officiated at the wedding of Kaelan Aker and Kyra Lucchetta on June 21, and the funeral of Jennifer Staccato on July 12. I continue to make pastoral care visits in people's homes and facilities, as well as offering support to members who stop by my office.

Pastors and lay leaders from the Kenosha ELCA congregations who want to plan a joint worship service around holiday weekends will meet on July 29 at St. Mary's.

Carthage College history professor Dr. Stephanie Mitchell has asked me to facilitate an event on August 9 that will bring together organizations in Kenosha and Racine that serve immigrants in the community.

I am in conversation with Mikah Meyer, who has traveled to all 400-plus National Park sites and has made a short documentary about growing up as a gay Lutheran pastor's kid. Mikah has offered to show his documentary/preach at St. Mary's on the weekend of August 23 and 24.
