## Zion UCC Consistory Meeting Agenda October 10/14/25

Call to Order by Dave at 7 pm.

Attending: John, Jeff, Debby, Robin, Bob, Dave, Cheryl, Kelly D and Pastor Duffy. Debbie G was present for first half hour as a guest.

Absent: Pierre, George, Elena, and Ted.

**Approval of Consistory Meeting Minutes** (one minor change made: "... Consistory "owns" the By-laws and can amend or review it after discussion. Trustees are the legal arm of the church and are caregivers Caretakers for the property of the church ..."

Motion to approve changes to last month's meeting notes were passed by all attending.

# **New Policy Reviews and Adoptions**

- Safe Church Policy (Debbie Grine)- The new policy was reviewed. A motion to clarify volunteers (as those who
  work with youth and vulnerable adults) and to adopt the new policy was proposed by Cheryl, seconded by Bob,
  and unanimously approved by all attendees.
- Document Retention Policy (John)- The policy was reviewed and discussed. John made a motion to adopt the
  policy with three proposed amendments: removing the quoted reference to Zion UCC, eliminating mention of
  pledge cards from the contribution records section, and adjusting the retention period for envelopes to one
  year—aligning with the existing seven-year retention of Breeze contribution records. The motion was seconded
  by Kelly and unanimously approved by all attendees.
- Rental Policy (John, Trustees)- The policy was reviewed and discussed. John reviewed the policy with us. There
  was much discussion about insurance liability. Several language modifications were made and John will followup with the Trustees on this.

**Final Revisions to Draft Bylaws -** The policy was reviewed and discussed. John made a motion to approve the by-laws as written, which was seconded by Kelly. The by-laws will now be presented to the congregation for final approval at the annual meeting in January.

### Treasurer's Report

As of 10/2/25 there is a balance of \$67,152.81 in the operating account and \$29,284.71 in the restricted funds account.

The revenue for September was \$17,573,69 and the net income was \$-7586.82. In comparison: The revenue for September 2024 was \$18,105.59. The net income for September 2024 was \$-1160.12.

The YTD Revenue is \$173,871.41 and the YTD Net Income is \$10,973.50. The YTD 2024 Revenue was \$155,355.25 and the YTD 2024 Net Income was \$10567.72.



Notable P&L events in September:

- 54000 Admin. Exp. Other \$8,188.84 Bal. due for Memorial Park not covered by donations {Trustees have agreed to cover \$7,888.00 of this expenditure – will show in October}

   Classroom partition, door signage, handrail, etc.



We remain in a good position. The budget is tracking as expected. The only unbudgeted expense expected to be forthcoming will be the plaque recognizing the Memorial Park donations. Any costs not covered by donations will be paid for directly from the General Fund.

Motion to approve the Treasurer's Report was made by John and seconded by Robin. All attending approved.

# **Pastor's Report**

- She will be away this weekend for the Western Area Youth retreat at Dunkirk (52 people will be attending). She will still be here Sunday morning (though probably a little tired).
