<u>Minister's Report</u>: Karen shared her experience at the Bridging the Gap evening at St Matthew's UC – dialogue with Israeli heritage and Palestinian Muslim students who modelled idea of respectful dialogue and deep listening – occurring at different universities/colleges - Thanks for Dessert and soups – importance of eating together

#### Operations – Doug

- Updated information will be posted on the website
- Doug feels that they are close to applying for the board's approval project has been divided into different chunks
- performance venue Ralph is overseeing this component
- A more professional 5 year projection has been compiled by Julie
- Getting final quotes and prices for the work NB mtg held onsite with Historic Restoration and Casavant organ representative – final quotes to be received within days hopefully
- Chouinard to do more inspections of roof and give quotes of full roof job and repairs
- Need to get permit to block centre street a few hours for roofers come in
- Carolyn and DJ are preparing to work on governance questions regarding performance centre

- One scenario explored with no hired manager for Performance Space- instead of sale of manse to generate cash to complete repairs, Julie and Finance projection recommend a major fundraising \$1.2 Million – if doesn't work well enough, sale of manse is Plan B
- In the scenario of no manager until later, current office staff and volunteers would work to make arrangements and book the space as first couple years so not incurring high cost of manager
- Don't necessarily need full \$200,000 loan
- Need to start thinking of outreach, brand ourselves, 'Friends of \_\_\_\_\_'
- Branding helps with credibility
- Few more pieces to come together to set the plan.... A complete doc needs to go to congregation prior to AGM if any approval is being sought (such as doc that Jane had circulated a while ago)
