Grant Updates: *NPS Roof Grant Update/Ceiling Issues *Stormwater Grant Update *DAR Grant for Patriot Graves	*NPS has approved Press Release that must be published in two newspapers re: the NPS Roof Grant. This was done and advertised. *Heritage Conservation noted the hole in the church ceiling above the organ. Chris will consult with Brunner Organ about how to complete a repair safely. *Stormwater Grant: when engineers reach 60% milestone (almost completion), they will present the plan to the congregation. *DAR Grant for Patriot Graves: HGDPC applied for a grant to have 13 patriot gravestones restored. Amy noted that obelisks in the NPS are leaning badly, but that repairs would need to be made in partnership with the NPS. Gabby is a member of DAR Washington DC Chapter and will contact the Phila Chapter to establish a connection with them.	
Property Updates and Plans: *Riverside Flooring Project *Plumbing Work in Roak *Wiring Issue in Rudman	After reviewing 4 estimates, it was decided to hire Dan Higgins, Inc. to install new flooring in Riverside. Samples of material were also reviewed and one was chosen. Project not expected to start until after the New Year. *Mark Roberts will obtain permits for a shed in anticipation of the flooring project. *Ceiling fans/lights cannot be installed in Rudman because of existing knob and tube wiring.	*Motion was made, seconded and approved to hire Dan Higgins, Inc. to install new flooring as chosen by Vestry for Riverside. *Motion was made, seconded and approved to fix electrical problem in Rudman as soon as possible instead of getting more estimates as the existing situation presents a danger to the building and any occupants.
Tithe Program	Rev Chris brought up the idea of tithing some of the money we saved for the church roof, which is now covered by a grant. He asked that the Vestry think about outreach opportunities. We have to consider what this windfall could do to our "income" and the effect this could have on our portion of the Sacred Ask. We have \$11-12k to spend on outreach.	At the suggestion of Candy, the Missions Committee will consider outreach opportunities and make a recommendation to the Vestry.
