Team Updates:

- 1. Director of Operations and Property Report: Doug Bjotvedt
 - **Tempe Land Sale Update:** The City sent over a special easement request. They need to rent some space for equipment when they do the well rebuild. The land sale contract is waiting in the mayor's office for a signature.
 - Parking Lot Update: Doug had approved a change to the contract to increase the
 materials and the price by \$1500. The change order was never sent to Doug and never
 completed by the company. Thus, not enough material was used to fill all the cracks.
 Mari and Vicki met with the owner of the company to survey the cracks & he agreed they
 would return to fix it. Now, no one is responding from the company & there are no
 scheduled plans to fix the unfilled cracks.

- The IRS finally finished a review from 2023 and it looks like an ERC refund will be coming to Desert Cross. The ERC accounting firm claimed it would be \$20,000. This is not yet confirmed, but the refund will come by 9/30/25. The ERC accounting firm gets 5.8% of the ERC refund per contract.

Addendum September 18, 2025

Corporation commission guidelines recognize certain titles that can add & remove people as signers on the bank accounts. • Pr. Andrea:

- Our fall programming at Desert Cross is off to a great start! We have good energy and participation in our worship and our education programs. - We had an informative mission moment this weekend in Tempe and next week in Gilbert with Habitat for Humanity. There are many ways to support Habitat including volunteering, bringing meals, financial support, and prayer.

- Desert Cross has a new missional partner in Borderlands Produce Rescue, a non-profit committed to rescuing and redistributing fresh produce with a mission of reducing food waste, feeding people nutritiously, and promoting sustainable agriculture and composting. Our Tempe campus has a perfect set up for their Produce on Wheels With-Out Waste program which is the Arizona Distribution program. We will be a monthly distribution site. We advertised in the Friday update and over 20 people from both campuses are interested in volunteering. Pastor Thadd, Denise McClellan and I met with the Founder and President last week and look forward to beginning the mission in November. More details to come.
- I completed required CE credits for boundary awareness training, "Boundaries for Christian Leadership" through the Faith+Lead Institute. This training ensures that our ministry is carried out with integrity, care, and safety for all.
