• Parking Lot Update (Pr. Thadd Book): Reported concerns of big cracks not completely sealed and light coverage in some areas. Doug Bjotvedt working to reach contractor and follow up on concerns.

REPORTS

Finance Report (Gary Balliet):

- Sale of land to City of Tempe approved.
- Shared outcome of 8/3/2025 special congregational meeting.
- Breakdown. Sale to City of Tempe \$245,000.
 - 1. 10% towards Mission and Outreach
 - 2. \$54,000 with 7% interest loan for AC units to be paid off
 - 3. Remaining funds (~\$167,000) to be placed in a Capital Expense Fund, guidelines in place to access matching funds. Capital projects <\$10,000 can apply for matching funds. Capital projects >\$10,000 must have congregational approval for matching funds.

Pastor's Report (Pr. Thadd Book):

- Planning to teach a class on the Gospel of Matthew for four Wednesdays beginning on 10/29/2025.
- Working with Joni Van Rossum on changing out the technology at Gilbert campus to MAC format, moving away from PowerPoint.

Outreach Report (Joy Petroff):

• Meeting scheduled for 9/7/2025.

Hospitality Report (Dana Hargis):

• Laid out the three-phase plan to refresh the Gilbert campus. Phase 1 includes interior paint for Sanctuary and Fellowship Hall, change out light fixtures and ceiling fans, stone behind cross on altar, updated

- countertops/faucets in bathrooms, and various small projects within this general scope.
