George has been stably housed with Interfaith's Permanent Supportive Housing program since 2013. George is a U.S. Air Force Veteran, a pilot, a retired LAPD reserve officer, a lifelong student, a brother, a son, and a mentor to his friends and other veterans in his community. After serving in the U.S. Air Force, George earned his security guard certification, joined the LAPD Reserve Corps, and completed his 4-year degree in Criminal Justice & Forensics with a minor in Political Justice. Later, following in his father's footsteps, George went to flight school. He worked as a flight instructor for some time before being hired by a major airline. George was flying for this airline on September 11, 2001, when the World Trade Center was attacked. Not long after this tragic event, George fell into hard times. He was laid off by the airline and was diagnosed with diabetes just a week later.

George did his best to stay afloat by taking security guard jobs whenever he could. However, he was confronted with adversity once again when he was hit by a car on-the-job. George's injuries kept him from being able to work and he eventually became homeless. Thankfully, George contacted the VA, and they directed him to Interfaith. George was immediately placed into emergency shelter where he received case management. To this day, George remembers the name of the Interfaith employee that counseled him at Interfaith's Haven House shelter and provided him with the information and resources he needed to start obtaining the VA benefits and compensation he deserved.

Then, in 2013, after 7 months in emergency shelter, George was connected to the Permanent Supportive Housing Program. Since then, George has been steadily increasing his income and investing more time in his hobbies and passions, one of which is painting model soldiers. Unfortunately, George suffered a stroke in April 2020. For a period of time following the stroke he was unable to walk, talk, eat, or swallow. However, the recovery that George has made in the last 5 years is truly incredible and a testament to his mental fortitude and unbreakable spirit. Although he still faces health challenges on a daily basis, George is optimistic about the future. He hopes to start a business with a good friend of his and buy a home within the next few years.
