# A Message from Pastor Lars

Churches are unique entities today. They're one of the few places left where people of different political persuasions exist in the same community. Yes, we work with all sorts of people, but jobs are not communities in the same way, as much as that new hip consultant who was hired to do the team bonding retreat tells you. At a place like Christ Lutheran, we worship and sing together. We pray together for each other, sometimes laying on hands or hearing each other one-on-one.

What makes us as ELCA Lutherans (and, mainline churches generally) so different is that we predate the self-sorting and silo-ing that's taken hold of our culture. Originally our connections were ethnic (the first members were mostly German), then theological, but not political. Maybe that's because our society was generally more socially conservative, regardless of opinions on economic policy. But also because we didn't think of our politics as identities. Now, we don't say, "I vote democrat" or "I vote republican". It's "I am a democrat/republican or conservative/liberal". What we believe has become who we are.

And so, when we come to looking for churches, we generally pick ones that align with our politics first, and sort between them. Those outside our politics, we don't even consider. And with 50 churches in Walla Walla, one has a lot of choices. Statistics show that this trend continues year after year, with churches becoming more politically homogeneous, and ones that are more mixed politics are shrinking. We people like to hear our views mirrored back, and seek places that align with our values.

That said, I would totally do that myself, if I were "Lars the insurance agent" instead of "Lars the pastor", and I were moving to town with my kids. I would cross off places that taught the earth was 6,000 years old, or had lots of hellfire, or lots of that "submission and obedience" language. I would search for a place that I felt was more open-minded, more critical thinking, less harsh, more accepting – more like the ELCA, in other words. And it's not because I need to only be around people like me, but there are things I just don't want to be a part of – such as fundamentalism or legalism.

On December 7 we have a vote on becoming a Reconciling in Christ (RIC) congregation. I encourage you to come, to be a part of the process of discernment. In many ways, I wish we didn't have votes, but could make decisions by consensus, so we don't move forward until we have everyone on board. Logistically, that's very difficult in large groups, and constitutionally we're not set up for that. So a decision has to be made one way or the other, ballots must be cast. It's how we do it that will make all the difference. Will we approach it as a community, in love and respect, honoring each other, however we vote? Will we give the best possible spin on our neighbor's position, and not assume bad faith or devious intent? And how will we react? Will we maintain that? I hope so.

Too many big votes turn ugly in the aftermath. It's why I struggle with them. You end up with "winners" and "losers". Some feel like they got what they wanted, while others feel defeated. Then you have those who gloat and dance, making the minority feel unwelcome. I've seen it too many times, the sore "winner".

I don't see this as something with winners or losers, but as a decision to change or not. It's part of the process of being in community. We know we can't keep everything the same forever. We know that new visions and new stances, new understandings and new directions are necessary to grow and not be stagnant. Which ones: that's what we have to figure out. And we try to do that together, with respect.

It's worth noting: the official ELCA statement on sexuality outlines 4 positions that are all considered valid. However the vote goes, you are still an ELCA member in good standing. You are still a part of our church. So I guess this is a plea for good process, for love and respect and support of one another in a big choice. I hope to still see everyone around after for Advent and Christmas.

## CHRIST LUTHERAN CHURCH CHURCH COUNCIL MEETING MINUTES November 11, 2025

Council president Kay Shelton called the meeting to order at 5:32pm. Those attending were Pastor Lars Hammar, Gordon Heimbigner, Anne Swant, Jim Peterson, Barbara Hoffman, Karleen Heintzberger, Janet Mobley, Melanie Hein, Kirsten Brannon, Peggy Haug and Peter Swant.

Pastor Lars opened the meeting with prayer.

The October minutes were approved by email affirmation on October 23, 2025.

Financial Report: Monthly report: Christ Lutheran's operational income came in \$8,608 less than budget for October.

Operational expenses were \$2,738 more than budget for October. Operational funds combined for a net outflow of \$12,521 for October. Designated/restricted activity resulted in a net outflow of \$1,496 for October.

Year To-Date: We have collected approximately 81.80% of the revenue through October. We have spent approximately 84.90% of the budget through October.

Balance Sheet Items: CLC's checking and saving account ended October with a \$171,966 balance. Restricted/endowments fund totaled \$290,840 as of 10/31/2025. CLC had \$1,803,215 in positive equity on 10/31/2025.

Pastor's Report: Pastor Lars Hammar provided a written report to Council.

#### Committee Reports:

**Property:** Fall clean up day was a success with 19 volunteers (saints) showing up to help with the clean up. There will be additional work that needs to be done with leaves as the fall progresses. JC Landscaping is ready to help with snow removal this winter and has been given instructions to plow out the lot when appropriate. They are blowing out the sprinkler system this week.

Pastor Lars & his son Leif have a plan for getting our streaming speed higher for better resolution of our services online. This will be completed asap.

WW Electric has been busy getting the church ready for the solar panel install.

The HVAC system is scheduled for fall cleaning/servicing.

Finance & Budget: Our current financial situation is pretty completely described in Gordon's Treasurer Report. I received budget requests from two council members. So, I guess two budget groups will get to split all the money. I do have a preliminary and incomplete draft of a 2026 budget for our review tonight.

Worship: Nothing new to report for Worship.

Evangelism: Maxwell Lohrmann and Jayla Ortiz were confirmed on October 26, 2025 with a reception following.

Name tag Sunday was held on Oct. 5.

Fellowship: Brats & Brews was a huge success with approximately 75-80 people attending. Many thanks to all who helped and participated. It was great to see friends & family join us as well. We had a small reception for Erin on her last day. It was very nice with a few treats, some Gluten Free, and beverages. Thank you to all who came and helped out as well. We wish her the best. We have our Advent Soup Suppers coming up as well as a wonderful night being planned for Christmas Caroling. Tis the Season!

Outreach: Continuing as reported last month.

Youth Education: No report.

Youth and Family: Kirsten is gathering with a group this next week to plan Advent and the Christmas program.

Adult Education: For the month of November, we are continuing the educational series in conjunction with SJAG in preparation for the vote of our church on whether to become an RIC congregation. There has been a good response so far and I expect even more people will attend with Pastor Lars leading the last two sessions. For December and Advent, since our church has events scheduled immediately after worship on the second and third Sundays in advent, December 7 and 14th, I have decided not to do any other adult education in December.

Stewardship: Pledge cards have been tallied. 31 cards have been received for a total of \$132,134 pledged. Looking forward to further information.

#### Continuing Business:

On October 29, 2025, Peggy Haug made a motion by email to hire Deanne Kasten as church secretary/administrative assistant at the pay rate, hours and benefits outlined in Kay's email. Emily Stone seconded the motion. A vote was taken by email reply. The motion carried. Deanne (Dee) Kasten accepted the position and begins on November 17, 2025; hours 8 am – 2:30 pm, M-F.

The Nominating Committee is comprised of Anne Swant, Barbara Hoffman, Kaye Miller, Carmen Funderburk, and Larry Johnson. The committee has worked hard to fill the open positions and a preliminary overview of people willing to serve was presented.

#### New Business:

Karleen Heintzberger made a motion to approve Sandra Heilman and Cheryl French as voting members of Christ Lutheran by Affirmation of Baptism. Kirsten Brannon seconded. Motion passed.

The updated Office Manager/Bookkeeper job description was shared. Barbara Hoffman made a motion to accept the updated Officer Manager/Bookkeeper job description. Peggy Haug seconded. Motion passed.

Anne Swant made a motion that mid-week Advent offerings be sent to BMAC with designation for the Food Bank. Jim Peterson seconded. Motion passed.

Jeff Wagner has given six months' notice of his resignation as Sexton, effective April 30, 2026. Council members are encouraged to sign up to help at Soup Suppers during Advent.

The first draft budget for 2026 was reviewed line-by-line in comparison to the updated budget from June 2025. Anne Swant presented a "Christ Lutheran Property Mgt Budget Proposal" with a detailed description of her requests. At their December meeting, council will vote on the final budget to recommend to the congregation at the January annual congregational meeting.

A capital campaign for roof replacement in the next 3 to 5 years was discussed.
