Permission to Transport During the Activity

As the parent/guardian of the child named above, I give consent to the leadership of the program to transport my child during the event through walking, vans, buses, airplanes or other forms of transportation available to the activity. I understand that the program will be following all Peterkin transportation and youth protection policies during transportation of my child during the program.

1. Minors must turn in their car keys to the leadership of the program upon arrival.
2. Minors are not allowed to provide rides to other minors (other than younger siblings) unless specific permission is granted in writing by the parent/guardian of the individual who will be riding with the minor. The parent/guardian of the rider will release Peterkin Camp and Conference Center and the Episcopal Diocese of West Virginia from any liability associated with this arrangement.
3. Minors may not leave the program before the conclusion of the event unless notification has been provided verbally or in writing to the leadership of the program.
4. All minors driving to and from the program will be required to sign in and out with the leadership of the program after arriving and before leaving.
5. Minors are responsible for any parking charges that may be incurred at the site of the program.

I give consent to allow my child to sign in and sign out themselves and any younger siblings during the program named above as they will be traveling to the program without a parent/guardian. I also give consent to allow my child to deliver or take any items related to signing in or signing out with the program listed above. These items could include money, medication, signed documents and program information. I understand my child does not have permission to leave prior to the conclusion of the program for any reason, and they cannot transport anyone they did not bring to the event, unless pre-approved by the parent/guardian and verbal or written notification is given to the leadership of the program.

In signing this form, I certify the information provided is true and accurate. I understand that it is my responsibility to reach out to the leadership of the program in relation to any questions I may have related to transportation. I also understand that it is my responsibility to update this information prior to, or during an event, if this information has changed. I hereby acknowledge and accept all risks individually and/or on behalf of my minor child, and I hereby release Peterkin Camp and Conference Center, the Episcopal Diocese of West Virginia, its governing board, officers, employees, agents, volunteers and representatives from any and all liability to my child, my child's personal representatives, estate, heirs, next of kin and assigns for any and all illness or injury to my child's person, including his/her death, that may result from or occur during transporting my child before, during or after a program with or without parental or guardian supervision, whether caused by negligence of Peterkin Camp and Conference Center, the Episcopal Diocese of West Virginia, its governing board, officers, employees, or representatives, or otherwise. I further agree to indemnify and hold harmless Peterkin Camp and Conference Center, the Episcopal Diocese of West Virginia, and its governing board, officers, employees, and representatives from liability for the injury or death of any person(s) and damage to property that may result from my child's negligence or intentional act or omission.
