**ST. GEORGE'S ANGLICAN CEMETERY, SOUTH ALICE
BY-LAWS / RULES AND REGULATION**

1. The control of the cemetery is vested in the Incumbent and Church Wardens and administered by the Cemetery Committee of St. George's Church, being responsible to the Vestry of that congregation under the Canons of the Diocese of Ottawa. (R. 5.04)
2. Lots and graves shall be sold hereafter by the Cemetery Committee chairman, covered by a rate for care and maintenance set forth in the tariff of rates.
3. Notice of each interment to be made shall be given to the Incumbent or the Cemetery Committee at least forty-eight (48) hours previous thereto except under special circumstances.
4. No interment shall be made on Sunday except on a doctor's certificate that burial must be made within 24 hours of death in accordance with the regulations of the Ontario Department of Health for the control of communicable diseases.
5. No body shall be moved or disinterred without the written consent of the local medical officer of health and the owner of the lot, except on an order from the court or as provided in the Regulations under the Cemeteries Act.
6. If any trees or shrubs situated in any lot shall have, ~~in the opinion of the Cemetery Committee~~, become by means of their roots or branches or in any other way detrimental to the adjacent lots or prejudicial to the general appearance of the grounds, the Committee may remove such tress or shrubs, or parts thereof. AFTER 30 DAYS NOTICE, IN WRITING, IS GIVEN TO THE INTERMENT RIGHTS HOLDER.
7. The erection hereafter is prohibited of borders, fences, railings, walls, and hedges in or around lots.
8. No person shall do any work upon a burial lot without the permission of the Cemetery Committee.
9. Monuments to be erected by or for lot owners shall be set upon adequate concrete bases, and no foundation shall be less than five feet in depth, or the full depth of the grave.
10. Children under the age of twelve years are not admitted to the grounds except in charge of an adult, who shall be responsible for their good conduct.
